A post-race veterinary examination of Willow Tree revealed split webbing between digit 2 and 3. the greyhound has been stood down from racing for 14 days.

A post-race veterinary examination of Dewana Be Tiny revealed minor swelling to the left hind medial tibia and the greyhound has been stood down from racing for 5 days.

In the opinion of the Stewards Dewana Be Tiny eased and failed to pursue the lure on the first turn under the provisions of GAR 124. As it was the greyhound's 1st offence under Gar 124 it has been suspended for 28 days at Launceston only and until the completion of a satisfactory trial.

A post-race swab sample was taken from the winner Wilson.

A post-race veterinary examination of Akuna Street revealed no obvious abnormalities. In the opinion of the Stewards Akuna Steet failed to pursue the lure approaching the winning post pursuant to GAR 124 when it shifted out and turned its head toward Georgie Dean. As it was the greyhounds first offence it has been stood down from racing at Launceston only for 28 days and until the completion of a satisfactory trial under the provisions of GAR 127(a).

A post-race veterinary examination of Hot Diggity revealed a spike wound to the right hind paw and the greyhound has been stood down from racing for 10 days.

Trainer B Deverell pleaded guilty to a charge under GAR 156(f)(ii) for negligence when acting on behalf of owner D Hammersley he had allowed Turtle Girl to leave his kennels when the greyhound had not fully completed its wind down period. The greyhound having served 21 days of the prescribed 28 days. Taking into account his long service as a trainer, his clean record in this regard and his guilty plea Mr Deverell was fined the sum of \$200 (\$100) wholly suspended for 12 months.
