Comments / Explanations:

Rider R Morimoto was indisposed for this meeting due to a trackwork incident during the week. Stewards advised rider R Morimoto that he must provide a medical clearance prior to riding again.

RACE 1 – LADBROKES OWNERS INCENTIVE MAIDEN (1200 METRES)

NO MORE ROCKS – Began awkwardly and was slow to begin, over raced early stages, laid in in the home straight. A post-race veterinary examination revealed no significant findings.

NEED TO THINK – Over-raced early stages.

RARE ORO – Held up rounding the home turn until entering the home straight. Rider A Darmanin was reprimanded under the provision of AR132(7)(a)(i) for using his whip on consecutive strides prior to the 100 metres on one occasion. Rider A Darmanin was also advised to ride his mounts out fully to the line.

SHE'S BLUFFING – Slow to muster early speed. A post-race veterinary examination revealed no significant findings.

SMASH 'N' GRAB – Had a tendency to lay in in the home straight, rider unable to ride out fully to the line. Trainer advised that the filly now go for a spell.

STEEL CONNECTION – Began awkwardly and was slow to begin. Held up rounding the home turn.

RACE 2 – KEVIN SHARKIE MAIDEN (1400 METRES)

SCARLETTI – Slow to begin and tightened shortly after by LADY SARAH which shifted out, losing its position. Laid in, in the home straight. A post-race veterinary examination revealed no significant findings.

WHO CAN IT BE NOW – Raced three wide throughout.

ALL ABOUT LUNA – Under-went a pre-race veterinary examination and was passed fit to race.

LADY SARAH – Began awkwardly and shifted out tightening SCARLETTI.

MISS DARKSIDE (NZ) – Declared a late scratching after refusing to be loaded into the barriers. Stewards advised trainer Mr J Keys that MISS DARKSIDE must complete two consecutive satisfactory trials prior to racing again. On the announcement of correct weight Stewards ordered that all monies invested on MISS DARKSIDE be refunded, with the following deductions to apply to successful wagers placed prior to 12.18pm.

Stewards ordered that the following deductions would apply:

1st - 8	WHO CAN IT BE NOW	4 cents win, 6 cents place.
2nd - 11	LOVE NEST	4 cents place.
3rd - 5	STERREK	7 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

RACE 3 – OLIVE TREE CATERING MAIDEN/CLASS 1 (2100 METRES)

AMERICAN JEWEL – Bumped with FASHION FOX shortly after the start.

ES AND ES – Raced three wide throughout, bumped with RAFAEL'S RAID at about the 800 metres.

FASHION FOX – Bumped with AMERICAN JEWEL after the start.

LET'S MESSAROUND – Began awkwardly.

MONTEZULU – Began awkwardly and shifted out tightening UNNERVING at the start, Steadied off heels at about the 1900 metres.

ROCHEAUX – Rider T Baker advised that he believed there was something amiss with the gelding's action. A post-race veterinary examination revealed no significant findings.

AL MAXIMUS – Jumped the crossing. A post-race veterinary examination revealed no significant findings.

RAFAEL'S RAID – Reared as the gates opened and was slow to begin. Bumped with ES AND ES at about the 800 metres.

UNNERVING – Blundered and then tightened when MONTEZULU shifted out.

ZULU FIELDS – Raced wide in the early stages.

RACE 4 – WINNING EDGE PRESENTATIONS CLASS 1 HANDICAP (1200 METRES)

LIGHT OF ROSE – Over raced early stages. Under- went a post-race veterinary examination and was found to have a superficial wound above the incisor tooth.

ROW ROW POWER – Raced wide throughout.

ANYWAYS ROXIE – Stewards queried rider T Baker in relation to the below market performance. Rider T Baker stated that his mount had failed to handle today's track conditions. Underwent a post-race veterinary examination and was found to have a loose cap from an impact to the mouth during the race.

SPINHOF – Raced wide throughout.

KITTY PURRING – Began awkwardly unbalancing its rider. A post-race veterinary examination revealed no significant findings.

RACE 5 – MINGARI + CO CLASS 2 HANDICAP (1400 METRES)

ASVA (NZ) – Shifted wider to improve in the home straight.

ADACHI – Bounded out at the start and was slow to begin, raced wide throughout.

BERSERKER – Slow to begin.

FLYING BILLIE – Hung out throughout and shifted wider in then home straight.

BANCA TOM – Stewards queried rider D Pires in relation to the below market expectations performance. Rider D Pires stated that in his opinion that he was in the worse section of the track and when he placed the gelding under pressure it failed to respond to his riding. A post-race veterinary examination revealed no significant findings.

CAPITAL CHEVAL – Fractious in the barriers and bounded out at the start, resulting in being slow away.

THE LAST HURRAH – Stewards granted permission for rider S Carr to ride 1/2kg over the allotted minimum weight.

I'M KEEFE – Laid in entering the home straight.

DIABLO – Raced wide throughout. A post-race veterinary examination revealed no significant findings.

ENCHANTED SPY – Harmlessly dislodged rider enroute to the barriers. Under-went a pre-race veterinary examination and was passed fit to start.

RACE 6 – KEVIN SHARKIE CLASS 4 HANDICAP (1400 METRES)

LOVIN' BEV – Stewards spoke with rider S Carr in relation to the below market expectations performance. Rider S Carr stated that in her opinion the mare failed to handle today's track conditions.

MAKE A DECISION – Raced wide in the early stages.

ZULU ANGEL – Shifted in on jumping and bumped with MAKE A DECISION which lost its position.

PRINCESS MATOAKA – Bounded out at the start. Stewards granted permission for rider C Newitt to ride 1/2kg over the allotted weight.

STEEL MIST – Fractious as the gates opened and bounded out at the start and was slow to begin. Stewards granted permission for rider M Ulucinar to ride 1kg over the allotted minimum weight.

MAARKLE – Slow to begin then shifted in and checked off heels of MAKE A DECISION.

RACE 7 – MOREY'S SPORTS & MUSIC TOURS BENCHMARK 68 HANDICAP (1100 METRES)

GEEGELUCKYSTAR – Lost an off-fore plate in running.

CHAMPAGNE CINDERS – Began awkwardly.

FAIRY MAGIC – Stewards granted permission for rider L Riordan to ride 1/2kg over the allotted weight.

MR FREEZE – Began awkwardly and over-raced early and middle stages.

NEV'S BOY – Declared a late scratching after refusing to be loaded into the barriers.

Stewards advised trainer M Everett that NEV'S BOY must complete a satisfactory trial prior to racing again. On the announcement of correct weight Stewards ordered that all monies invested on NEV'S BOY be refunded, with the following deductions to apply to successful wagers placed prior to 3.44pm.

Stewards ordered that the following deductions would apply:

1st - 2	NICCO THE GREEK	5 cents win, 5 cents place
2nd - 11	YOURAWAY	7 cents place
3rd - 7	THUNBERG	7 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

Rider B Muhcu (YOURAWAY) pleaded guilty to a charge of careless riding under the provisions of AR131(a) the particulars being that at about the 150 metres he allowed his mount to shift in when not fully clear resulting in QUICKEN UP (E Byrne Burke) being tightened and restrained off heels of YOURAWAY. Rider B Muhcu's licence to ride in races was suspended for one Tasmanian race date commencing midnight 21st July, 2024 and expiring midnight 28th July, 2024.

RACE 8 – AVISO TAS INSURANCE BROKERS BENCHMARK 64 HANDICAP (1600 METRES)

FIGHTING FLOYD – Slow to begin. Shifted out under pressure in the home straight.

JOHNNIE PINCH – Over-raced early stages.

NAVAJO WARRIOR (NZ) – Raced wide throughout. Stewards granted permission for rider M Ulucinar to ride 1/2kg over the allotted weight.

MY DEMETRA – Raced wide throughout.

BOUNTY BAY – Shifted in under pressure in the home straight, rider C Newitt momentarily stopped riding at about the 200 metres to straighten his mount. Stewards granted permission for rider C Newitt to ride 1/2kg over the allotted minimum weight.

FOUR LETTER WORD – Tightened and checked at about the 150 metres. Adjourned inquiry.

HAMOGANY – Raced wide throughout.
