A post-race veterinary examination of Silent Keiko revealed muscle soreness to the left hind thigh muscle and the greyhound has been stood down for 7 days.

A post-race veterinary examination of Replicant revealed a spike wound to the right front foot and the greyhound has been stood down from racing for 7 days.

A post-race veterinary examination of Special Bond revealed no obvious abnormalities. In the opinion of the Stewards as Special Bond had pulled up in the back straight under the provisions of GAR 124 he had failed to pursue the lure. Under GAR 127(a) Special Bond is suspended from racing at Hobart only for 28 days and until the completion of a satisfactory trial.

A post-race veterinary examination of Mr Ten Percent revealed a muscle injury to the left hind leg and the greyhound has been stood down from racing for 14 Days.
