GENERAL

Trefusis today completed a satisfactory trial for failing to pursue. Beginning from box 3 with 3 other greyhounds and weighing 28.3 kg. This greyhound ran 4th in a time of 30.16 seconds and has not been cleared to race at all tracks as the greyhound visibly eased on the second turn.

Anndar Lodge today completed a satisfactory trial as it had not race for over 6 months pursuant to 135(b) as well a weight trial. Beginning from box 3 weighing 33.5 kg. This greyhound ran a time of 16.31 seconds and has been cleared to race.
