GENERAL

Hook Shot completed a weight trial today, beginning from box 1 with one other greyhound and weighing 34.7 kg (previous 30.6). Hook Shot completed the 340 metres in 19.91 seconds finishing first and has been cleared to race.

Licensed Trainer Mr S Croft pleaded guilty to a charge under GAR 156(f)(ii) for improper conduct towards Steward R Brown in vicinity of the kennel wash bay after race nine when he swore at him. In considering penalty Stewards took into account his guilty plea his and record under the rule. Also taken into account was the need for a deterrent for Mr Croft specifically and the need for a general deterrent for improper behaviour toward officials and all participants in general. Subsequently his licence was suspended for a period of two months to commence midnight tonight and to expire midnight 11 January 2025. Mr Croft was advised of his rights of appeal.
