### RACE 1 – KING ISLAND SENIOR CITIZENS OP SHOP CLASS B HANDICAP – (1000 METRES)

**SQUAZEEMOTO –** Raced fiercely early and middle stages.

**ENUFF BREAKERS –** Slow to muster early speed.

**BARRABOOL** – Raced wide in the later stages.

### RACE 3 – J&S MUIR MEMORIAL MAIDEN – (1400 METRES)

**INTRO –** Slow to muster early speed.

### RACE 4 – COX ELECTRICAL CLASS B HANDICAP – (1400 METRES)

**PAXA PUNCH –** Scratched at 9:15am. Trainer T Muir was advised she would be required to supply a veterinary certificate prior to the geldings next race start.

Stewards spoke to jockey J Gibbons in relation to him allowing his mount to laid in over the concluding stages. Mr Gibbons was advised to exercise more care when racing in restricted room.

### RACE 5 – KING ISLAND CONCRETE CLASS B HANDICAP – (1200 METRES)

**ROYAL MOLLY –** Declared a late scratching at 4:15pm, after the mare ran approximately 500 metres when the starting barriers malfunctioned and opened prematurely.

On the announcement of correct weight, Stewards ordered that all monies invested on ROYAL MOLLY be refunded, with the following deductions to apply to successful wagers placed prior to 4:15pm.

Stewards ordered that the following deductions would apply:

1st - 5 – PRESS FOR VICTORY 23 cents win, 18 cents place.
