Following the running of the event stewards ordered a post-race veterinarian inspection of BERATE which showed signs of lameness over the concluding stages. Post race inspection revealed the greyhound may have sustained a fracture to its left hock. Trainer was advised that BERATE must be taken to their veterinary clinic in the morning and pain relief was administered to the greyhound. Berate was stood down for a period of 120 days.

A post race veterinarian examination was called on DEWANA DAICOS. Over the concluding stages of the event the greyhound seemed to turn its head towards the inside greyhound. After a conclusion of an inquiry with the trainer, it was established that DEWANA DAICOS did turn its head towards the inside greyhound however there was no contact with its muzzle. The post race veterinarian examination revealed the greyhound was suffering from some muscle soreness to its left hind thigh. DEWANA DAICOS was stood down for a period of 10 days by the veterinarian and it must trial to the satisfaction of stewards over the distance of 461m prior to racing again.
