

RACE 1 - LADBROKES RACING CLUB STAKES - 1680m Mobile

CINCINNATI – Held up for clear running until well into the home straight for the run to the finish. Completed the event with a cast off-hind plate.

BUMPY J NZ – Unsuccessful with a short challenge for the lead leaving the 1000. Under pressure from 300. Raced rough latter stages of final turn.

NORBET – Hung in under pressure in the latter stages of the final turn.

RACE 2 - BEVAN LEE'S BUTCHERY STAKES - 2200m Mobile

General: The start of this race was delayed approximately 2 minutes so as to avoid a clash with an international thoroughbred event.

SOKYS LINE – Broke gait approaching the stating point losing valuable ground, effectively taking no competitive part in the race. It was also noted SOKYS LINE broke a number of times during the event. Stewards deemed the performance of SOKYS LINE well below the required standard and as such stood the gelding down from racing until satisfactorily completing one(1) qualifying trial. In addition, SOKYS LINE will be excluded from the barrier draw in future mobile start events.

COOLANDCOLLECT – Placed on its last chance to race truly after breaking gait when becoming unbalanced when checked by its driver became unbalanced after shifting in, momentarily tightening JUST JAYDO.

ART HUNTSMAN – Checked and raced rough approaching the first turn when COOLANDCOLLECT broke gait.

KEAYANG KEVIN – Will continue to be excluded from the barrier draw after breaking gait fee of interference as the start was being effected.

RACE 3 - LADBROKES BLACKBOOK PACE - 2200m Mobile

PARTY BLAZE – Held up for clear running until well into the home straight for the run to the finish.

ROCKNROLL GRANT – Tired over the concluding stages to be beaten approximately 80 metres. Stewards deemed the performance below the required standard and as ROCKNROLL GRANT had been stood down recently for a poor performance, Stewards stood the mare down from racing until it can satisfactorily complete two(2) consecutive qualifying trials.

GEMAEDDE – Over-raced in the middle stages when the pace of the race was only steady.

RACE 4 - FAITHFUL PARK STUD PACE - 160m Mobile

General: The start of this race was delayed approximately 2 minutes due to the need for a sulky change on LOU LOUS ALLGOLD

A GOOD RED – Failed to secure clear running over the concluding stages.

BRIAN WHO – Failed to secure clear running over the concluding stages.

MY ULTIMATE JACKO – Failed to secure clear running over the concluding stages.

KIAVINO STRIDE – Raced wide from the 1400.

RACE 5 - NUTRIEN AG SUPPLIES PACE - 2200m Mobile

GOTTAHAVEAHOBBIE – Severely checked 100 metres from the finish when JACK JAMES shifted ground abruptly.

LAID BACK KENNY – Checked 100 metres from the finish when JACK JAMES shifted ground abruptly.

JACK JAMES – Shifted ground abruptly approaching the 100 when the near-side rein became entangled with JACK JAMES' tail. On questioning driver K Pratten informed Stewards JACK JAMES had swished its tail catching the rein, resulting in the gelding shifting ground markedly. Trainer Pratten further informed Stewards he intends to fit a tail tie to JACK JAMES for its next race.

Stewards accepted the undertakings of trainer Pratten, taking no action other than to note the circumstances.

QUEENOFDANCE NZ – Inconvenienced 100 metres from the finish when JACK JAMES shifted ground abruptly.

SWEET AMOUR – Severely checked 100 metres from the finish when JACK JAMES shifted ground abruptly.

RACE 6 - LADBROKES PUNTER ASSIST STAKES - 1680m Mobile

SMOKESCREEN – Will be excluded from the mobile barrier draw after breaking gait, free of interference, shortly after the start.

CHEETAH LODGE – Checked after the start when SMOKESCREEN broke gait.

RACE 7 - LEE ORCHARD STAKES - 2200m Mobile

SCRUB BASHER – Had difficulty in securing clear running in the early stages of the home straight for the run to the finish.

MORRIS BROWN – Failed to secure clear running over the concluding stages.

GROVE DALE – Had difficulty in securing clear running in the early stages of the home straight for the run to the finish.

General: Driver N Ford was fined \$400 for the unapproved manner he used his whip use in the early stages of the home straight in the run to the finish. Stewards in issuing penalty were mindful driver Ford had been fined earlier this month for a similar breach [AHR Rule 156(2)(a)].

RACE 8 - LADBROKES MATES MODE HOSTED POTS PACE - 2200m Mobile

ISOLATION – Having its first registered race start for over 8 months. Raced in behind the leader. Under pressure leaving the 600. Beaten in excess of 50 metres. A post-race Veterinary examination could find no obvious issues. Stewards took no action other than to place a warning on the gelding's performance.
