## RACE 1 - TASRACING STAKES - 2200m Mobile

**NANCESTIGER** – Held up for a clear run in the early stages of the run to the finish.

MYNAMESEVAN – Began well to lead the event, pulled hard throughout. Under pressure from the 700, giving ground to be beaten in excess of 105 metres. A post-race veterinary examination revealed no significant abnormalities. On questioning, connections acknowledged their disappointment as the gelding had been working well leading up to tonight's event and were at a loss to explain the disappointing performance. Stewards deemed the performance below the required standard and as such stood MYNAMESEVAN down from racing until satisfactorily completing one(1) qualifying trial.

**General:** Drivers G Jones and M Ford were both reprimanded for failing to have their respective horses in their true starting positions. [AHR Rule 162(1)(h)].

#### RACE 2 - KEITH STANLEY DEBUTANTE - 1680m Mobile

**RAINBOW RANGER** – Raced greenly throughout, hanging both in and out in various stages.

A DRAGON FOR JOE – Hung in at various stages, shifted in when placed under pressure in the home straight for the run to the finish.

**BARBER SHOP** – Shifted out when placed under pressure in the home straight for the run to the finish.

## RACE 3 - LDBROKES SAME RACE MULTI STAKES - 1680m Mobile

**JUST JAYDO** – Gave ground to be beaten in excess of 50 metres. JUST JAYDO was placed on its last chance to race competitively.

**NORBET** – Back from its allotted position at the start, when the momentum of the mobile stalled due to SWIMINTHERUVER being inconvenienced in the score-up, the benefit of the doubt was given with no action taken other than to note the circumstances.

**SWIMINTHERIVER** – Inconvenienced in the score-up when DAZZLE ME broke gait. Dislodged a shin boot shortly after the start and another entering the first turn. Broke gait entering the first turn. A post-race veterinary examination revealed a laceration to the off-fore leg. The leg was washed and dressed, with treatment given to the gelding. SWIMINTHERIVER was subsequently stood down from racing pending a Veterinary clearance.

**DAZZLE ME NZ** – Fractious prior to scoring up, breaking gait in the early stages when leaving the pre-race circle. Well out of position when the start was effected, as a consequence DAZZLE ME NZ will be excluded from barrier draws forfuture events conducted under mobile conditions. Trailed the field throughout, taking no competitive part. A post race veterinary examination failed to reveal any abnormalities.

**BELIEVE IN FOREVER** – Had difficulty in securing clear running room in the run to the finish.

#### RACE 4 - KEVIN GILLIES MEMORIAL - 2698m Stand

General: Trainer W Yole was fined \$100 for the late notification of a change of driver on VANQUISH STRIDE NZ [AHR Rule 210].

**HAZEWILLREV** – Placed on its last chance in the barrier draw for races conducted under standing start conditions after failing to begin in the required manner.

**WATERMELON SUGAR NZ** – Will continue to be excluded from the barrier draw for races conducted under standing start conditions after failing to begin in the required manner. Pulled hard and over-raced throughout.

**THE CHANCER** – Reinstated in the barrier draw for races conducted under standing start conditions after satisfying re-inclusion requirements.

### RACE 5 - ALLEN WILLIAMS MEMORIAL - 2200m Mobile

**GLENVIEW LANIKAI** – First registered race start.

**IRIS BROWN** – First registered race start. Will continue to be excluded from the barrier draw for races conducted under mobile start conditions after failing to fill its position at both the candy pole and the start.

#### RACE 6 - LADBROKES EASTER CUP - 2698m Stand

**KEAYANG FITZY** – Will be excluded from the barrier draw for races conducted under standing start conditions after failing to begin in the required manner, specifically galloping out at the start, and continuing to do so for some distance.

**ALL BY MYSELF NZ** – Badly away when the strands were released and as such will continue to be excluded from the barrier draw in standing start events.

**HELLUVA NZ** – Fractious before the start. Checked shortly after the start by the galloping KEAYANG FITZY, and subsequently broke gait for a number of strides.

MAGICIAN – Inconvenienced after the start by the galloping ALL BY MYSELF NZ.

**MAGNETIC TERROR NZ** – Will continue to be excluded from the barrier draw for races conducted under standing start conditions after failing to begin in the required manner.

## RACE 7 - LADBROKES RACING CENTRE STAKES - 2200m Mobile

**SOUTHPAW SLUGGER** – Broke gait in the score up, and continued to gallop for some considerable distance before being brought back into a pace. Stewards deemed the performance of SOUTHPAW SLUGGER to be well below the required standard, and subsequently stood the gelding down for one (1) satisfactory trial prior to its next race start and in addition placed the gelding out of the draw for races conducted under mobile start conditions. On questioning connections informed Stewards that they were at a loss to explain SOUTHPAW SLUGGER's performance, indicating they would not be continuing with its racing programme and will be returned to its owners.

**COLBY SANZ** – Inconvenienced by the galloping SOUTHPAW SLUGGER.

## RACE 8 - LADBROKES MATES MODE POTS PACE - 1680m Mobile

**MY MATE LUKE** – Will be excluded from the barrier draw for races conducted under mobile start conditions after breaking gait shortly after the start was effected.

**ALBERIO** – Checked shortly after the start, when shifting ground to avoid the galloping MY MATE LUKE.

## RACE 9 - VICTORY IMAGES PHOTOGRAPHY PACE - 1680m Mobile

**MONTGOMERY BURNS NZ** – Dropped a shin/tendon boot shortly after the start. Began well to lead the event.

**MAJOR LESTER** – Shifted in when placed under pressure in the run to the finish.

**SERENGETI SUNRISE** – Reinstated in the barrier draw for races conducted under mobile start conditions after satisfying re-inclusion requirements.

## RACE 10 - NEIL PITT'S STAKES - 2200m Mobile

**RAY DAN** – Broke gait shortly after the start was effected. RAY DAN will be excluded from the barrier draw in future events conducted under mobile starting conditions.

## Supplementary – BRIAN WHO late scratching Race 1 Hobart 18th April 2025

Stewards questioned trainer W Yole over the circumstances around the late scratching of BRIAN WHO out of race 1 at the Tasmanian Trotting Club's meeting on Friday 18<sup>th</sup> April 2015 due to not having a sulky. Trainer Yole informed Stewards he had organized for a sulky to be supplied by another licensee earlier in the day, however due to circumstances beyond his control, that arrangement did not eventuate, adding that on requesting the use of the club sulky, initially that request was denied. Stewards under the circumstances gave the benefit of the doubt on this occasion, taking no action other than to note the circumstances and to instruct trainer Yole to take the necessary action so as to prevent this situation being repeated. Further, trainer Yole was instructed to remind his assistants to bring any matters to the attention of Stewards much earlier than took place on this occasion, which more than likely would have prevented the scratching.
