**RACE 1 – LADBROKES MATES MODE POTS TWO-YEAR-OLD – 1680m Mobile**  
SNIPER STRIDE – First registered race start.

QUETZALLI – First registered race start.

**RACE 2 – THE BOTTLE-O HADSPEN PACE – 2200m Mobile**

A SHADOW OF DOUBT – Over-raced and pulled hard in the lead. Shifted out under pressure from the 300.

I AM MARQUEZ – A warning was placed on the gelding for hanging in. Of note, approaching the 800, several markers were struck, ultimately dislodging one which bounced up, landing in the sulky of ROCK THE TABLEAU, trainer K Pratten was instructed to take the necessary action in an attempt to rectify the issue. Re-instated in the barrier draw for races conducted under mobile start conditions after satisfying re-inclusion requirements.

*General:* Racing toward the 400, Driver Castles lost his whip after his whip became entangled with that of driver R Hillier.

### **RACE 3 – LADBROKES SAME RACE MULTI PACE – 1680m Mobile**

**OUR SWEET TRIXIE NZ** – Disappointed for clear running in the run to the finish.

**TASSIE DAZZLER** – Placed on its last chance to race truly after racing roughly and ultimately breaking gait near the 1400, contacting marker pegs in the process. Took no competitive part in the remainder of the event.

**NORMANS GIRL** – Raced in restricted room rounding the home turn through general race movement, ultimately contacting several marker pegs.

### **RACE 4 – NUTRIEN AG SUPPLIES STAKES – 2200m Mobile**

**JAMES CAGNEY** – Slow to muster early speed.

**DE GOEY** – Caught wide early, worked forward to the position leading the one-out line approaching the 1200.

**DIAMONDS N CASH NZ** – Stood down from racing until satisfactorily completing one (1) trial, after repeated poor performance.

*General: The 'all-clear' was delayed allowing D Ford, the driver of the second placed WATERMELON SUGAR NZ, the opportunity to review the official race footage of the final stages of the event. On review, driver Ford had no objections and as such Stewards declared 'all-clear' on the judge's numbers, 6-5-8-1-7.*

### **RACE 5 – BEVAN LEES BUTCHERY STAKES – 1680m Mobile**

### **RACE 6 – LADBROKES ODDS SURGE STAKES – 1680m Mobile**

**ZEUS IMMORTAL** – Secured an inside run over the concluding stages to win the event. Re-instated in the barrier draw for races conducted under mobile start conditions after satisfying re-inclusion requirements.

*General: Driver M Jones was fined \$200 after pleading guilty to charge of advantaging another runner through his failure to keep CAPTAIN CHEDDAR on a straight course in the run to the finish, thus presenting an inside run to the eventual winner ZEUS IMMORTAL [AHR Rule 162(1)(www)(c)].*

### **RACE 7 – FAITHFUL PARK STUD PACE – 2200m Mobile**

**SERENGETI SUNRISE** – Over-raced and pulled hard in the lead, particularly in the middle stages. Driver B Davis was counselled with regard to his driving style where he was leaning significantly outside the sulky confines. As this is not the usual driving style of driver Davis no other action was taken.

**SHARMEY** – Gave ground to be beaten in excess of 50 metres, for which a warning was issued. In considering the warning, Stewards were mindful of the individual time recorded by the gelding (MR 2:01.98).

### **RACE 8 – VICTORY IMAGES PHOTOGRAPHY STAKES – 2200m Mobile**

**JACK JAMES** – Had difficulty in securing clear running over the final stages.

*Trainer B Parrish reported that after LA PIERRE's last start, where its performance was very disappointing, finishing in last place, beaten 36.8 metres, the gelding on returning to his stable had pulled up poorly, tying-up badly and was later found to be badly dehydrated. LA PIERRE has since trialed satisfactorily.*
