### Race 2 - AVISO TAS INSURANCE BROKERS MAIDEN: 1100m

Stewards today concluded the reasons why apprentice L Bingley was dislodged at the 200 meters on TAKEAWAY in this event. Stewards took evidence from Riders A Darmanin (OUTBUSH), App J Johnson (WOOLCLASSER) & App L Bingley (TAKEAWAY) in relation to this incident. Stewards, after considering the evidence tendered at the inquiry's and acting on their own observations and viewing the official patrol films, were satisfied there was no rider at fault. The particulars of the incident were that approaching the 200m

WOOLCLASSER (App J Johnson) tended to shift outwards despite efforts from its rider to straighten the gelding and at the same time OUTBUSH (A Darmanin) tended to shift inwards under pressure. TAKEAWAY (L Bingley) while attempting to take a run between these two horses shifted outwards marginally away from WOOLCLASSER and clipped the heels of OUTBUSH and blundered, dislodging app L Bingley. Stewards could not blame any one rider, as TAKE AWAY (L Bingley) had contributed to this interference by shifting outwards at this stage. Stewards deemed it a racing incident. Stewards reminded all riders of their obligations in similar circumstances, and took no action.

#### **Race 1 – 11:40 AM – LADBROKES FORM GENIUS MAIDEN PLATE - (1150 METRES)**

| <b>9. HELP FROM ABOVE -</b> | Shifted inwards upon jumping.   |
| <b>10. SIENNA WOLF -</b>    | Rider had to take hold of his mount at the 1000m. Over raced in the early stages. Raced wide making the home turn.  |
| <b>11. ZULU FIELDS -</b>    | Shifted outwards upon jumping.  |
| <b>12. ROUNdle PARK -</b>   | A post race swab sample was taken from this winner for analytical testing.  |

Stewards questioned riders App J Radley (ROUNdle PARK) and D Ganderton (SIENNA WOLF) into reasons why Jockey D Ganderton had to take hold of his mount at the 1000 meters. After taking evidence from both riders and stewards acting on their own observations and viewing the official patrol films it was established that ROUNdle PARK was shifted inwards by App J Radley at this point to gain a position closer to the rail. and while making this move was not fully clear of SIENNA WOLF, resulting in this rider having to ease of this gelding's heels. Stewards in not acting against the license of App J Radley were mindful that SIENNA WOLF may have marginally shifted outwards at this stage and contributed to this incident. In all the circumstances stewards issued App J Radley with a Severe Reprimand and advised him in the strongest terms that he must ensure that he is fully clear of other riders mounts front legs when shifting ground in the future.

#### **RACE 2 – 12.20 PM – THE STABLES AT SPREYTON (BM64) - (1880 METRES)**

The start of this event was delayed by three minutes due to STEEL MY SUNSHINE having to be re bridled.

| <b>1, EARENDEL</b>             | Bumped upon jumping. Raced three wide to the 1000m. A post race swab sample was taken from this winner for analytical testing.  |
| <b>4. MAKEWHOLE -</b>          | Jumped outwards upon jumping, bumping another runner. A post race veterinary examination was ordered on the gelding as it failed to run on over the final 200m. Upon inspection the gelding showed signs of some pain in its right fore tendon. Pain relief was administered, and a certificate of soundness will need to be tendered prior to being nominated to race again. |
| <b>7. STEELE MY SUNSHINE -</b> | Became fractious in the barriers, dislodging its bridle and had to be refitted. Underwent a veterinary examination prior to the start and passed fit to take its place in the field. The trainer will be advised that a warning will be placed against the barrier manners. Tended to over race in the early and middle stages of the event.                                  |

#### **RACE 3 – 1:00 PM – GOODSTONE GROUP HANDICAP - (1009 METRES)**

| <b>1. SIMPLY DEEP</b>      | Tightened for room between runners shortly after the start losing its position. A post race swab sample was taken from this winner for analytical testing.  |
| <b>3. OHSHE'S TROUBLE</b>  | Became fractious in the barriers. Shifted outwards shortly after the start.   |
| <b>4.SAY IT WITH WORDS</b> | Tended to over race in the early and middle stages of the event. Shifted out abruptly approaching the 600m when eased off the heels of the runner in front. |
| <b>6. PLATINUM REGGAE</b>  | Became fractious in the barriers. Shifted inwards shortly after the start.  |

The announcement of correct weight was delayed when the connections of the second-place horse by the judges HIGHLAND DUEL (app J Radley) and trainer L Gaffney wished to view the official patrol films as they were contemplating lodging a protest against the winner SIMPLY DEEP (App L Bingley) for alleged interference over the concluding stages. After viewing the official patrol films and taking the official margin of ½ Head into consideration the connections were satisfied there was minimal interference and did not wish to lodge an objection. The announcement of correct weight was given on the judge's numbers:

- 1<sup>st</sup> – SIMPLY DEEP
- 2<sup>nd</sup> – HIGHLAND DUEL
- 3<sup>rd</sup> – PLATINUM REGGAE
- 4<sup>th</sup> – ZOETE'S ROCK

#### **RACE 4 – 1:40 PM – SIMONS CARPETS DEVONPORT (BM76) - (1009 METRES)**

**2. BOLD INSTINCT -**

A post race swab sample was taken from this winner for analytical testing.

**6. WARICA -**

Inspected by the farrier prior to leaving the mounting yard requiring a shoe adjustment.

The declaration of Correct Weight was delayed allowing connections of the second-place runner PERWINKLE (Trainer S Carr) to view the official photo finish of the event as in their opinion they may have won the race. After advising the official judge to place the margin between the two runners on the monitor, connections were satisfied that there was a short half head between them, and correct weight was declared on the judge's numbers.

Stewards questioned riders B Muhcu (ANYWAYS ROXIE) and App C Wells (BOLD INSTINCT) in the presence of Senior Rider advocate Cody Jordan into reasons why ANYWAYS ROXIE had to be eased by its rider approaching the 900m. It was established that approaching the 900m, PERIWINKLE (J Johnson) shifted inwards to gain a leading position closer to the rail and BOLD INSTINCT who was racing to the outside also angled inwards to follow PERWINKLE closer to the rail. In this move Rider App C Wells was not fully clear of ANYWAYS ROXIE (B Muhcu) who had to be restrained off the heels of BOLD INSTINCT. Stewards after taking evidence from all riders and acting on their own observations along with viewing the official patrol films issued Apprentice C Wells with a Severe Reprimand on this occasion. Stewards took into account App C Wells' very good record when considering this penalty and was reminded of her obligations in similar circumstances.

Stewards questioned apprentice J Johnson in the presence of Mr. K Ring acting as apprentice advocate, into reasons why over the final stages he may have not ridden his mount fully to the line as required into second place given the margin of a short half head to the winner. Apprentice J Johnson was not aware he may have stopped riding and confirmed after viewing the official patrol films he may have slightly sat up for one stride over the concluding stages. Mr. K Ring added that in his opinion the apprentice may have sat up to push the horse in the tight finish with the winner BOLD INSTINCT. Stewards were satisfied with the explanations received, however reminded apprentice J Johnson that he should ensure he rides his mounts fully to the finish line as required by the Rules of Racing.

**RACE 5 – 3:04PM – KEVIN SHARKIE HANDICAP (C2) - (1350 METRES)**

**2. RICH GLOW -**

A post race swab sample was taken from this winner for analytical testing.

**3. MOHNAR -**

Tended to over race in the early and middle stages.

**4. LIONS TOOTH -**

Brushed with another runner in the home straight.

**5. RUBICK'S AFFAIR -**

Raced three wide to the 1000 meters and tended to over race at various stages.

**6. THE PRAYER -**

Raced wide making the home turn.

**8. MARTINI BLUE -**

Tended to lay in under pressure in the home straight and brushed with another runner and had to be straightened by its rider.

### **RACE 6 – 3:00PM – TASMANIAN HORSE TRANSPORT PLATE - (C6) - (1350 METRES)**

Due to a transmission fault there was no SKY Channel racing vision, which was rectified prior to the next event.

### **RACE 7 – 3.40 PM – LENDING 4 U - (BM60) -1150 METRES)**

| <b>3. CORNELIAN BAY -</b>     | A post race swab sample was taken from this winner for analytical testing.  |
| <b>5. ADACHI -</b>            | Tended to over race in the early and middle stages of the event.  |
| <b>8. GUNSHIP -</b>           | Became fractious in the barriers and reared striking its head on the uprights and got down on its hocks in the gates. It was removed from the barriers and underwent a veterinarian examination. Swards declared the gelding a late scratching at 3.42pm after consultation with the veterinarian behind the barriers. The trainer was advised that a certificate of fitness will be required before being nominated for a race and a satisfactory trial must be performed before racing again. |
| <b>9. POWER MAGNUM -</b>      | Jumped outwards upon jumping bumping another runner.  |
| <b>10. ROMANESCO FRESCO -</b> | Bumped upon jumping. Tended to over race in the early stages. Raced three wide throughout the event.  |

Rider A Darmanin, who was the rider of GUNSHIP, who became fractious in the barriers and was a late scratching, was examined by the clubs Doctor Ms. T Rahman and Medical Edge Paramedics behind the barrier's stalls. The findings were that he sustained a superficial / minor crush injury to his right leg resulting in a calf strain. Rider A Darmanin was stood down for his remaining riding engagement.

### **RACE 8 – 4.20 PM - STALL GATE KIOSK - (BM 68) – 1650 METRES)**

- 1. CARNEROS –** Became fractious in the barriers.

**2. SHY GUY** – Held up for a clear run in the home straight and shifted inwards to gain a clear run.

**3. SPRING BEAN** – Had to momentarily steady leaving the front straight on the first occasion. A post-race swab sample was taken from this winner for analytical testing.

**5. KIREINA MARUBRAH** – Tended to shift out under pressure in the home straight.
