If you are eligible and wish to be able to claim back GST that you pay on your purchases you should apply for an ABN and register for GST – **DO NOT** complete the Statutory Declaration.

4. I declare that my involvement in harness racing is undertaken without reasonable expectation of a profit. I will not be making a taxation deduction for any expenses associated with my involvement with harness racing.
5. Should any of these circumstances change I will advise the controlling body for harness racing in my State immediately.
