



HOBBYIST DECLARATION

If you have indicated that you are a "Hobbyist", you are confirming that you are a Genuine Hobbyist who is not able to claim a credit for GST paid on your Harness Racing purchases. If you wish to be able to claim back GST that you pay on your purchases, you should register for GST with an Australian Business Number (ABN).

- 1. I/We participate in harness racing as an owner/entity-owner "not considered to be carrying on an enterprise", but as a hobby or recreational pursuit.
- 2. I/We understand that under the Tax System if I/we are "not considered to be carrying on an enterprise", but as a hobbyist participant in harness racing, we will NOT be able to claim an input tax credit ("refund") for Goods and Services Tax that we pay on our purchases.
- 3. I/We declare that our supply of horses for harness racing is an activity done as a private recreational pursuit or hobby or is wholly of a private or domestic nature for us/me.
- 4. I/We declare that our involvement in harness racing is undertaken without reasonable expectation of a profit. I/We will not be making a taxation deduction for any expenses associated with our involvement with harness racing.
- 5. Should any of these circumstances change I/we will advise the controlling body for harness racing in our State immediately.
- 6. The details on page 4 of this document are true and correct.

If you do not provide to Tasracing the personal information requested by this document the main consequences for you is likely to be that Tasracing may not be able to process your application and/or your application may be considered invalid.

You have the right to access your personal information by request to Tasracing and you may be charged a fee for this service. If you consider any of the personal information held by Tasracing to be incorrect or not up-to-date, please contact Tasracing.
