3. I declare that my supply of horses for thoroughbred racing is an activity done as a private recreational pursuit or hobby or is wholly of a private or domestic nature for me.
4. I declare that my involvement in thoroughbred racing is undertaken without reasonable expectation of a profit. I will not be making a taxation deduction for any expenses associated with my involvement with thoroughbred racing.
5. Should any of these circumstances change I will advise the Controlling Body for thoroughbred racing in my State immediately.
