

## STABLE EMPLOYEES & TRACKWORK RIDERS

Trainers and participants should be aware that although a person may hold a Stable Employee and/or Trackwork Riders licence with another jurisdiction they are not permitted to automatically work in Tasmania and **MUST** make application to be registered in Tasmania.

On or preferably prior to arrival in the state participants should **IMMEDIATELY** contact the Tasracing Integrity Unit (TIU) on 6777 1900 to obtain the necessary application forms to be licensed.

In accordance with Local Rules persons, currently licensed by an interstate jurisdiction, may be permitted to undertake these duties for a Tasmanian licensed trainer under the following provisions.

### **Stable Employees - Local Rule 19.1(c)**

- a) A license application is lodged with the Tasracing Integrity Unit (TIU) prior to commencing work and a satisfactory clearance is obtained by the TIU from the PRA where the person is currently licensed.
- b) All outstanding documentation including criminal history record check is provided to the TIU within 30 days of the initial application.
- c) The person may only perform roles for one nominated trainer until a Tasmanian licence application is approved.

### **Trackwork Riders – Local Rule 19.2(f)**

- i. A licence application is lodged with the Tasracing Integrity Unit (TIU) prior to commencing any trackwork duties; a satisfactory clearance is obtained by the TIU from the PRA where the person is currently licensed and the person has undertaken a riding ability assessment to the satisfaction of Stewards or appointed track steward, prior to undertaking any riding duties.
- ii. All outstanding documentation including criminal history record check and medical examination report is provided to the TIU within 30 days of the initial application.
- iii. The person may only perform roles for one nominated trainer until a Tasmanian licence application is approved.

Trainers are reminded that it is an offence to have an unregistered person performing stable employee and trackwork rider duties as part of their training activities.

### **Stable Employee & Trackwork Riders with Visiting Trainer (Local Rule 19.3)**

Stable Employees and Trackwork Riders currently licensed in another jurisdiction may continue to undertake the duties on that licence when in Tasmania assisting a trainer who has a current Visiting Trainer Permit under the following provisions –

- a) The person is listed on the particular trainer's Visiting Permit application lodged with the Tasracing Integrity Unit (TIU).
- b) A satisfactory clearance is obtained by the TIU from the PRA where the person is currently licensed.
- c) The person is only permitted to undertake duties for the trainer with the Visiting Permit.
- d) The person is not permitted to undertake duties for a Tasmanian licensed trainer unless they meet the requirement of LR 19.1(c) and 19.2(f).

A **Visiting Interstate Stable Employee** application must be submitted to the TIU prior to arriving in Tasmania. The TIU will obtain a clearance from the home state jurisdiction of the applicant. The applicant must hold a current Stable Employee licence in their home state to be granted a Visiting Stable Employee licence.

**International Applicants** must also provide a copy of their passport and visa which indicates they have immigration permission to work in Australia.
