TASBRED Eligibility

TASBRED eligibility is included upon lodgement of this foal notification with the Office of Racing Integrity, Tasmania. To be eligible the following criteria must be met – (1) The mare is served, naturally or artificially, by a stallion registered and standing in Tasmania; or (2) The mare is lawfully inseminated in Tasmania by semen from any registered stallion provided that the resultant foal is born in Tasmania. Tasracing has absolute discretion to make determinations regarding Tasbred eligibility. Foal notification is free provided notification is lodged with the Office of Racing Integrity, Tasmania no later than three (3) months from the date of foaling. Penalties may apply if lodged after that time.
