- 4. You stabled MELODY BEACH & OUR IDEAL FELLA at a training premises other than your registered training address from 03 October 2020 to 04 October 2020 without prior permission of the Office of Racing Integrity Stewards.

# **Tammy Langley**

AHRR119C(1). The particulars of the Charge:

- 5. You are a trainer licenced by the Office Of Racing Integrity and are bound by the Australian Harness Racing Rules.
- 6. You are and were at all relevant times the trainer of CHRISTIAN MAJOR.
- 7. CHRISTIAN MAJOR was nominated for, and did compete in Race 5 TASMANIAN HORSE TRANSPORT SHOW CUP at Launceston Pacing Club on 04 October 2020.
- 8. You stabled CHRISTIAN MAJOR at a training premises other than your registered training address from the 03 October 2020 to 04 October 2020 without prior permission of the Office of Racing Integrity Stewards.

#### FACTS:

Overnight 03 October 2020 to 04 October 2020 trainers Miss Taylor Ford and Miss Tammy Langley both stabled horses at an address other than that of their registered training address without prior approval of the Office of Racing integrity Stewards.

#### **DECISION:**

## **Taylor Ford**

In considering penalty, stewards took into consideration all of the evidence given throughout the inquiry, including but not limited to:

- The importance that stewards are aware of the location of all horses at all times particularly when they are engaged to race
