RACE 1 – CAVALOR EQUINE PACE – 1609 METRES

MOTH HUNTER raced greenly during the score up and was out of position as the field was released. This filly has been placed on its last chance in the mobile start draw.

BOBBIE ADDISON raced roughly for a few strides as the field raced out of the home straight on the final occasion.

MOTH HUNTER was held up for clear racing room over the concluding stages.

ASHANTE QUEEN shifted out under pressure over the concluding stages.

GUENEVERES ANGEL was placed back in the mobile start draw.

Driver Ryan Backhouse (ASHANTE QUEEN) pleaded guilty to a charge under AHRR 156(3) in that he used the whip continuously over the concluding stages without giving this filly time to respond. Mr Backhouse was fined the sum of \$100.

RACE 2 – TASMANIAN HORSE TRANSPORT PACE – 2090 METRES

CASTLE RETREATS' lugging pole became dislodged during the score up causing a false start. No action was taken against this gelding

MOST PERFECT MAJOR was out of position at the start, due to the previous false start no action was taken against this mare.

MAGIC PEBBLES was caught wide early and restrained to the rear of the field.

THE DEMOCRAT was caught wide early and restrained to the rear of the field.

CHEDDAR VALLEY NZ hung in, contacting marker pegs as the field raced towards the bell. A warning has been placed on this gelding.

JACK JAMES utilised the sprint lane.

ENDEAVOUR STRIDE gave ground over the concluding stages to be beaten in excess of 49 metres.

RACE 3 – PRYDES EASIFEED PACE – 2090 METRES

KIAVINO STRIDE pulled hard during the early and middle stages until working forward to the lead.

SOUTHSHORE NZ was held up for clear racing room over the concluding stages.

SHARMEY underwent a post-race veterinary examination, revealing it had bled from one nostril. Under the provisions of AHRR101B this gelding has been stood down until the completion of a satisfactory trial.

RACE 4 – CASCADE DRAUGHT PACE – 2090 METRES

EUREKA NZ raced outside the leader in the early stages of this event, before being restrained behind the leader.

LOCKAWAY KACIE was held up for clear racing room as the field raced into the home straight on the final occasion.

AHA REACTION NZ pulled hard at various stages during this event and was held up for clear racing room behind CULLENBURN NZ and ISAAC as the field raced around the home turn on the final occasion.

RACE 5 – TYPEFACE PACE – 2090 METRES

MAYLEEJAE EAGLE (Ryan Backhouse) withstood an early challenge for the lead from CAROLS JUDGE, before obtaining a trail behind CAROLS JUDGE. MAYLEEJAE EAGLE tired, to be beaten in excess of 57 metres. This gelding has been placed on its last chance to race competitively.

POPNPENNIES tired, to be beaten in excess of 72 metres. This mare has been placed on its last chance to race competitively.

ALL FOR DAVE tired, to be beaten in excess of 53 metres. This gelding has been placed on its last chance to race competitively.

BETTERTHANFETTA tired, to be beaten in excess of 60 metres. This gelding has been placed on its last chance to race competitively.

STAROFREMEMBRANCE tired, to be beaten in excess of 58 metres, a post-race veterinary examination revealed no abnormalities. After taking into account this mares recent race record she has been stood down for fourteen days and until the completion of 2 satisfactory trials.

GALAXY DANCER has been placed back in the draw for future mobile start events.

Stewards questioned the driving tactics of Ryan Backhouse who stated that he initially withstood the challenge from CAROLS JUDGE, however, he relented to the pressure from this mare and handed up the lead. Mr Backhouse explained that the mare commenced to pull hard resulting in him shifting off the fence at the 1100 metre mark. In hindsight Mr Backhouse believed that in similar circumstances he would consider relinquishing the lead earlier. Stewards noted Mr Backhouses comments.

RACE 6 – TASMANIAN EQUINE VETERINARY SERVICES PACE – 2090 METRES

BUSTER WILLIAM broke during the early stages of the score up however was in position at the start. This gelding also shifted out under pressure over the concluding stages.

IYLAC BEACH broke shortly after the start was affected. This gelding has been placed outside the draw in future mobile start events.

WE SALUTE YOU was severely checked by the galloping IYLAC BEACH.

MONTANA FLASH shifted out under pressure over the concluding stages.

PUNTARNO STRIDE NZ was held up for clear racing room before utilising the sprint lane.

Driver Ryan Backhouse (Montana Flash) pleaded guilty to a charge under AHRR 156(3) in that he used the whip continuously over the concluding stages without giving this gelding time to respond. Mr Backhouse was fined the sum of \$200.

RACE 7 – YOUNG GROUP PACE – 1609 METRES

BLACKBIRD MISS raced roughly after start. This mare has been placed on its last chance in the draw.

BLACKBIRD MISS hung out for much of the back straight, before contacting the sulky of MISSIN ROCK at approximately the 400-meter mark. This mare has been placed on its last chance to race truly.

SAFE JEWELS was severely checked by the galloping BLACKBIRD MISS, causing this mare to race roughly for a short distance.

MISSIN ROCK sulky was contacted by the galloping BLACKBIRD MISS, checking MISSIN ROCK.

CINOCAL JAMANE, TRUE STEPPER and QUEENOFDANCE NZ were severely checked by the galloping BLACKBIRD MISS.

LESYA utilised the sprint lane.

RACE 8 – NUTRIEN SPRINTLAND – 2090 METRES

SEA HAWKE pulled hard for much of this event, before tiring to be beaten in excess of 87 metres. This gelding underwent a post-race veterinary examination, revealing no abnormalities. SEA HAWKE has been placed on its last chance to race competitively.

TEE JAY CEE gave ground over the concluding stages.

Driver Luke Hooper (TO THE LOOKOUT) pleaded guilty to a charge under AHRR 168(1)(j) in that he failed to maintain his position until the start.

Driver Mitch Ford (Vigoroso NZ) pleaded guilty to a charge under AHRR 168(1)(a) in that he carelessly contacted the sulky of TEE JAY CEE shortly after the start. Mr Ford was fined the sum of \$100.

RACE 9 – LADBROKESPACE – 2090 METRES

MAYWYN MACDUFF tired to be beaten in excess of 56 metres. This gelding has been placed on its last chance to race competitively.

MACH ANGELO tired, to be beaten in excess of 53 metres. This gelding has been placed on its last chance to race competitively.

EYE SEE DOUBLE gave ground over the concluding stages.

SLINGSHOT tired to be beaten in excess of 57 metres. This gelding has been placed on its last chance to race competitively.

BRIAN WHO tired to be beaten in excess of 57 metres. This gelding has been placed on its last chance to race competitively.

KING OF COOL tired to be beaten in excess of 51 metres. This gelding has been placed on its last chance to race competitively.
