### **RACE 1 – 6TY TWO YEAR OLD – 1680 METRES**

PROMISE STRIDE showed gate speed to lead and then gave ground over the concluding stages to be beaten in excess of 33 metres.

FIRECRACKER NOLA was restrained to the rear of the field after the start.

BOBBIE ADDISON was tightened around the first time when racing in a three wide position.

JULEPE SANZ was caught wide early and hung in around the first turn tightening BOBBIE ADDISON on its inside. A warning was issued.

BOLT YOUR SOCKS ON was held up early before gaining clear running in the home straight.

### **RACE 2 – BOOK NOW FOR YOUR CHRISTMAS FUNCTION SATURDAY 3 DECEMBER PACE. – 2200 METRES**

CHEDDAR VALLEY NZ broke shortly after the start and has been placed out of the draw in future mobile events.

SEVENTHREEOHSEVEN worked forward three wide in the middle stages to race outside the leader.

A warning was issued to BRIDWOOD BELLA which had a tendency to hang out and momentarily raced in a four wide position approaching the bell.

### **RACE 3 – BEVAN LEE'S BUTCHERY STAKES. – 2200 METRES**

BETTOR BLAST NZ broke in the score-up, was well out of position at the start and will be placed out of the draw in future mobile events.

BETTOR BLAST NZ broke free of interference and will be placed on its last chance to race truly.

After beginning satisfactorily THEUGLYSISTER has been reinstated in the mobile draw.

After beginning satisfactorily LOU LOUS ALLGOLD will now revert from right out of the mobile draw to out of the mobile draw.

Stewards cautioned driver P Hill (MAXI JOLT) regarding his failure to adhere to the sectional time policy. Stewards took into account the manners of this gelding and the actions of Mr Hill in attempting to quicken the pace during this section of the event.

TOMMI BRULEE underwent a post-race veterinary examination after tiring to be beaten in excess of 135 metres. No abnormalities were detected and the gelding has been stood down for a period of 14 days and until the completion of two satisfactory trials.

#### **RACE 4 – TRAINERS ENCOURAGEMENT PACE. – 1680 METRES**

IMPULZE broke as the start was effected and has been placed out of the draw in future mobile events.

A warning was issued to MAJOR DAVVIN after the gelding hung in down the back straight the final time.

LOYOLA TRIOS underwent a post-race veterinary examination after giving ground to be beaten in excess 48 metres. No abnormalities were detected.

#### **RACE 5 – TASSIE GOLDEN APPLE RACE MEETING SATURDAY 3 DECEMBER PACE – 2200 METRES**

HICKSTEAD NZ was out of position at the start and has been placed on its last chance in the mobile draw.

COLBY SANZ was caught wide early and worked forward three wide to race outside the leader.

BUSTER WILLIAM raced outside the leader early before working to the lead at the 1600 metre mark.

AHA REACTION NZ pulled hard during the event.

MONTANA FLASH underwent a post-race veterinary examination after tiring to be beaten in excess of 57 metres. No abnormalities were detected. Stewards spoke to trainer B Yole regarding the apparent poor performance of this gelding Mr Yole was at a loss to explain this geldings performance however undertook to keep Stewards informed if anything that may have affected his performance should arise in the coming days.

Driver M Ford (JAWBREAKER) was suspended for two race meetings after pleading guilty to a charge under AHRR163(1)(a)(iii). Particulars of the charge were that when shifting wider from a position behind the leader he made contact with the front leg of COLBY SANZ (G Rattray) causing interference to this gelding. Mr Fords good record and his guilty plea were taken into account when arriving at this penalty.

#### **RACE 6 – FAMILY FUN NIGHT SATURDAY 3 DECEMBER PACE – 1680 METRES**

EQUITY STRIDE was caught wide early before being restrained to the rear of the field.

WATTABOUT SPANGHER shifted out under pressure in the home straight.

ENDEAVOUR STRIDE gave ground over the concluding stages to be beaten in excess of 31 metres.

#### **RACE 7 – FIND US ON FACEBOOK PACE – 2200 METRES**

SEA HAWKE was restrained to the rear of the field after the start.

SZABOLSKI LEIS was restrained to the rear of the field after the start.

SANUR BEACH underwent a post-race veterinary examination after tiring to be beaten in excess of 51 metres. The examination revealed swelling to the horse near side knee and the gelding has been stood down until the receipt of a veterinary clearance.

WHATTA GOOD REASON was held up and inconvenienced when SANUR BEACH tired.

#### **RACE 8 – GREAT NORTHERN SUPER CRISP PACE – 2200 METRES**

The start of this race was delayed for 4 minutes due to a gear change required to BE GOOD BENNY.

All clear was held on this race to enable M Yole (WRITTEN IN SILK) to view the official replay of the home straight. After viewing the films all clear was given on the judges numbers.

A warning was issued to FURY DAN which shifted out under pressure in the home straight. BOLTNMACH obtained an inside run in the home straight when FURY DAN shifted out.

Stewards cautioned driver N Ford (FURY DAN) regarding his failure to adhere to the sectional time policy. Stewards took into account the minimal time breach and the fact that FURY DAN race clear in the lead during this section of the race.

Trainer B Yole was fined the sum of \$200 under AHRR273(2)(d) for presenting BE GOOD BENNY in gear which was deemed to be in poor condition.

### **RACE 9 – CARLTON DRAUGHT PACE – 2200 METRES**

SMILE LYLE was placed on its last chance in the draw after being out of position at the start.

RAFFAS ACE was caught wide early before being restrained to the rear.

IDEAL KARALTA raced roughly as it worked forward three wide in the back straight the first time.

KARALTA DAZZLER was restrained to the rear of the field after the start.

GRAPHITE STRIDE and SMILE LYLE locked wheels in the back straight the final time checking HEZA RUMMAGE NZ

DON HESTON underwent a post-race veterinary examination after tiring to be beaten in excess of 102 metres. No abnormalities were detected and the gelding has been stood down until the completion of a satisfactory trial.

COVERED KYLIE underwent a post-race veterinary examination after tiring to be beaten in excess of 332 metres. No abnormalities were detected. After taking into account the recent race record of the mare Stewards stood her down for a period of 14 days and until the completion of two satisfactory trials.

### **RACE 10 – LADBROKES RACING CENTRE STAKES – 2200 METRES**

BOLD CENTURIAN was caught wide early before being restrained to the rear of the field.

TEE JAY CEE worked forward three wide to race outside the leader before gaining a trail when TURQUOISE STRIDE worked forward to take over that position

LEFT A HURRIKANE was held up and checked behind a tiring runner then tired to be beaten in excess of 82 metres. The gelding has been placed on its last chance to race competitively.

DONT WRITE ME OFF NZ underwent a post-race veterinary examination after tiring to be beaten in excess of 104 metres. No abnormalities were detected and the gelding has been stood down until the completion of a satisfactory trial.

STYLISH TREND NZ underwent a post-race veterinary examination after tiring to be beaten in excess of 84 metres. No abnormalities were detected and the gelding has been placed on its last chance to race competitively.
