RACE 1 – JEREMY ROCKLIFF PACE – 1670 METRES

RESURGENT WARRIOR was out of position at the start and has been placed on its last chance in the mobile draw.

NAUTIBUTNICE gave ground over the concluding stages to be beaten in excess of 27 metres.

RACE 2 – BARUNAH STOCK FEED STAKES – 1670 METRES

EMJAYS BLACK CHIP was held up and unable to be fully tested.

QUEENOFDANCE NZ underwent a post-race veterinary examination after giving ground to be beaten in excess of 39 metres. This mare was found to be showing signs of lameness and has been stood down pending a veterinary clearance.

RACE 3 – LADBROKES PACE – 2150 METRES

RECKLESS DREAM worked forward three wide in the middle stages to race outside the leader.

SOFTLY SOFTLY gave ground over the concluding stages to be beaten in excess of 38 metres.

BE GOOD BENNY gave ground over the concluding stages to be beaten in excess of 37 metres.

RACE 4 – WESTWOOD QUARRY STAKES – 2150 METRES

PACIFIC ROCK galloped soon after the start and has been placed out of the draw in future mobile events.

KERMADEC was severely checked and locked wheels with PACIFIC ROCK when that horse galloped in the early stages. In this incident the off-side fork on the cart of KERMADEC broke and the gelding was retired from the event.

EL JAYS BLU was inconvenienced shortly after the start by the galloping PACIFIC ROCK.

IMPULZE was out of position as the start was effected. Driver L Older was fined the sum of \$100 after pleading guilty to a charge under AHRR162(1)(j). Particulars were that he failed to maintain his position behind the barrier until the start.

HEZ A FAKE shifted out under pressure in the home straight.

RACE 5 – CRESSY TRANSPORT TASMANIAN COUNTRY CHAMPIONSHIP – 2150 METRES

HES APPLES was out of position at the start and will continue out of the draw in mobile events.

BIG BOY MAL worked forward three wide in the middle stages to take the lead.

SPORTS ILLUSTRATOR broke turning for home and has been stood down until the completion of a satisfactory trial.

FORSAKEN ME was checked behind a galloping runner in the home straight.

SOLO SYNC was held up early before gaining clear running in the home straight.

Driver B Davis (THE GARDENER) was fined the sum of \$50 under AHRR52(5) for failing to return to the All Clear Steward after finishing in fifth placing.

RACE 6 – LAUNCESTON BOBCAT HIRE STAKES – 2150 METRES

On return to the All-Clear driver D Ford, (BE MAJOR THREAT) which finished in second placing lodged a protest against the winner THE SHALLOWS, (H Woods) alleging interference approaching the 400 metres and again in the home straight the final time. After taking evidence from both drivers and viewing the official replays Stewards dismissed the protest and all clear was given on the judges numbers. It was established that approaching the 400 metres when THE SHALLOWS was moved down the track to the one out line BE MAJOR THREAT was slightly inconvenienced and, in the home straight the final time THE SHALLOWS had shifted up the track under pressure however had caused no interference to BE MAJOR THREAT. Given all circumstances the protest was dismissed.

LIP READER was caught wide early before restraining to the rear of the field.

AHA REACTION NZ pulled hard during the event.

FRANCO HAMPTON NZ underwent a post-race veterinary examination after giving ground to be beaten in excess of 41 metres. No abnormalities were detected.

JAWBREAKER was inconvenienced behind a tiring runner.

Driver D Ford (BE MAJOR THREAT) was cautioned regarding his whip action and advised to modify his action to prevent any future breaches of the whip rule.

RACE 7 – S & M HORSE TRANSPORT PACE – 2150 METRES

CHRIS BE QUICK was out of position at the start and has been placed on its last chance in the mobile draw.

STONE CRACKER was caught wide early before working forward three wide to race outside the leader.

RACE 8 – CARRICK ROADHOUSE PACE – 2150 METRES

After beginning satisfactorily CHEDDAR VALLEY NZ has been reinstated in the mobile draw.

JUNIPER was caught wide early before being restrained to the rear of the field.

CHEDDAR VALLEY NZ broke free of interference on the first turn and has been placed on its last chance to race truly.

Driver B Parker, (KIVIK) was fined \$200 after pleading guilty to a charge under AHRR156(2)(a). Particulars of the charge were that he used his whip with more than a wrist only flicking motion.

RACE 9 – PFEIFFER CRANES STAKES – 2150 METRES

ROCKNROLL WIZARD broke in the initial score-up causing a false start and has been placed out of the draw in future mobile events.

WRITTEN IN SILK was out of position as the start was effected. Driver O Weidenbach was fined the sum of \$100 after pleading guilty to a charge under AHRR162(1)(j). Particulars were that she failed to maintain her position behind the barrier until the start.

Driver L Older, (BOLTNMACH) was fined the sum of \$100 after pleading guilty to a charge under AHRR168(1)(a). Particulars were that he allowed his horse to race forward and contact the wheel of CINOCAL JAMANE near the 1200 metres.

ROCKNROLL WIZARD broke free of interference in the back straight the final time and has been stood down until the completion of a satisfactory trial.

RACE 10 – JAMIE LEALE APPRECIATION STAKES – 2150 METRES

VINNY CHASE obtained an inside run to win the event.

Driver C Crossland (URUS NZ) was fined the sum of \$200 after pleading guilty to a charge under AHRR162(1)(www)(c). Particulars of the charge were that after leading into the home straight he allowed his horse to shift ground advantaging another runner which went on to win the event.

SALVATOR MUNDI which led the event before tiring to be beaten in excess of 105 metres underwent a post-race veterinary examination. No abnormalities were detected and the gelding has been stood down until the completion of a satisfactory trial.

NOVA BAXTER was inconvenienced by a tiring runner.

C Crossland (URUS NZ) was fined the sum of \$250 under AHRR170(4)(a) for allowing his right foot to lower from the footrest and be placed in the vicinity of his gelding's hind leg near the 150 metres.
