

# **STEWARDS REPORT**

## RACE 1 – CAVALOR EQUICARE PACE – 2090 METRES

KIAVINO STRIDE led the event and contacted its own sulky wheels and over raced.

EUROKING gave ground over the concluding stages to be beaten in excess of 42 metres.

## RACE 2 – PRYDES EASIFEED PACE – 1609 METRES

JACK JAMES was restrained after the start.

GORDIEVSKY LEIS was restrained after the start.

KOLOVOS NZ was restrained after the start.

WHEY BETTER was restrained after the start.

SZABOLSKI LEIS led early then was unable to hold the front when JAWBREAKER worked forward three wide to take over that position.

A warning was issued to SZABOLSKI LEIS which hung in and contacted marker pegs after the 800 metres.

## RACE 3 – LADBROKES PACE – 1609 METRES

BEE SEVENTEEN underwent a pre-race veterinary examination which revealed a small cut to the tongue and was deemed suitable to race.

BEE SEVENTEEN was restrained after the start.

SUTTER STAR was restrained after the start.

LIFEOFBRIAN NZ utilised the sprint lane in the run to the finish.

### RACE 4 – NUTRIENT SPRINTLANE PACE – 2090 METRES

LORIMERTYRREL broke in the score up and was out of position when the start was effected. The mare has been placed out of the draw in future mobile events.

DON HESTON was caught wide early before being restrained to the rear.

IMAGE OF STARZZZ was caught wide early before being restrained to the rear.

TURQUOISE STRIDE worked forward in the middle stages to race outside the leader.

BE GOOD BENNY utilised the sprint lane in the run to the finish.

#### RACE 5 – TYPEFACE PACE – 2579 METRES

COOL SCOOTER NZ was restrained after the start.

STALEY was restrained after the start.

WAYONBYE led early then surrendered the lead in the middle stages. The gelding shifted wider rounding the home turn affording SHARMEY an inside run. Driver J White was reprimanded under AHRR168(1)(a) in that he allowed his horse to shift ground around the final time when adjusting removable gear.

KENYA NZ raced outside the leader early before working to the lead at around the 1200 metre mark.

SHARMEY obtained an inside run around the home turn then utilised the sprint lane in the run to the finish.

LETSPLAYUNI underwent a post-race veterinary examination after tiring to be beaten in excess of 63 metres. No abnormalities were detected and the gelding has been placed on its last chance to race competitively.

ONEOFTHELADS worked forward in the middle stages to race outside the leader.

#### RACE 6 – TASMANIAN HORSE TRANSPORT PACE. – 2090 METRES

Driver J Leedham (VIVID STRIDE) was reprimanded under AHRR162(1)(j). Particulars were that he failed to maintain his barrier position until the start was effected.

LETHERROCKNROLL NZ underwent a post-race veterinary examination after tiring to be beaten in excess of 184 metres. The mare was displaying a poor recovery and has been stood down for a period of 14 days and until the completion of two satisfactory trials.

#### RACE 7 – YOUNG GROUP PACE – 2090 METRES

RADAR STRIDE was fractious and delayed the start. The gelding has been placed on its last chance in the standing start draw.

STYLISH TREND NZ galloped out and has been placed on its last chance in the standing start draw.

OZZIE MAJOR galloped out and has been placed out of the standing start draw.

KEEP PLAYING reared as the start was effected and then galloped away. The gelding will continue to be out of the standing start draw.

After beginning satisfactorily MISTA EAGLE has been reinstated in the standing start draw.

A post-race veterinary examination revealed HEZA RUMMAGE NZ to have bled from both nostrils. Under AHRR101(3)(a) the gelding has been stood down for a period of three months. A veterinary clearance must be submitted before the gelding completes a satisfactory trial then being eligible to race again.

## RACE 8 - ST VIRGILS FOOTBALL CLUB PACE - 2090 METRES

JUDGE JUJON broke free of interference and has been placed on its last chance to race truly.

MAJOR ASSASSIN was inconvenienced when JUDGE JUJON broke.

IFBUTZANDMAYBES hung in during the score up before racing outside the leader. The gelding was then restrained to a trailing position before utilizing the sprint lane in the run to the finish.
