

STEWARDS REPORT

RACE 1 – LADBROKES STAKES – (2,180 METRES)

STYLISH TREND NZ – broke at the start – excluded from draw in future standing start races.

LONGNWINDINGROAD – fractious prior to start and broke when field was dispatched losing ground – continue to be excluded from standing start draws.

ULTIMATE ME NZ – broke at the start – continue to be excluded from the draw in standing starts; broke passing the 400 metres when back- stood-down one satisfactory trial.

Stewards delayed the all-clear to determine whether STYLISH TREND NZ had gained an advantage after breaking at the start and maintaining the lead while off-stride. After reviewing vision of the start the Stewards were satisfied that STYLISH TREND NZ had not broken for an excessive distance and the all-clear was duly authorised.

RACE 2 – RELAY FOR LIFE STAKES – (2,180 METRES)

IM QUITE AMERICAN – fractious prior to start then broke at dispatch- last chance in standing start draw.

FURY DAN – broke at the start and lost ground – last chance in standing start draws; broke near the 500 metres when weakening – last chance to race truly- post race veterinary examination revealed no obvious abnormality.

OUR RUBY ROSE – broke at start and lost ground – excluded from draw in future standing start races.

VIVID STRIDE – hampered after the start.

SHANOCON NZ – broke at the start - continue to be excluded from the draw in standing starts.

KING OF COOL – hampered shortly after the start; paced roughly throughout – broke passing the 550 metres and lost all chance. Last chance to race truly.

RACE 3 – 7BU PACE – (2180 METRES)

CHRIS BE QUICK – inclined to pace roughly on occasions and gave ground from 500 metres, finishing well back- last chance to race competitively.

BONZA GUY hung out throughout- gave ground from 700 metres and finished well back- post race veterinary examination revealed no obvious abnormality - warned racing manners.

REDS GOOD TO GO – over-raced during the running.

PICKLE IT – held up from 500 metres.

RACE 4 – JACKSONS SECURITY - SWEEPSTAKES – (2,180 METRES)

ROAD RUNNER NZ – broke when leading rounding the first bend and settled back- stood-down one satisfactory trial.

SEACHANGE – compounded from 700 metres and was distanced at the finish- post-race veterinary examination revealed no obvious abnormality -stood-down one satisfactory trial.

LALIBELA NZ - paced roughly for a short distance in the early stages.

RACE 5 – POLY WELDING SOLUTIONS STAKES – (2,180 METRES)

LETSPLAYUNI was a late scratching at 10:30am after trainer Mr Ben Yole became aware that the gelding was potentially an ineligible acceptor due to it obtaining its standing start qualification when not being permitted to trial. Given all circumstances no additional sanction was imposed.

MAJOR GENERALJUJON – broke at the start and lost ground- last chance in standing start draw.

SPORTS CANDY – held up passing the 500 metres and had to shift ground inward near the 300 metres to improve.

SEAL THE DESTINY – fractious prior to the start.

SHARMEY – slow into stride; gave ground latter stages – stood-down one satisfactory trial.

AMILLION PROMISES – slow into stride.

JACKSON NEPTUNE – broke at the start and settled back - last chance in standing start draw.

AQUA SANCTA NZ – held up passing the 400 metres.

RACE 6 – THE CATERING LADIES PACE. – (2,180 METRES)

GRAPHITE STRIDE – underwent a pre-race veterinary inspection and was passed fit to run.

DON HESTON – compounded passing the 500 metres and was distanced at the finish. A post-race veterinary examination of the gelding revealed no obvious abnormality – stood-down one satisfactory trial.

CINOCAL JAMANE – lay in when challenging for the lead passing 550 metres.

JOHN RICHARD – back in mobile draw.

RACE 7 – IMPRESS PRINT & DESIGN STAKES – (1,892 METRES)

SEA HAWKE – tangled for several strides at the start however recovered quickly; tightened rounding the first turn and paced roughly for a short distance.

TO THE LOOKOUT – broke at the start then inconvenienced - excluded from draw in future standing start races.

MONEY HONEY NZ – broke at the start -excluded from draw in future standing start races.

TURQUOISE STRIDE – slow into stride.

MACH ANGELO – broke at start – continue to be excluded from standing start draws.

CHRISTIAN JAZ NZ – lay in rounding first turn – driver fined; over-raced during the running; held -up from 400 metres until 150 metres.

Driver Todd Rattray admitted a breach of AHRR 168 (1)(a) with the particulars being the racing into the first bend when attempting to cross to the lead he shifted in when not fully clear of SEA HAWKE which was tightened and paced roughly for a short distance. In determining the appropriate penalty, the Stewards factored Mr Rattray's admission, his previously very good record, and the tractability of both horses at the time of the incident. Mr Rattray was fined \$200.00

RACE 8 – THANKS TO OUR VOLUNTEERS STAKES – (2,180 METRES)

ROCKS ARNT PETS – gave ground from the 500 metres and finished well back. Stood down 14 days and two satisfactory trials.

DAPPER NZ – broke at the start – last chance in standing start draws.

DEADLY ASSASSIN- broke at the start – last chance in standing start draws.

KOLOVOS NZ broke at the start - excluded from draw in future standing start races; paced roughly and hung in contacting marker pegs near the 1,800 metres; badly held up on the back of a tiring runner passing the 400 metres and lost ground.

PLEASE SHUDDUP NZ – broke at the start – continue to be excluded from standing start draws; broke near the 800 metres when back – last chance to race truly.

Driver Troy Madden admitted a breach of AHRR 163A (2) - with the particulars being that he failed to hold his reins in each hand prior to the finish. After consideration Mr Madden was fined \$100.00
