RACE 1 – AUSTRALIAN DRIVERS CHAMPIONSHIP HEAT 1 – 2200m Mobile

CAPTAIN COSMONAUT – Held up for clear running early in the home straight for the run to the finish, before switching back to the inside to improve along the marker line.

RACE 2 – AUSTRALIAN DRIVERS CHAMPIONSHIP HEAT 2 – 2200m Mobile

MARGARETS CLAN - Gave ground, beaten in excess of 50 metres. A warning was issued.

FORBIDDEN JEWEL NZ – Subjected to a post-race Veterinary examination after blood was detected in its mouth after the race. On inspection Dr J McKenna confirmed FORBIDDEN JEWEL NZ had a small laceration on the end of its tongue, with the probable cause being bitten.

SOUTHSHORE NZ – Raced ungenerously in the first 500 metres before settling. Gave ground, beaten in excess of 60 metres. A warning was issued.

THUMBS UP NZ - Tended to over-race and pull hard.

MAJOR MUCHA – Gave ground, beaten in excess of 50 metres. A warning was issued.

CASTLE RETREAT – Gave ground, beaten in excess of 70 metres. A warning was issued.

SLINGSHOT– Held up for clear running early in the home straight for the run to the finish.

VELOCITY STRIDE – Tended to hang out, over-race and pull hard in the middle stages.

RACE 3 – AUSTRALIAN DRIVERS CHAMPIONSHIP HEAT 3 – 2200m Mobile

I OF THE HURRIKANE– Held up for clear running early in the home straight for the run to the finish.

CAROLS JUDGE- Held up for clear running early in the home straight for the run to the finish.

STORMY SANZ – Caught wide in the early stages, worked forward to lead the one-out line. Raced rough over the final 500 metres. Subjected to a post-race Veterinary examination. On inspection Dr J McKenna found STORMY SANZ to be lame on the near-fore fetlock and as such will be stood down from racing pending a Veterinary Clearance.

NO NUKES SKIPPER NZ- Held up for clear running early in the home straight for the run to the finish.

KENYA NZ – Held up for clear running in the latter stages of home straight for the run to the finish.

COOL SCOOTER NZ – Held up for clear running early in the home straight for the run to the finish.

RACE 4 – AUSTRALIAN DRIVERS CHAMPIONSHIP HEAT 4 – 2200m Mobile

BUDGIESMUGGLER – Failed to secure clear running over the concluding stages.

TWO SOCK CREEK NZ – Raced ungenerously during the score-up.

IDEN BLACK PRINCE – Held up for clear running early in the home straight for the run to the finish.

ROCKSTAR REBEL – Held up for clear running early in the home straight for the run to the finish.

General: Due to severe lightning in the vicinity of Mowbray Racecourse, race 5 was delayed indefinitely, however as the storm intensified, and weather information worsened, Stewards deemed it unsafe for racing to proceed, and as such the remainder of the race meeting (races 5 to 8) was abandoned.
