

# RACE 1 - TASMANIAN HORSE TRANSPORT TASMANIAN 3YO GUINEAS - 2090m Mobile

MORE THAN THIS raced roughly as the field raced out of the home straight on the final occasion.

#### RACE 2 - PRYDES EASIFEED EVICUS HEAT ONE - 1609m Mobile

ELIZABETH DELILAH failed to circle and has been placed on its last chance in the mobile draw.

MACKEON hung in as the field raced around the home turn on the final occasion.

TAMBROS TILLY hung in as the field raced into the home straight on the final occasion.

DARE YOU TO MOVE gave ground over the concluding stages to be beaten in excess of 46 metres.

## RACE 3 - PRYDES EASIFEED DANDY PATCH HEAT ONE - 2090m Mobile

The start of this event was delayed due to Richmond Greyhounds running late.

TASSIE DAZZLER hung out shortly after the start, contacting the sulky of THUNDER SANZ, and sustaining a flat tyre.

TASSIE DAZZLER pulled hard during the early and middle stages and was retired from the event. Driver M Yole reported the gelding had choked down and was pulled up in the interests of safety. TASSIE DAZZLER has been stood down until the completion of a satisfactory trial. Trainer B Yole advised that the gelding will be sent for a short spell.

VINCENTAUR hung out and contacted the sulky of CUZZY BRO as the field raced into the home straight on the final occasion.

SERIOUSLY SAM has been placed back in the draw for future mobile start events.

## RACE 4 – CAVALOR EQUICARE 3YO FILLIES CHAMPIONSHIP – 2090m Mobile

The start of this event was delayed due to Richmond Greyhounds running late.

JULEPE SANZ was caught wide early and restrained to the rear of the field.

AREYAWATCHINGTHIS gave ground to be beaten in excess of 52 metres.

## RACE 5 – PRYDES EASIFEED EVICUS HEAT TWO – 1609m Mobile

The start of this event was delayed due to Grafton Greyhounds running late.

ORTEM MISS broke shortly after the start. This filly has been placed outside the draw for future mobile start events.

GLENWOOD BEAUTY raced roughly shortly after the start.

#### RACE 6 – PRYDES EASIFEED DANDY PATCH HEAT TWO – 2090m Mobile

IDEN KAMAKAZI was out of position at the candy pole and will continue to be placed outside the draw in future mobile start events. This gelding also raced roughly over the concluding stages.

MIKI SANZ raced greenly as the field raced into the back straight on the first occasion.

## RACE 7 – LADBROKE IT PACE– 2090m Mobile

The start of this event was delayed approximately 4 minutes due to a RACKEMUP TIGERPIE requiring its off side front shoe to be replaced.

Stewards questioned drivers Nathan Ford (AHA REACTION NZ) and Ewa Justice (HULI NIEN) along with stable representative Rohan Hillier (HULI NIEN) into the reason why there was a locking of sulky wheels on entering the first turn, before HULI NIEN broke gait and AHA REACTION NZ raced rough. Stewards, after taking evidence from both drivers and acting on their own observations could not place the blame for this incident on any one driver or horse, as both drivers had contested the one-out position which brought them together, initially caused the locking of sulky wheels, and as such took no action other than to note the circumstances. Stewards in assessing the incident noted HULI NIEN, which had drawn the inside of the second row, was racing ungenerously from the start as driver Justice restrained the gelding to move away from the inside line. in an attempt to be positioned in the one-out line. Meanwhile, driver Ford, who had begun from barrier 3 on the front row, began well and was in the process of moving AHA REACTION NZ down the track, also in an attempt to secure the one-out line. These simultaneous movements brought the sulkies together resulting in the locking of wheels, Stewards further noted, when the drivers attempted to disengage the wheels, HULI NIEN became unbalance, resulting in its hind leg striking the sulky of AHA REACTION NZ, with the result of HULI NIEN breaking gait and AHA REACTION NZ to racing rough.

SUNNY SANZ inconvenienced when HULI NIEN and AHA REACTION NZ locked wheels.

CULLENBURN NZ inconvenienced when HULI NIEN and AHA REACTION NZ locked wheels.

Trainer Troy Hillier (HULI NIEN and HICKSTEAD NZ) was reprimanded under AHRR 238 for failing to comply with a requirement under Harness Racing Policy 36, in that a trainer with two or more runners in a race must notify Stewards of the intended tactics of each runner no later than 60 minutes prior to the race.

#### RACE 8 - YOUNG GROUP PACE - 2090m Mobile

Driver R Hillier (MIA RAGAZZA) pleaded guilty to a charge under AHRR 162(1)(h) in that he failed to come fully into position at the start of this race. Mr Hillier was fined the sum of \$100.

## RACE 9 - NUTRIEN SPRINTLANE PACE - 2090m Mobile

LOU LOUS ALLGOLD broke during the score up causing a false start. This mare has been placed outside the draw in future mobile start events.

FEELS LIKA BOSS sustained a flat tyre during the running of this event.

ULTIMATE ME NZ tired to be beaten in excess of 193 metres. This gelding underwent a post-race veterinary examination which revealed it had bled from one nostril,

consequently ULTIMATE ME NZ has been stood down until the completion of a satisfactory trial.

## RACE 10 - DYNAMO 10<sup>TH</sup> NOVEMBER PACE - 2090m Mobile

SMILE LYLE was caught wide early and restrained to the rear of the field.

RAMBUNCTIOUS pulled hard throughout and tired to be beaten in excess of 69 metres.

This gelding has been placed on its last chance to race competitively.

PRIDDY EASY tired to be beaten in excess of 67 metres. This gelding has been placed on its last chance to race competitively.

KARALTA DAZZLER tired to be beaten in excess of 82 metres. This gelding underwent a post-race veterinary examination which revealed no apparent abnormalities. KARALTA DAZZLER has been placed on its last chance to race competitively.
