RACE 1 – RACING CONNECT PACE – 2090m Mobile

BOLD CENTURIAN – Will be excluded from the barrier draw in future mobile starts after breaking gait free of interference after the start. Hung in on the final turn resulting in its sulky wheel brushing markers.

RACE 2 – MORE CONFIDENCE CONSULTING PACE – 2090m Mobile

WHERE YA BIN NZ – Failed to secure clear running over the final stages.

SHARMEY – Checked and broke gait on crossing the finish line when a number of runners shifted ground.

GRINNING AGAIN NZ – Failed to maintain its position on the starting gate until the start was effected. Driver R Hillier was fined \$100 [AHR Rule 162(1)(j)].

MAJOR DAVVIN – Over-raced and pulled hard, particularly in the middle stages. Raced wide from the 1100 metres. Hung in on crossing the finish line.

RACE 3 – PRYDES EASIFEED EVICUS FINAL – 1609 Mobile

BARBETTE – Hung in on the final turn, contacting markers.

GLENWOOD BEAUTY – Hung out during the score-up, back from its allotted position at the start and raced rough after the start. A warning was issued.

ELIZABETH DELILAH – Back from its allotted position at the start before being restrained. A warning was issued.

SABINE – Back from its allotted position at the start before being restrained. A warning was issued. Broke gait free of interference near the 900 metres. As the filly had been placed on its last chance recently, SABINE was stood down from racing until satisfactorily completing one(1) requalifying trial.

TAMBROS TILLY – Over-raced when eased on the first turn. Raced wide shortly after before positioned leading the one-out line. Raced rough near the 300 metres.

MACKEON – Declared a late scratching at 10:10am for Veterinary reasons due to a paddock incident.

ORTEM MISS – Declared a late scratching at 5:15pm, taken out by Stewards acting under Veterinary advice, after arriving on course with swelling to the right side of its jaw. ORTEM MISS will be ineligible to race until connections forward on a Veterinary clearance.

RACE 4 – CAVALOR EQUICARE TASMANIAN OAKS – 2090m Mobile

FIESTA STRIDE – Hung in approaching the 1800 metres resulting in its sulky wheel striking markers.

MILLIES CREATION NZ – Hung in when wide on the track, particularly on the first turn.

REELY NAUTI – Raced wide in the early stages, progressing forward to lead the one-out line, where it tended to over-race.

RACE 5 – PRYDES EASIFEED DANDY PATCH FINAL – 2090m Mobile

IDEN KAMAKAZI – Failed to, once again, fill its allotted position at the start. IDEN KAMAKAZI will now be drawn on the extreme outside in mobile start events. Broke gait free of interference on the final turn, as such was stood down from racing until completing two(2) consecutive requalifying trials. Stewards in imposing this embargo were mindful IDEN KAMAKAZI had been stood down for a similar offence two starts previously.

General: Driver N Ford was fined \$200 for the unacceptable continuous manner he used his whip on FEELINKINDALUCKY over the concluding stages [AHR Rule 156(3)].

RACE 6 – TASMANIAN HORSE TRANSPORT TASMANIAN DERBY – 2579m Mobile

KARALTA ARTEMIS – Raced rough in a mid-field marker post position, racing up and contacting the sulky of ANDAMAN BAY. Dropped out sharply from the 1000 metres, beaten in excess of 130 metres. A post-race Veterinary examination could find no obvious abnormalities. Driver J Walters and trainer K Rattray were of the opinion that the gelding may have choked down. Stewards deemed the performance below the required standard and as such stood KARALTA ARTEMIS down until satisfactorily completing one (1) requalifying trial.

HEATHBERN BRUCE – Gave ground over the final stages after unsuccessfully challenging for a forward position mid-race and left racing wide. A post-race Veterinary examination could find no obvious abnormalities. A warning was issued.

RACE 7 – LADBROKE IT PACE – 2090m Mobile

STEPPING STONES – Will be excluded from the barrier draw in future standing start events after galloping away and continuing to do so for some considerable distance.

CHECK IN NZ – Placed on its last chance in the draw for races conducted under standing start conditions after galloping away at the start.

WATTABOUT SPANGHER – Placed on its last chance in the draw for races conducted under standing start conditions after galloping away at the start.

SUNNY SANZ – Tended to over-race and pull hard.

RACE 8 – THE DYNAMO 10TH NOVEMBER PACE – 2090m Mobile

SERENGETI SUNRISE – Stewards acting under AHR Rule 141(4) declared SERENGETI SUNRISE a late scratching after causing two false starts. SERENGETI SUNRISE will need to satisfactorily complete one(1) mobile trial before returning to mobile racing. In addition SERENGETI SUNRISE will be excluded from the barrier draw in mobile start events.

MONTANA LAD NZ – Hung in near the 200 metres resulting in its sulky wheel striking markers.

BONNY MY BOY – Shifted out under pressure over the final 300 metres. Tended to over-race.

LETSGOBRO – Placed on its last chance to race truly after breaking gait near the 900 metres.

ARDEN ROANOKE NZ – Checked when LETSGOBRO broke gait.

CULLENBURN NZ – Checked when LETSGOBRO broke gait.

PUNTARNO STRIDE NZ – Checked when LETSGOBRO broke gait.

ROSSINI – Held up for clear running on the final turn.

General: Driver A McDonough was fined \$200 for the unacceptable manner he used his whip on WE SALUTE YOU over the concluding stages [AHR Rule 156(2)(a)].

RACE 9 – NUTRIEN SPRINTLANE PACE – 1609m Mobile

IMA SOCIALITE – Gave ground over the concluding stages, beaten in excess of 40 metres.

ROCKSTAR REBEL – Issued with a warning after racing rough near the 1300 metres and again passing the 1000 metres. A post-race Veterinary examination could find no obvious abnormalities. Driver J Duggan was of the opinion that ROCKSTAR REBEL had badly struck its knee throughout which may have contributed to the gelding missing stride at times.

SALVATOR MUNDI – Inconvenienced when ROCKSTAR REBEL raced rough near the 1300 metres.

HEZ RAZOR SHARP– Inconvenienced when ROCKSTAR REBEL raced rough near the 1300 metres.

SUPPLEMENTARY REPORT

BURNIE HARNESS RACING CLUB – Friday 27th October 2023

Race 6: Everett Flight and Associates Pace - 2180m Mobile

Stewards today concluded an investigation into the tactics adopted by driver Tim Yole (LORD VERDE NZ) through the early and middle stages of the event, where he raced adjacent to the leader before yielding ground over the final 700 metres. After considering all relevant factors, including a review of the sectional times of the race, Mr Yole was told that he must ensure he drives his horses within their capabilities and not leave any aspect of his driving to query or question.
