RACE 1 – BRIAN "DAVO" DAVIDSON MEMORIAL – 1680m Mobile

SEANNAFAIR – Slow to muster speed at the start.

STAR WATCHING – Led the event, shifted out under pressure in the run to the finish.

CAROLS JUDGE – Raced outside the leader where it tended to over-race.

DONNY IN PARIS – Held up for clear running until well into the home straight in the run to the finish.

PRINCELY REIGN – Driven forward from the start, eased to be positioned in the oneout, one-back position near the 1300 metres. Tired over the concluding stages, beaten in excess of 60 metres.

IM QUITE AMERICAN – Tired over the concluding stages, beaten in excess of 50 metres.

LAID BACK KENNY – Reinstated in the barrier draw for races conducted under mobile start conditions after satisfying ORI re-inclusion requirements.

RACE 2 – 6TY YOUNGBLOODS HEAT ONE – 2090m Mobile

FIESTA STRIDE – Driven forward from the start, securing the early lead. Obtained cover near the 1500 metres. Tired badly to be beaten in excess of 350 metres. A post-race Veterinary examination failed to find any obvious abnormalities, other than a slow postrace recovery. Stewards deemed the performance well below the required standard. FIESTA STRIDE was stood down from racing satisfactorily completing one (1) qualifying trial.

SNEAKY PEAK – Pulled up out of the event passing the 1800 metres after having its sulky struck damaging its off-side sulky wheel.

OUR BALOU – Raced wide from the 1800 metres to secure the lead shortly after, gave ground over the concluding stages, beaten in excess of 70 metres. A post-race Veterinary examination failed to find any obvious abnormalities.

General: Driver B Woodsford (OUR BALOU), was fined \$100 for careless manner he shifted ground wider on the track approaching the 1800 metres, this resulted on OUR BALOU striking the sulky of SNEAKY PEAK, damaging its wheel [AHR Rule 168(1)(a)].

RACE 3 – BEVAN LEE'S BUTCHERY GOLDEN GIRLS – 2200m Mobile

SWEET AMOUR – Raced roughly passing the 1400 metres whilst leading the one-out line, inconveniencing other trailing runners.

LOOBY LOMBO – Raced wide over the final 1100 metres. Failed to run on as may have been expected. A post-race Veterinary examination failed to detect any issues with the mare. Stewards noted the circumstances.

MOST PERFECT MAJOR – Failed to secure clear running over the concluding stages.

RACE 4 – FAITHFUL PARK STUD GOLDEN SLIPPER – 1680m Mobile

INDI AIR TONIGHT – Tended to hang in.

ROCK AMOUR – Broke shortly after the start and generally performed poorly, racing roughly, hanging out and giving ground over the concluding stages. A post-race Veterinary examination failed to detect any abnormalities. Trainer P Carlson indicated that ROCK AMOUR would be let out for a spell. Stewards accepted the undertakings of trainer Carlson, and in addition before returning to racing ROCK AMOUR will be required to trial satisfactorily and will be excluded from the barrier draw in mobile start events.

CALL HER BETTY – Tightened for racing room turn for home, however then shifted in on its own accord in the run to the finish, tightening FEELINKINDALUCKY for racing room with that gelding's sulky wheel striking markers.

FEELINKINDALUCKY – Tightened for racing room resulting in its sulky wheel striking markers.

CUSTOM HARLEY – Well out of position passing the candy pole, failing to fill its allotted barrier position at the start.

FEARLESS STRIDE – Reinstated in the barrier draw for races conducted under mobile start conditions after satisfying ORI re-inclusion requirements.

General: Driver H Woods was reprimanded for failing to have CUSTOM HARLEY in position when the start was effected [AHR Rule 162(1)(h)].

RACE 5 - NUTRIEN AG SOLUTIONS GLOBE DERBY FINAL - 2200m Mobile

FIVEFORTY – Tired significantly, dropping out to be beaten in excess of 90 metres, Stewards deemed the performance under the required standard, and after referring to the colts recent poor recent race record, Stewards stood FIVEFORTY down from racing until satisfactorily completing two (2) consecutive qualifying trials. Further, after a postrace Veterinary examination, FIVEFORTY was also stood down pending a Veterinary clearance, as upon inspection FIVEFORTY was found to have an irritating skin condition. Stewards directed that the Veterinary clearance be produced prior to FIVEFORTY trialing.

General: Stewards allowed the late change of driver Rohan Hillier on IDEN SIR FRANKE after the engaged driver, Damian Wilson, experienced transportation difficulties.

RACE 6 – 6TY YOUNGBLOODS HEAT TWO – 2200m Mobile

BABY YOU A SONG – Tended to over-race and pull hard whilst racing in a mid-field marker line position. It was noted passing the 1100 metres, BABY YOU A SONG, raced up contacting the sulky in front and raced roughly.

KHAKI NUI NZ – Fractious before the start. Failed to secure clear running over the concluding stages.

RACE 7 – LEES ORCHARD TASSIE GOLDEN APPLE – 2200m Mobile

WATTABOUT SPANGHER – Shifted out after the start and then slow away.

DENWEN DANCER – Shifted out in the run to the finish.

MICKEY OH – Issued with a warning due to being fractious behind the barrier and rearing as the strands were released, and then slow away.

STEPPING STONES – Reinstated in the barrier draw for races conducted under standing start conditions after satisfying ORI re-inclusion requirements.

General: Dylan Ford was fined \$100 for carelessly allowing DENWEN DANCER to shift out in the run to the finish, allowing RICK REILLY to secure an inside run [AHR Rule 162(1)(www)(c)].

RACE 8 – 6TY BANDBOX FINAL – 2200m Mobile

MAR BAYKA – Declared a late scratching at 8:18pm, taken out by Stewards acting under Veterinary advice after the filly was found to have a skin condition. Further acting under this advice Stewards stood MAR BAYKA down from racing until connections can provide a Veterinary clearance.

KIWI TILLY – Tired badly to be beaten in excess of 120 metres. A post-race Veterinary examination failed to find any obvious abnormalities, other than a slow post-race recovery. Stewards deemed the performance well below the required standard. KIWI TILLY was stood down from racing satisfactorily completing one (1) qualifying trial.

RACE 9 – 6TY YOUNGBLOODS HEAT THREE – 2200m Mobile

BRIGADIERS SON NZ – Tired over the concluding stages, beaten in excess of 60 meters. Stewards, after taking into account the false start, BRIGADIERS SON NZ was given the benefit of the doubt, taking no action other than to note the circumstances.

TWO SOCK CREEK NZ – Reinstated in the barrier draw for races conducted under mobile start conditions after satisfying ORI re-inclusion requirements.

SCOTLYNN BEACH NZ – Jibbed in the early stages of the score-up, refusing to move whilst positioned in the middle of the track. A false start was declared. Positioned wide on the track and facing forward for the second score-up. Refused to score-up on the second attempt, taking no part in the event. As a consequence of its barrier behavior, Stewards stood SCOTLYNN BEACH NZ down from racing until it can satisfactorily complete two (2) consecutive mobile qualifying trials.

RACE 10 – 6TY YOUNGBLOODS HEAT FOUR – 2200m Mobile

HEATHBERN BRUCE – Hung out under pressure in the run to the finish.

REBEL WITH A GRIN NZ – Led the one-out line early, obtaining a trail near the 1500 metres. Inconvenienced and carried back through the field when LETSPLAYUNI gave ground.

LETSPLAYUNI – Caught wide for the first 700 metres before positioned leading the one-out line. Under pressure from the 600 metres, dropping back through the field, beaten in excess of 90 metres. A Post-race Veterinary examination failed to find any obvious issues. Stewards gave the benefit of the doubt to LETSPLAYUNI on this occasion as the gelding had been caught wide early, however will monitor its future performances.
