

RACE 1 - KENDALLS HOTEL & DORSET TRANSPORT PACE - 1955M STAND

IM QUITE AMERICAN was placed EOD (Extreme outside draw by order of Stewards). **HORRIE OTARA** galloped out and has been placed on its last chance in the draw.

SMILE LYLE galloped out and has been placed out of the draw in future standing start events.

STRONGHOLD underwent a post race veterinary examination after giving ground to be beaten 42 metres and no apparent abnormality could be detected.

Driver M Ford (**STRONGHOLD**) was fined the sum of \$100 after pleading guilty to a charge under AHRR168(1)(a). Particulars were that approaching the 1300 metre mark he allowed his horse to contact the rear of the preceding sulky resulting in **STRONGHOLD** galloping.

RACE 2 – SCOTTSDALE ROTARY CLUB STAKES – 1955M STAND

MISTER FINNIGAN galloped out and has been placed on its last chance in the draw. **OUR RUBY ROSE** was checked and broke shortly after the start.

Approaching the 600 metre mark **OUR RUBY ROSE** galloped free of interference and has been placed on its last chance to race truly.

IDEAL KARALTA broke free of interference approaching the 1600 metre mark and then continued to race roughly throughout the event eventually finishing distanced. After taking into account his recent race record Stewards stood the gelding down until the completion of a satisfactory trial.

ALAPHILIPPE was checked after the start by a galloping runner.

TAXI METER was held up and unable to be fully tested.

After beginning satisfactorily **ALAPHILIPPE** has been reinstated in the standing start draw.

After beginning satisfactorily **OUR RUBY ROSE** has been reinstated in the standing start draw.

RACE 3 – JANIE FINLAY MP - TAS LABOR SUPPORT RACING STAKES – 1955M STAND

LAFOND galloped out and has been placed on its last chance in the draw.

TOP HANOVER galloped out and has been placed out of the draw in future standing start events.

TOP HANOVER tired over the concluding stages to be beaten in excess of 92 metres and has been placed on its last chance to race competitively.

LAFOND gave ground and contacted marker pegs over the concluding stages to be beaten in excess of 28 metres.

RACE 4 – LITTLE RIVERS BREWERY PACE – 1955M STAND

IMPULZE galloped out and has been placed out of the draw in future standing start events.

SALVATOR MUNDI galloped shortly after the start and has been placed on its last chance in the draw.

AGOUDA RULER galloped out and has been placed out of the draw in future standing start events.

NOVA BAXTER hung in and contacted marker pegs during the event. Taking into account the recent race record of the mare, Stewards placed her on her last chance to race truly.

LOYOLA TRIOS hung in and contacted marker pegs during the event. A warning was issued.

JACKSON NEPTUNE pulled hard throughout the event.

RACE 5 – THE MCLAUGHLIN FAMILY NEPC CUP – 2692M STAND

LAST OF THE MOHICANS NZ was placed EOD (Extreme outside draw by order of Stewards).

LAST OF THE MOHICANS NZ stood flat footed then galloped out and will continue out of the draw.

KHAKI NUI NZ reared as the start was effected and will continue out of the draw.

MISS PAPENHUYZEN galloped out and has been placed out of the draw in future standing start events.

COLBY SANZ galloped out and will be placed on its last chance in the draw...

Driver S Davis's (MAJOR DAVIN) foot slipped from the foot rest momentarily when activating ear plugs and was immediately replaced.

KHAKI NUI NZ galloped in the home straight the final time. Taking into account the recent race record of the gelding **KHAKI NUI NZ** has been stood down until the completion of a satisfactory trial.

COLBY SANZ finished the event with a flat tyre.

COLBY SANZ underwent a post-race veterinary examination after tiring to be beaten in excess of 62 metres and no apparent abnormalities could be detected. A warning has been issued.

After an inquiry into the reasons **COLBY SANZ** raced in a four wide position after the bell driver B Rattray(**KUZMA**) was found guilty of a charge under AHRR163(1)(b). Particulars were that he obliged **COLBY SANZ** to race wider on the track before reaching the ease out pole. Stewards suspended Mr Rattray for a period of 2 race dates commencing midnight 7/1/24 and expiring midnight 14/1/24.

RACE 6 – LORDS HOTEL PACE – 1955M STAND

MACARIA broke shortly after the start and has been placed on its last chance in the draw.

NEON underwent a post-race veterinary examination after giving ground to be beaten in excess of 49 metres and no apparent abnormalities could be detected.
