

General:

All horses that raced in Launceston on 13 January 2024 underwent pre-race veterinary examinations.

RACE 1 - PRYDES EASIFEED PACE - 2090m Mobile

Driver M Ford (CAPTAIN COSMONAUT) was reprimanded under AHRR 162(1)(h) in that he failed to come fully into position before the start was effected.

HURRICANE Rock utilised the sprint lane over the concluding stages.

RACE 2 - CAVALOR EQUICARE PACE - 2090m Mobile

The start of this event was delayed for approximately 3 minutes due to a sulky change (flat tyre)

Driver A Collins (SLINGSHOT) was reprimanded under AHRR 162(1)(j) in that he failed to maintain his starting position before the start was effected.

RANIERI NZ (C CASTLES) caught wide early and restrained to the rear of the field. This gelding was held up for clear racing room upon entering the home straight on the final occasion.

RACE 3 - CLUBS TASMANIA PACE - 1609m Mobile

FEISTA STRIDE pulled hard during the score up.

EIPPERMILL raced ungenerously at various stages of this event.

RACE 4 – YOUNG GROUP PACE – 1609m Stand.

SHAUN TO THE MAX was a late scratching due to driver Jack Watson being indisposed. Mr Watson has been stood down until the receipt of a medical clearance.

STYLISH TREND pulled hard during the score up.

RACE 5 – TASMANIAN HORSE TRANSPORT PACE – 2090m Mobile

JUSTIFY was out of position at the start and will continue to be placed outside the draw in future mobile start events.

BLACKJACK JIM caught wide early, before working forward to race outside the leader.

RACE 6 - NUTRIEN SPRINTLANE PACE - 1609m Mobile

N Ford (FURY DAN) was cautioned for not being in position by the time the candy pole was reached prior to the start of this event.

TO THE LOOKOUT (O Weidenbach) contacted marker pegs as the field raced around the home turn.

RACE 7 - MORE CONFIDENCE PACE - 2090m Mobile

KARDESLER was a late scratching due to driver Jack Watson being indisposed. Mr Watson has been stood down until the receipt of a medical clearance.

KENYA was re-handicapped to start off 10 metres due to winning in Launceston on 13 January 2024.

THEUGLYSISTER reared at the start and galloped out. This mare has been placed on its last chance in the standing start draw.

OUR BALOU broke gait shortly after the start and has been place on its last chance in the standing start draw.

MAJOR MUCHA broke gear shortly after the start and was retired out of the event.

RACE 8 – LADBROKES HUB PACE – 2090m Mobile

MERRY DANCER tired to be beaten in excess of 83 metres. This mare underwent a postrace veterinary examination which revealed no abnormalities. Consequently, MERRY DANCER has been stood down until the completion of two satisfactory trials.
