

**STEWARDS REPORT**

**RACE 1 – PRYDES EASIFEED PACE – 2090(MS)**

COOL SCOOTER NZ caught wide early before working forward to sit outside the leader. This gelding over raced and gave ground over the concluding stages.

EQUITY STRIDE hung out at various stages.

AGOUDA RULER held up for clear racing room as the field entered the home straight on the final occasion.

PIPPO NIEN gave ground over the concluding stages.

MONTANA LAD NZ raced roughly as the field raced towards the 300 metres.

SCOTLYNN BEACH NZ has been placed outside the draw after completing two satisfactory right outside the draw starts.

Driver Mathew Howlett, (GALAXY DANCER) pleaded guilty to a charge under AHRR 156(3) in that he used the whip continuously in the home straight without giving the horse time to respond. Mr. Howlett was fined the sum of \$100.

Driver Nathan Ford was cautioned for dropping his right foot. Stewards were satisfied that whilst Mr Ford's foot slipped out of the rests, he kept his foot in the immediate vicinity.

### **RACE 2 – MORE CONFIDENCE CONSULTING PACE – 2090(MS)**

BIGJIMVALENTINE broke shortly after the start and has been placed outside the draw in future mobile start events.

LOOBY LOMBO caught wide during the early stages before being restrained to the rear of the field.

ENSTEIN held up for clear racing room as the field raced into the home straight on the final occasion, before utilised the sprint lane over the concluding stages.

### **RACE 3 NUTRIEN SPRINTLANE PACE – 2090(MS)**

PEPPER STRIDE broke shortly after the start and as a consequence has been placed outside the draw in future mobile start events.

NOT YET MUM broke gait free of interference as the field raced away from the 800 metres and again approaching the home turn. This gelding has been stood down until the completion of two satisfactory trials.

SPIRITED STRIDE tired to be beaten in excess of 66 metres. This filly has been stood down from racing until the completion of a satisfactory trial.

LAZARO GIRL tired to be beaten in excess of 102 metres. This filly has been stood down from racing until the completion of a satisfactory trial.

### **RACE 4 – PAUL BELCHER @ ROBERTS NEW NORFOLK CUP (GRASS) – 2400(SS)**

WILL HE PIKE severely checked shortly after the start by the galloping IDEN BLACK PRINCE.

IDEN BLACK PRINCE swung sideways at the start and galloped out. This gelding has been placed outside the draw in future standing start events.

PUNTARNO STRIDE NZ galloped out and will continue to be placed outside the draw in future standing start events.

FLEETWOOD ROCK galloped out and has been placed on its last chance in the standing start draw.

IMPULZE galloped out and will continue to be placed outside the draw in future standing start events.

SALVATOR MUNDI checked shortly after the start by the galloping WILL HE PIKE.

DAZZLE ME NZ fractious before the start and stood flat footed before galloping away. This gelding has been placed on its last chance in the standing start draw.

DAZZLE ME NZ broke gait as the field raced over the crossing. A warning has been issued on this gelding's racing manners.

GOBSMACKED gave ground over the concluding stages.

MAJOR DAVVIN broke gear (spreader) at the 100 metres.

PUNTARNO STRIDE tired to be beaten in excess of 129 metres. This gelding underwent a post-race veterinary examination which revealed no apparent abnormalities. PUNTARNO STRIDE has been placed on its last chance to race competitively.

#### **RACE 5 – TASMANIAN HORSE TRANSPORT PACE – 2090(MS)**

BONNY MY BOY pulled hard.

COLBY SANZ caught wide during the early stages and was restrained to the rear of the field.

#### **RACE 6 – LADBROKES HOBART PACING CUP – 2579(MS)**

HULI NIEN out of position at the start and will continue to be placed outside the draw in future mobile start events.

JIMMY THE IRISHMAN NZ raced roughly in the home straight on the first occasion, causing the pace to abruptly ease.

LYNRYD SKYNYRD NZ raced roughly as the pace eased in the home straight on the first occasion.

THE SHALLOWS raced roughly as the pace eased in the home straight on the first occasion.

HULI NIEN raced roughly as the pace eased in the home straight on the first occasion. This gelding raced ungenerously at various stages of this event.

SUNNY SANZ gave ground over the concluding stages.

Driver Nathan Ford (RACKEMUP TIGERPIE) pleaded guilty to a charge under AHRR 163(1) in that he failed to keep both hands on the reins and saluted prior to the finish. Mr. Ford was fined the sum of \$100.

#### **RACE 7 – CAVALOR EQUICARE PACE – 2090(MS)**

CHRISTIAN JAZ NZ pulled hard during the score up.

MR KIWI NZ utilised the sprint lane over the concluding stages.

### **RACE 8 – YOUNG GROUP PACE – 2090(MS)**

BOTANY BAY WARRIOR broke gait free of interference as the field raced towards the back straight on the first occasion. This horse has been placed on its last chance to race truly.

MAYLEEJAE EAGLE momentarily tightened for racing room approaching the home turn, contacting marker pegs.

MISS BARTY has been placed back in the mobile start draw.

### **RACE 9 – RACING CONNECT PACE – 1609(MS)**

OUR RUBY ROSE shifted out under pressure over the later stages of the event. Driver Dylan Ford was reprimanded under AHRR 168(1)(a) careless, in that he allowed his drive to shift ground upon entering the home straight and again just prior to the finish.

The all clear for this event was delayed allowing Driver Mark Yole (REMEMBER ME NOW) to view the official films over the concluding stages. After viewing the official films Mr Yole declined to proceed any further and all clear was given on the Judges' numbers.
