Driver K Pratten was indisposed and was unable to take his drives at tonight's meeting. Driver Pratten has been stood down from driving pending a medical clearance.

RACE 1 – LEES ORCHARD STAKES – 1680M MOBILE

WARRIORESS – Issued with a warning for hanging out.MISS BARTY – Obtained an inside run in the run to the finish as WARRIORESS hung out.

RACE 2 – LADBROKES EASY FORM STAKES – 1680M MOBILE

KIWI TILLY – Subjected to a post-race blood test. Stewards questioned trainer M Laugher over the apparent improved performance of the mare, which has been unplaced at all 8 starts leading up to this event and resuming after being stood down at its most recent race start in late May 2024. Trainer Laugher explained he had expected a good showing tonight based on its good recent trial and improvement to its work through a change of methods. Trainer Laugher further stated that although the form does not read well on paper, he felt KIWI TILLY had been performing well and racing without luck. Trainer Laugher further added that KIWI TILLY at this stage of its racing career is better suited to racing over the shorter mile or equivalent distances. The evidence was noted.

B K WINDERMERE NZ – Started the race at \$2.45 second favourite, having its first registered Australian race start, and first in over four(4) months. Although far from disgraced, beaten only 14 metres, B K WINDERMERE NZ did not run on as may have been expected. Subjected to a post-race Veterinary Inspection which revealed no obvious abnormalities. Trainer S Lukac, when queried on the performance stated he was not overly disappointed with the performance, all things considered, and felt that the mare would benefit greatly from the run. The evidence was noted.

KOZACZYNSKI – Tired badly to be beaten in excess of 90 metres. Subjected to a post-race Veterinary inspection which revealed that the gelding had a poor post-race recovery, mild dehydration with some respiratory noises. Stewards deemed the performance below the required standard, and with the knowledge that a warning had been placed on KOZACZYNSKI at its most recent start, stood the gelding down from racing until satisfactorily completing one(1) qualifying trial.

General: Trainer T Rattray was reprimanded for starting LEWICKI LEIS with gear contrary to that registered to the gelding [AHR Rule 273(6)(b)].

General: Trainer T Langley was reprimanded for starting NOBLEZZZ ADVICE with gear contrary to that registered to the gelding [AHR Rule 273(6)(b)].

General: Trainer W Yole was reprimanded for starting KOZACZYNSKI with gear contrary to that registered to the gelding [AHR Rule 273(6)(b)].

RACE 3 - TASMANIAN HORSE TRANSPORT PACE - 2200M MOBILE

JUST FOLLOW ME – Shifted in on entering the home straight for the run to the finish which resulted in its sulky coming together with that of LAID BACK KENNY.

LAID BACK KENNY – Tightened on entering the home straight for the run to the finish.

RACE 4 – LADBROKES BET TICKER PACE – 2200M - MOBILE

NANCYS HOPE - Dropped an off-side knee boot during the event.

NORBET – Raced in behind runners until well into the home straight in the run to the finish.

THE MIGHTY DOC – Held up in the early stages of the home straight in the run to the finish.

MORE THAN THIS – Tended to over-race.

MEMPHIS – Tended to hang out in the straights and in on the turns. Failed to secure clear running over the concluding stages.

General: Driver N Ford was reprimanded for failing to maintain his position with DONE WELL, until the start was effected, thereby being out of position at the start [AHR Rule 162(1)(j)].

RACE 5 - STACEY LEAR PHOTOGRAPHY STAKES - 2200M - MOBILE

ITS SUPER EASY NZ – Had difficulty in securing clear running over the concluding stages.

General: Driver B Davis was reprimanded for failing to maintain his position with ROYAL REACTOR, on the mobile gate, until the start was effected [AHR Rule 162(1)(j)].

General: Driver D Ford was reprimanded for failing to have ITS SUPER EASY NZ up and in position on the mobile gate at the start [AHR Rule 162(1)(h)].

General: Driver O Weidenbach was fined \$100 for whilst leading with KIAVINO STRIDE failed to run the minimum time standards for the first half of the last mile in 66.3

General: Trainer R Hillier was reprimanded for starting MY ULTIMATE ROMEO with gear contrary to that registered to the gelding [AHR Rule 273(6)(b)].

RACE 6 - NUTRIEN AG SUPPLIES PACE - 1680M - MOBILE

NAPATTACK SAM – Started the race at \$1.40 favourite, led the one-out line throughout, racing rough at times. Subjected to a post-race race Veterinary inspection, on inspection Dr O'Brien found NAPATTACK SAM to have a greasy heel condition on both front pasterns. On questioning, trainer M Reggett expressed his disappointment with the performance and will review its racing schedule, potentially increase time between starts. Stewards acting on Veterinary advice, stood NAPATTACK SAM down from racing for fourteen(14) days so as to allow some time for the greasy heel condition to heal. Stewards were advised that Dr O'Brien had recommended treatment to trainer Reggett.

BRIAN WHO – Held up in the early stages of the home straight in the run to the finish.

PADDY MACH – Held up in the early stages of the home straight in the run to the finish.

RAMBUNCTIOUS – Failed to secure clear running in the run to the finish.

RACE 7 – CHARTLEY ESTATE PACE – 2200M - MOBILE

HEZ RAZOR SHARP – Gave ground over the concluding stages, beaten in excess of 60 metres. Trainer Yole expressed his disappointment with the performance. HEZ RAZOR SHARP was placed on its last chance to race truly.

MACH ANGELO – Gave ground over the concluding stages, beaten in excess of 70 metres. Trainer Yole expressed his disappointment with the performance. MACH ANGELO was placed on its last chance to race truly.

RACE 8 – LADBROKES ODDS SURGE STAKES – 2200M - MOBILE

GRIZZLY MONTANA – Led the one-out line before under pressure approaching the 900, giving ground to be beaten in excess of 70 metres. A subsequent Veterinary inspection failed to detect any obvious abnormalities. Stewards, based on the geldings recent performances gave the benefit of the doubt to GRIZZLY MONTANA, taking no action other than to note the circumstances.

BEAST MODE – Tired badly to be beaten over 110 metres. A subsequent Veterinary examination found BEAST MODE to have suffer an atrial fibrillation. Stewards, with this being the case, imposed the conditions as set out in AHR Rule 101C(2)(a), standing down BEAST MODE for fourteen(14) days full respite, directing that connections need to supply a Veterinary clearance, which includes a favourable ECG report, and on receipt of the Veterinary Clearance, BEAST MODE before returning to racing, will be required to satisfactorily complete two(2) consecutive qualifying trials.
