The start of this race 1 was delayed 70 minutes due to a thunderstorm and lightning moving across the area. Once the stewards were satisfied that the lightning and rain had passed, stewards inspected the track surface and tested the mobile barriers in relation to the traction required to safely perform its duties. Stewards were satisfied with the conditions of the track and advised all participants that we will commence with the race meeting. All races were put back.

The following race times were amended: Race 1 – 6.21 pm – Race 2 – 6.57pm – Race 3 – 7.27pm – Race 4 – 8.02pm – Race 5 – 8.37pm Race 6 – 9.05pm - Race 7 – 9.37pm – Race 8 – 10.05pm – Race 9 – 10.32pm.

RACE 1 – TASMANIAN HORSE TRANSPORT PACE – 2090m Mobile

LETS GO LUCYLOU – Showed gait speed early and tended to pull hard during the event. Broke free of interference when shifting outwards to gain a clear run approaching the home turn. Trainer P Ashwood was shown the patrol film and stewards advised him that the mare will be placed on its last chance to race truly given her good record for this offence.

WEONA EAGLE – Showed gait speed to lead the event in the early stages and surrendered that position off the back straight to receive the bell. Hung inwards and contacted marker pegs.

SWIATEK LEIS - Hung inwards making the home turn onto another runner.

JUSTIFY – Restrained at the start.

SWIMINTHERIVER NZ – Showed gait speed and raced wide in the early stages before progressing forward to gain the position outside the leader.

SOUTHERN LUCK – Restrained at the start. Driver reprimanded for failing to maintain his position on the mobile at the start

HEATHBURN BRUCE – Restrained at the start. Tired over the concluding stages and given the margin was placed on its last chance to race competitively. Driver reprimanded for failing to maintain his position on the gate at the start.

MAGNETIC TERROR NZ – Raced wide in the middle stages to eventually lead the event entering the back straight to receive the bell.

RACE 2 - LADBROKES RACING CLUB PACE - 2090m Mobile

PLATONIC MISS – Tired over the concluding stages and given the fillys record will be placed on its last chance to race competitively.

ROCK AMOUR - Showed gait speed.

MUZZAME MATE – Showed gait speed to lead the event. Broke free of interference entering the back straight on the final occasion. The gelding was stood down until a completion of a satisfactory trial given its previous record.

MISS DUTTON – Caught racing wide in the early stages before gaining the position outside the leader. Suffered a near side flat tire in the run.

SOHO UNDERTAKER – Showed gait speed to lead the event. Broke free of interference off the back straight on the first occasion.

BOLT YOUR SOCKS ON – Tired over the concluding stages. Given the geldings previous record was placed on its last chance to race competitively.

MARTYR – Driver fined for accidently contacting and flattening a wheel at the 700m.

JUST JAYDO – Raced wide from the 900m and tired over the concluding stages. The horse was placed on its last chance to race competitively.

DANGER PLAY – Raced Three wide from the 900m in a trailing position.

KEAYANG KEVIN – Began badly and the gelding will be placed out of the draw in future mobile starts.

RACE 3 - RACING CONNECT PACE - 1609m Mobile

MISS MAGIK – Showed gait speed to gain the leading position before surrendering that position in the early stages.

RESURGENT WARRIOR – Driver fined for his whip use.

MISS COLLANN - After showing gait speed progressed forward to eventually lead.

KEEPERS IDEAL NZ - Gained the position outside the leader. Tended to pull hard in the event.

KERALA STAR NZ – Left a trailing position to race wide over the final lap.

FIVE STAR SHARK – Restrained at the start.

RACE 4 - ART MEEKER MEMORIAL MATRON STAKES - 2579m Stand

IDEN LADY LINCOLN – Galloped out and will be excluded from the draw in future standing start events. Trailed the field throughout.

KILLARNY DANCE NZ – Gave ground over the concluding stages. A post race veterinary examination revealed no obvious abnormalities. Stewards questioned the trainer in relation to the disappointing performance of the mare. The trainer was at a loss to explain the performance as she had worked well and expected a forward showing. Stewards placed the mare on its last chance to race competitively.

MODERN POWER – Inconvenienced during the run because of a galloping runner.

SPOT RULER – Obtained the position outside the leader and obtained a trail in the middle stages.

STEPPING STONES – Gained the position outside the leader. Inconvenienced because of a galloping runner during the event.

MISS PAPENHUYZEN – Began badly and given the gelding's previous record will now be excluded right out of the draw in standing start events.

RACE 5 - FEHLBERGS PRODUCE BRIGHTON CUP - 2090m Mobile

MAJOR CELEBRITY – Showed gait speed in the early stages to gain the position outside the leader before progressing forward to lead the event. Gave ground over the late stages. Stewards questioned trainer M Laugher into the apparent disappointing performance of the gelding. The trainer was at a loss to explain the performance but stated it was a step up in class but could not offer anything further. Mr. Laugher further

stated he would be advising the owners that maybe a change of trainer may be required. A post race veterinarian examination revealed no obvious abnormalities. Mr. Laugher was advised that it will be placed on its last chance to race competitively.

LYNARD SKYNRYD NZ – Delayed the start due to a sulky change. Held up for a clear run in the home straight.

CUSTOM HARLEY – Caught racing three wide in the early and middle stages of the event before restraining to the rear of the field. Raced three wide late in a trailing position.

PARDOE PLUGGA – Showed gait speed early to lead the event before surrendering that position entering the back straight on the first occasion.

DIAMONDS N CASH NZ - Raced three wide in the middle stages to lead the event.

RACE 6 - E C PLUNKETT MEMORIAL - 2090m Mobile

SPOOKY GIRL – Broke free of interference racing off the back straight on the final occasion and was placed on its last chance to race truly given its good record. Gave ground over the concluding stages.

WILL HE PIKE – Gave ground over the concluding stages of the event.

JORGE STREET – Showed gait speed to lead the event.

AMBIGUOUS – Showed gait speed and raced roughly for a short distance and raced three wide early before gaining the position outside the leader. Raced roughly at various stages of the event and gave ground over the concluding stages.

ONEHANDONEBOUNCE – Hung outwards in the score up before breaking gait. Out of position at the start. The trainer was advised that the gelding will be excluded from the draw in mobile events.

JEREMY WELLS NZ – Utilized the sprint lane in the run to the finish.

RACE 7 - MOREY'S SPORTS & MUSIC TOURS PACE - 1609m Mobile

CINCINNATI – Showed gait speed to lead the event. Suffered a punctured tire off the back straight on the final occasion and retired from the event.

HELLO SWEETHEART – Showed gait speed early. Contacted a wheel while in a trailing position. Driver suspended for 3 race dates for causing interference and 1 race date for carelessness.

A GOOD RED – Broke free of interference in the front straight on the final occasion and was placed on its last chance to race truly.

STRAWBERRY BLING – Showed gait speed to gain the position outside the leader. Driver suspended for three race dates for causing interference to another runner, racing to the first turn.

ARTS CLASSIC – Restrained at the start.

TWILIGHT BEACH – Raced wide in the middle stages and was unsuccessful challenging for the position outside the leader.

MY ULTIMATE JACKO - Inconvenienced racing to the first turn.

KIAVINO STRIDE – Raced three wide in the middle stages before gaining the position outside the leader.

DEADLY ASSASSIN – Raced three wide in the middle stages in a trailing position before having to restrain to the rear.

Stewards questioned drivers Jack Watson and Olivia Weidenbach in the presence of concession drivers advocate Neville Webberley into reasons why HELLO SWEETHEART suffered interference racing to the first turn. After taking evidence from both drivers and stewards acting on their own observations and viewing the official patrol films charged Jack Watson under provisions of Rule 163 (1) (a) for causing interference by shifting inwards when not fully clear. Jack Watson pleaded Guilty to the charge and had his drivers license suspended for three race meetings. Stewards considered his good record under this rule when considering a penalty.

Stewards questioned drivers Olivia Weidenbach and Jacob Duggan in the presence of concession driver advocate Neville Webberley into reasons why driver Jacob Duggan suffered some interference racing to the first turn. After taking evidence from both drivers and comments from Mr. Webberley and stewards acting on their own observations and viewing the official patrol films, Charged Olivia Weidenbach under provisions of rule 163 (1) (a) for causing interference. The particulars are that racing to the first turn HELLO SWEETHEART was shifted inwards when not fully clear of the front legs of MY ULTIMATE JACO. Olivia Weidenbach pleaded guilty to the charge and had her license suspended for three race dates. Stewards considered her previous record under this rule.

Stewards further questioned driver Olivia Weidenbach into reasons why she contacted the wheel of CINCINNATI driven by Todd Rattray racing into the front straight resulting in the wheel deflating and having to be retired from the event. Miss Weidenbach pleaded guilty to the charge of Carelessness Rule 168 (1) and had her license suspended for a further race date. Stewards considered Miss Weidenbach's submissions on penalty in arising to this penalty.

RACE 8 - SMITHAWARDS PACE - 2090m Mobile

GRIZZLY MONTANA – Showed gait speed to gain the position behind the leader. Returned with a flat tire post race.

SNEAKY PEAK – Showed gait speed and broke free of interference leaving the front straight on the first occasion. Pulled hard and retired from the event with broken gear.

MONEYS NO ISSUE - Hung inwards and raced roughly over the concluding stages.

SHARMEY – Showed gait speed and raced three wide early before progressing forward to lead the event.

DONNY IN PARIS – Raced wide in the early stages before gaining the position outside the leader.

BELIEVE IN FOREVER – Restrained at the start.

MAJOR LESTER – Restrained at the start.

MODERN JIVE – Utilized the sprint lane in the run to the finish.

RACE 9 – CAVALOR EQUICARE PACE – 2090m Mobile

ROLL WITH ANGEL – Broke free of interference making the first turn and given the mares previous record was placed on its last chance to race truly.

B K WINDERMERE NZ – Showed gait speed to lead the event. Hung inwards under pressure on two occasions in the run to the finish.

SERIOUSLY SAM – Showed gait speed early and had to utilize the sprint lane in the run to the finish.

ONLINE MODEL – Showed gait speed early and was caught wide early before restraining to a trailing position.

SWEET AMOUR – Restrained at the start.

COLBY ART – Restrained at the start.

SAPPHIRE GAMBLER – Restrained at the start. Left a trailing position in the middle stages to race three wide before gaining the position outside the leader.

VELOCITY STRIDE – Gained the position outside the leader in the early stages before obtaining a trail in the front straight to receive the bell.
