RACE 1 – SWEET VIVIENNE CUP – 1680M – MOBILE START

TUGRAH JUDGE- Slow in the score up resulting in the gelding being well out of position at the start. Stewards took into account its previous record and excluded the gelding from the draw in future mobile events.

NAUTIBUTNICE- Shifted outwards in the home straight to gain a clear run in the run to the finish.

SUGOI ALTO- Showed gait speed to lead the event.

RUNPOPRUN- Showed gait speed to gain the position outside the leader.

FIGHTING FIRE- Broke gait racing in the front straight on the final occasion.

Stewards questioned driver Peter Jakowenko (FIGHTING FIRE) into reasons he failed to maintain his position on the mobile gait and began to cross over before reaching the starting point of this event.

After taking evidence from the driver and stewards acting on their own observations and viewing the official patrol films issued Mr. Peter Jakowenko a charge under provisions of Rule 162 (1) (f).

A driver shall not-

(f) Cross over before reaching the starting point.

Mr. Jakowenko pleaded guilty to the charge and was fined a sum of \$200.00. Stewards when considering penalty took into account his previous good record under this rule.

Stewards further questioned driver Peter Jakowenko into reasons why racing in the front straight he contacted the sulky of another runner and broke gait as a result. Stewards after viewing the official patrol films and acting on their own observations issued Mr. Peter Jakowenko a charge under provisions of Rule: 168 (1) (a)

A person shall not before, during or after a race drive in a manner which is in the opinion of stewards: -

(a) Careless.

Mr. Peter Jakowenko pleaded guilty to the charge of contacting another runner's sulky and was fined a sum of \$100.00.

RACE 2 – NETHERBY ROCKS PACING PLATE- 2079M – STANDING START

SANJE COLLINS- Gave ground over the concluding stages.

CHASIN FRANKIE- Stepped away to lead the event.

NOBLEZZ ADVISE- Raced three wide in a trailing position in the middle and late stages of the event.

ARMA ROLLING STONE- Raced at the lead of the three wide line in the middle and late stages of the event.
