Comments / Explanations:

RACE 1 – LADBROKES OWNERS INCENTIVE MAIDEN – (1200 METRES)

Prior to correct weight rider D Pires (CARTOON GRAVEYARD) wished to view the official photo finish. After viewing the photo finish, correct weight was given on the judges' numbers.

AUNTIE JAKE'S BAR - Slow to begin 1-2 Lengths.

CARTOON GRAVEYARD – Raced three wide throughout, had a tendency to lay in, in the home straight.

FRENETICO – Slow to muster early speed.

GEEGEES SUNSHINE – Tightened on jumping.

BATTLE AWARD – Raced three wide throughout.

BE KINDER – Began awkwardly, raced wide throughout.

RACE 2 - KEVIN SHARKIE MAIDEN - (1390 METRES)

GRAND PEGASUS – Raced wide throughout.

LOUD MOUTH – Jumped inwards at the start and had to be straightened by its rider.

VELOCE AQUILA – Began awkwardly, slow to muster early speed.

WHERE YOU FROM – Tightened close to the finish by LILY LUELLA (T Stalker) which shifted in.

LADY SARAH – Approaching the 200 metres rider L Annells was restricted for room and unable to fully ride her mount out.

LOVE NEST – Over raced in the early stages. Tightened close to the finish line by WHERE YOU FROM which had been carried inwards.

Prior to correct weight, rider of the third placegetter B McCoull (WHERE YOU FROM) and the rider of the fourth placegetter L Annells (LADY SARAH) wished to view the official patrol films approaching the finish line in relation to laying an objection against the winner over the concluding stages. After both riders and connections viewed the official patrol films, correct weight was given on the judges' numbers.

Rider T Stalker (LILY LUELLA) was severely reprimanded under the provisions of AR 131(a) for allowing her mount to shift in tightening the running of WHERE YOU FROM (B McCoull) and LADY SARAH (L Annells) who subsequently shifted in onto LOVE NEST (T Baker) over the concluding stages.

RACE 3 - TASMANIAN BLOODSTOCK MDN/CL1 - (1600 METRES)

DUMPUS – Declared a late scratching on veterinary advice at 12.27pm after hitting its mouth and sitting down in the barriers. Stewards advised trainer P Luttrell that DUMPUS must complete a satisfactory trial. On the announcement of correct weight Stewards ordered that all monies invested on DUMPUS be refunded, with the following deductions to apply to successful wagers placed prior to 12.27pm.

Stewards ordered that the following deductions would apply:

1st RIGOLETTO3 cents win, 3 cents place2nd LONDIANI3 cents place3rd PUNTER5 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

PUNTER – Had a tendency to lay in, in the home straight.

RIGOLETTO (NZ) - Raced wide throughout.

VANITY STAR – Slow to begin, raced wide throughout.

WOOD'S POINT – Raced wide throughout.

AURUM MAN (NZ) – Slow to begin.

FASHION FOX – Over raced early stages.

LONDIANI – Shied away from the running rail at the 200 metres.

NO SURPRISES – Slow to begin, tired from the 400 metres after leading. A post race veterinary examination revealed no abnormalities.

KNOT DANCING – Slow to begin.

RACE 4 - RACING CONNECT CLASS 1 HCP - (1100 METRES)

ADACHI – Shifted out upon jumping.

HARPER RAE – Slow to begin.

NEEDS REMEMBERING – Tightened between ADACHI and EVELINA ROSE upon jumping. Brushed with WANDERBETOUGH at 150 metres.

VOLKANOVSKI – Jumped outwards at the start. Raced three wide throughout.

DING DING – Raced three wide throughout. Stewards spoke to rider C Wells in relation to the below market expectations. Rider C Baker stated she was further back than anticipated due to the mare being difficult to ride. However, when she placed the mare under pressure in the home straight the horse ran on.

WANDERBETOUGH – Brushed with NEEDS REMEMBERING at the 150 metres.

TRICKY MIKKI – Rider E Byrne-Burke was advised she must ride her mounts out fully to the line.

EVELINA ROSE – Began awkwardly, tightened shortly after the start.

GRAPHITE MIST – Stewards granted permission for rider H Le BLANC to ride ½ a kilogram over the allotted overweight. Bounded outwards upon jumping, raced three wide throughout.

HER THOUGHTS – Stewards granted permission for rider D Pires to ride 1 kilogram over the allotted weight. Bounded outwards upon jumping. A post-race veterinary examination revealed no apparent abnormalities.

MILLA'S READY – Stewards granted permission for rider A DARMANIN to ride ½ a kilogram the allotted overweight.

RACE 5 - WINNING EDGE PRESENTATIONS BM76 HCP - (1100 METRES)

LAYLOW PLUCK – Stewards questioned Rider G Catania on the below market expectations performance of the gelding. Rider G Catania advised Stewards that her mount had travelled well in the early stages but failed to respond when placed under pressure in the home straight. A post-race veterinary examination revealed no apparent abnormalities.

TSUNAMI SAM (NZ) – Over raced during the early stages, shifted in under pressure in the home straight.

THUNBERG – Stewards granted permission for rider H Le Blanc to ride ½ kilogram over the allotted weight.

FAIRY MAGIC – Over raced during the early and middle stages.

RACE 6 - LADBROKES IT! BM60 HCP - (1390 METRES)

RICH CLAN – Raced wide throughout.

THOUGHTS'N'PRAYERS – Stewards questioned rider D Pires on the below market expectations of the gelding. Rider D Pires stated in his opinion the gelding travelled well in the early stages, however, failed to respond when placed under pressure. He also stated that in his opinion the step up in distance may not have suited. Underwent a post-race veterinary examination which revealed no apparent abnormalities.

MR FREEZE – Over raced during the early and middle stages, approaching the 400 metres restrained off the heels of the runner in front.

SUNSET GUN – Raced wide throughout.

SWEETSOP – Over raced during the early and middle stages before being disappointed for a run between the 400 and 200 metres shifting out to gain clear racing room.

THE DECIDER – Raced wide throughout.

MAARKLE – Slow to begin. Restrained off the heels of NOT A BRASS RAZOO approaching the 600 metres.

NEV'S BOY – Slow to begin.

RACE 7 – LADBROKES ODDS SURGE BM60 HCP (1390 METRES)

ROYAL AND TOUGH – Over-raced early stages, raced four wide throughout.

I'M BACK - Raced wide throughout.

WANE'S QUEST – Raced three wide throughout.

BRINKTOP LAD – Jumped inwards at the start, over raced during the early stages.

CAPTAIN MORGAN (NZ) - Slow to muster early speed.

DIAMOND BAY – Soon after the start contacted the hind quarters of BLACK EAGLET.

BLACK EAGLET – Threw its head up shortly after the start and commenced to over race.

RACE 8 - IT'S WHY WE RACE OPEN HCP - (1600 METRES)

There was a two-minute delay to the start of this race due to runners being placed in the incorrect barriers stalls. They were required to be removed and placed in their correct barriers.

MANDELA EFFECT – Laid in under pressure and brushed with SIR SIMON inside the 100 metres.

SHOT OF IRISH – Re-saddled behind the barriers. Tightened shortly after the start by AND BEYOND which shifted out.

AMAWORD – Restrained off the heels of DARK WANDERER after being tightened shortly after the start by KING ISLAND which had been carried out.

AND BEYOND – Underwent a pre-race veterinary examination after the race day farrier placed tips on the front and plates behind. Rider C Baker pleaded guilty to a charge under the provisions of AR 132(7)(a)(ii) for using the whip on nine occasions prior to the 100 metres, four more than permitted. In assessing penalty Stewards considered her guilty plea, her record under this rule and that it was her first offence. Rider C Baker was fined the sum of \$200.

SIR SIMON – Underwent a pre-race veterinary examination after the race day farrier placed tips all around. Over raced during the early and middle stages.

KING ISLAND - Tightened shortly after the start by SHOT OF IRISH which was carried out...

Stewards inquired into an incident shortly after the start where AMAWORD (H Le Blanc) had to restrain off the heels of DARK WANDERER (L Annells). It was ascertained that AND BEYOND (C Baker) shifted out marginally, resulting in SHOT OF IRISH (G Catania) shifting out and away from AND BEYOND. SHOT OF IRISH then shifted out onto KING ISLAND (E Byrne Burke) which subsequently shifted up the track tightening AMAWORD. After hearing evidence from all riders, viewing the official patrol films and acting on their own observations, Stewards could not attribute the incident to any one rider.

Rider D Pires (MANDELA EFFECT) pled guilty to a charge under the provisions of AR132(7)(a)(ii) for using the whip on 7 occasions prior to the 100 metres and 10 times inside the 100 metres, with a totality of 17. In assessing penalty Stewards considered his guilty plea, his record under this rule and that he had won the race. Rider D Pire's licence to ride in races was suspended for 1 Tasmanian race date, commencing midnight 13th August 2023 until midnight 20th August 2023.

RACE 9 – AVISO TAS INSURANCE BROKERS BM68 HCP – (2100 METRES)

CHI MAZEL - Raced wide throughout.

JACKJACK - Steadied off the heels of BLUSHED at the 600 metres.

HELLFIRE EAGLE – Stewards granted permission for rider M Ulucinar to ride 1 kilogram over the allotted minimum weight.

AUTISSIER (NZ) – Shortly after the start was tightened for room between COSTERO and PERUN.

EXPENSIVE MISTAKE – Stewards granted permission for rider D Pires to ride 1 kilogram over the allotted minimum weight. Raced three wide throughout, laid in under pressure over the concluding stages.

CROWN AND ANCHOR – Stewards granted permission for rider H Le Blanc to ride ½ kilogram over the allotted weight. Jumped awkwardly, over raced early stages. Steadied off heels of PERUN approaching the 700 metres.

Rider **S Carr** (SOUTHERN WIND) pled guilty to a charge under the provisions of AR 132(7)(a)(ii) for using the whip on 9 occasions prior to the 100 metres, 4 more than permitted. In assessing penalty assessing penalty Stewards considered her guilty plea, her record under this rule and that she had won the race. Rider S Carr's licence to ride in races was suspended for 1 Tasmanian race date, commencing midnight 13th August 2023 until midnight 20th August 2023.
