Apprentice E Byrne-Burke was stood down for race 4 only after being kicked by her mount after the running of race 3. Apprentice E Byrne-Burke was passed suitable to fulfil her engagements.

Apprentices T Johnstone and C Jordan were dislodged after Race 3. Both riders were examined and passed suitable to fulfil their engagements.

RACE 1 – LADBROKES OWNERS INCENTIVE BENCHMARK 68 HANDICAP – 1100 METRES

GEEGEE JET BY – Knuckled shortly after jumping. Approaching the home turn bumped with WARICA.

WARICA – Raced wide and without cover. Approaching the home turn bumped with GEEGEE JET BY. Brushed with FEISTY LION over the concluding stages.

GEE GEE ALS PRINCE – Slow to begin.

FEISTY LION – Brushed with WARICA over the concluding stages.

RACE 2 - PROSPECT MARKET PLACE NEWSAGENCY MAIDEN 3YO & UP - 1200 METRES

WHO CAN IT BE NOW - Near the 1000 metres was checked, blundered and lost ground.

PONSFORD – Slow to begin. Near the 1000 metres had to be severely checked and lost ground.

LULULAND – Rider R Tan reported that the mare hung out throughout.

SOULITA – Bumped heavily on jumping. Near the 1000 metres when tightened, had to be severely checked and lost considerable ground.

CORONATION KEELY -

KABOOM KABOOM – Began very awkwardly, shifted out and bumped with LULULAND.

Apprentice C Wells (NEED A GIGGLE) was found guilty of a charge of careless riding under the provisions of AR131(a) the particulars being that near the 1000 metres she permitted her mount to shift in when not sufficiently clear of FIGHTING FOR GOLD, which was taken in onto SOULITA which was checked resulting in WHO CAN IT BE NOW having to be checked and PONSFORD, who was trailing also having to be checked. Apprentice C Wells permit to ride in races was suspended for a period of two Tasmanian race dates. In assessing penalty, stewards were mindful of her good riding record and also that the manners of FIGHTING FOR GOLD, in the opinion of stewards, contributed to the incident. Apprentice C Wells was reminded of her right of appeal.

RACE 3 – LONGFORD NEWSAGENCY MAIDEN 3YO & UP – 1400 METRES

FOREIGN LEGION - Had difficulty obtaining clear running over the concluding stages.

MACAN – Under-went a pre-race veterinary examination and was passed suitable to race. Passing the 200 metres had to be momentarily steadied when awkwardly placed inside the heels of JOHHNIE PINCH.

GOLDEN SOIL – Went down in the barriers. Underwent a pre-race veterinary examination and was passed suitable to start. Apprentice J Radley reported that the mare failed to respond throughout. A post-race veterinary examination revealed no abnormalities. Trainer E Batt was

advised that the gelding would be required to trial to the satisfaction of stewards prior to racing again owing to it being fractious in the barriers and the poor performance. Trainer E Batt advised on returning to his stables that the mare was in season and this may have affected its performance.

ZULU ESPRIT - Raced wide and without cover.

RACE 4 – NEXTRA KINGS MEADOWS NEWSAGENCY MAIDEN/CL1 – 2100 METRES

AURUM MAN (NZ) - Slow to begin.

MONTE FLEUR – Began awkwardly and shifted out, bumping PENNINE.

PENNINE – Bumped on jumping. Over raced in the early stages when being restrained. Rider S Carr reported upon returning to scale that something may have been amiss with the mare. A post-race veterinary examination revealed the mare to be mildly lame in the near hind. No stand down was issued.

RACE 5 - INVERMAY NEWSAGENCY CLASS 2 HANDICAP - 1200 METRES

CREATIVE LICENCE – Over raced in the middle stages.

RUBBLEONTHEDOUBLE – Slow into stride.

EXTREME GEM – Under-went a pre-race veterinary examination and was passed suitable to race. A post-race veterinary examination revealed no abnormalities.

BARMAID GIRL – Bumped on jumping.

VENTUS – Held up rounding the home turn.

MISS RED – Stewards granted permission for rider M Ulucinar to ride 1kg over the allotted weight of 54kgs. .

RACE 6 – RIVERSIDE POST, NEWS & LOTTO BENCHMARK 60 HCP 1400 MTERES

GEEGEELUCKYSTAR – Bumped on jumping. Over raced in the middle stages.

WILLBY RULES – Slow into stride.

THE DECIDER – Near the 1200 metres was momentarily inconvenienced when awkwardly placed inside of the heels of O'REILLY MCLUKE (I Toker) which shifted in marginally. I Toker was advised in future circumstances he should relief the pressure to runners to his inside.

UPSET – Held up and unable to improve approaching and rounding the home turn. Over the concluding stages had to be momentarily steadied when awkwardly placed on the heels of THE DECIDER (App C Wells) which shifted out when not clear. Apprentice C Wells was advised to exercise more care. Apprentice C Wells was reminded of her obligations to ride her mounts out to the finishing line.

MAARKLE – Over raced in the middle stages.

RACE 7 - NORWOOD NEWSAGENCY OPEN HANDICAP - 1400 METRES

MANDELA EFFECT – Steadied shortly after the start. Brushed with RISING LIGHT over the concluding stages. Apprentice J Radley was reprimanded for failing to weigh in, under the provisions of AR210(1).

RISING LIGHT – Brushed with MANDELA EFFECT over the concluding stages when racing tight.

ARTY LUCAS – Stewards permitted rider H McCarthy to ride the gelding 1kg over the declared weight of 54kgs. Steadied shortly after the start when awkwardly placed on heels.

SH'BOURNE REBEL - Raced wide and without cover.

KING ISLAND – Underwent a pre-race veterinary examination and was passed suitable to start.

RACE 8 - CHARLES ST. CENTRAL NEWSAGENCY CLASS 2 HCP 1600 METRES

ALPINE ASSAULT – Began awkwardly and shifted out.

DOONICAN – Slow into stride.

Race 1 - 10:55AM Ladbrokes Owners Incentive Maiden (1390 METRES)

LA FOLIE DOUCE – Trainer S Cotton reported upon returning to the stables it was determined that the mare was in season and that this may have contributed to the poor performance.
