#### RACE 1 – LADBROKES OWNERS INCENTIVE SCHEME MAIDEN – (1200 Metres)

**AUNTIE JAKE'S BAR –** Jumped awkwardly, raced wide throughout, laid in, in the home straight.

**BUEL** – Change of tactics, to be ridden further forward. Tactics unable to be adopted. Tightened near the 800 metres when carried in by MY DESIGN.

LOUD MOUTH (NZ) – Bumped on jumping when MY DESIGN shifted in.

**ROHZHAE –** Raced wide throughout.

**CARNELIAN ROCK –** A post-race veterinary examination revealed no obvious abnormalities.

**RUBBLE** 'N' FUDD – Bounded on jumping unbalancing the rider.

**MY DESIGN –** Over-raced near the 800 metres and proved difficult to control. A warning has been issued, laid in, in the home straight.

**TOSEN FAME –** Rider reported the mare failed to respond to her riding from the 600 metres.

**SUNRISE AT KIRRA –** Attempted to buck shortly after the start. Stewards spoke to apprentice Jackson Radley and advised him that he is not to use spurs on first starters and inexperienced horses and that he should speak to the respective trainers prior to his riding engagements. Stewards have advised the trainer that the filly will be required to trial prior to racing again. Tightened near the 800 metres and over raced. Raced tightly to the inside of BUEL near the 600-metre turn and again commenced to over race and bumped heavily with BUEL.

**THEM'S THE BREAKS** – Fractious in the gates, slow to muster early speed. Trainer M Ryan was advised a warning has been issued on the fillies barrier manners.

#### RACE 2 – LADBROKE IT! MAIDEN – (1200 Metres)

**CAPTAIN TAZ (NZ) –** A post-race veterinary examination revealed no obvious abnormalities.

**GOLD PROOF –** Raced wide throughout.

**MISS TANZANITE –** Slow to muster early speed.

**STRAWBERRY CREAM** – Bumped heavily with LITTLE RIVER TOFF near the 800 metres when that filly commenced to over-race.

**APRIL'S DANCE –** Stewards granted permission for rider S Tsaikos to be ride ½ kilogram over the allotted weight.

**LITTLE RIVER TOFF** – Over-raced after becoming tightened to the inside of STRAWBERRY CREAM near the 800 metres and bumped heavily with that mare, a warning on its racing manners has been issued.

**PEROLA –** Bumped near the 800 metres when STRAWBERRY CREAM was bumped and carried wider.

#### RACE 3 – BEACH CLUB CLASS 1 HANDICAP – (1200 METRES)

**ARELIUS –** Over-raced early and middle stages.

**CREEK LODGE –** Slow to begin and laid in over the concluding stages.

**SHARE THE GOLD –** Fractious in the barriers a warning has been continued.

**SPINHOF** – Held up on the home turn and again near the 250 metres behind ARELIUS.

**PUNTER –** Laid in on the home turn.

**MISS KEEDS –** Stewards spoke with rider C Newitt in relation to the below market expectations. Rider C Newitt stated that the filly was up in class and in future races may need to find cover and take a sit. Compounded over the concluding stages. A post-race veterinary examination revealed a high heart rate, slow recovery.

**TARKINE EAGLE –** Raced three wide throughout.

#### RACE 4 – TASMANIAN BLOODSTOCK BENCHMARK 60 HANDICAP – (1600 METRES)

**JERIMIAH** – Fractious in the barriers, a warning has been issued. A post-race veterinary examination revealed a minor laceration to the near fore elbow. Rider C Newitt reported that the gelding failed to stretch out in the run and that when placed under pressure failed to respond to his riding. He also stated that in his opinion that JEREMIAH may have come to the end of its preparation.

**EAGLE STREET –** Laid in home straight.

**NEEDS REMEMBERING** – Stood flat footed and missed the start by 5/6 lengths. Trainer T Evans was advised the gelding must trial satisfactorily prior to racing again.

#### RACE 5 – KEVIN SHARKIE ELWICK STAKES – (1100 METRES)

**GEEGEES MISTRUTH** – Underwent a pre-race veterinary examination after becoming cast in its stall the previous day and was passed suitable to race. Shifted in on jumping tightening the running of SKY LAND.

**OLIVE GIRL –** Raced three wide in the early stages.

**VIOLA VIVACE –** Shifted out on jumping tightening ANGEL SPHERE out onto SKY LAND. Tightened and restrained shortly after the start when GEEGEES MISTRUTH shifted in when not quite clear. A Darmanin was issued with a severe reprimand under AR 131(a) for careless riding. A post-race veterinary examination after the horse became fractious in the tie ups revealed a minor cut on the right hind pastern.

**ANGEL SPHERE –** Tightened on jumping at the start when GEEGEES MISTRUTH shifted in carrying SKY LAND inward. Over raced early and middle stages.

**BAYBOUGG** – Rider S Carr reported that her mount had laid in for the entire home straight placing her at a disadvantage and she was unable to ride her mount out.

**SKY LAND** – Tightened on jumping when GEEGEES MISTRUTH shifted in, and ANGEL SPHERE was carried out.

Stewards inquired into an incident about the 1000 metres when VIOLA VIVACE (B McDougall) had to steady his mount. Rider B McDougall stated it was his intentions to allow GEEGEES MISTRUTH (A Darmanin) to cross so as he could take a sit. Stewards issued ride A Darmanin with a severe reprimand under the provisions of AR131(a) careless riding as in their opinion they believed that A Darmanin was not fully clear.

## RACE 6 – GEARD FAMILY BLACKFLASH – (1100 Metres)

**NEEDS SUGAR –** Raced wide throughout, over-raced in the middle stages, Stewards spoke with rider A Darmanin in relation to the below market performance expectations, rider A Darmanin stated that the filly had not responded to his riding in the early stages.

**SPRING EAGLE –** Slow to begin.

**POPILITA –** Difficult to load, a warning has been issued.

**ANYWAYS ROXIE –** Over-raced in the early stages and was caught three wide throughout.

LA VIRAGO – Shifted out on jumping bumping with SWINGING IT.

**SWINGING IT –** Bumped with LA VIRAGO at the start. Over-raced in the early stages of the race and had to be continually steadied off heels approaching the 800 metres.

**POSITIVE PRESS** – Stewards granted permission for rider B McDougall to ride 1kg over the allotted minimum weight. A post-race veterinary examination revealed no obvious abnormalities.

## RACE 7 – WINNING EDGE PRESENTATIONS LADY LYNETTE – (1100 METRES)

**JAGUAR STONE –** Jumped awkwardly and then bumped by EMILY which had shifted in.

**ALVARINHO** – Laid out under pressure approaching the winning post momentarily inconveniencing JAGUAR STONE. Rider B Muhcu was advised to exercise care when shifting ground.

**QUEENSBROUGH FLYER –** Laid in entering the home straight.

**EMILY –** Shifted in on jumping bumping with JAGUAR STONE.

BELPINE MISS – Bumped with ALVARINHO near the 900 metres.

**INTISAR –** Raced three wide throughout.

## RACE 8 – WINNING EDGE PRESENTATIONS THOUSAND GUINEAS – (1600 METRES)

**ISLAND WARRIOR –** Over raced in the early and middle stages.

WINGS OF SONG - Over-raced in the middle stages and shifted out bumping with TRIXIE

**BOBBLE –** Change of tactics advised, to be ridden further forward circumstances permitting. Tactics adopted.

**GOLDEN MEADOW** – Bumped on the home turn when BUDDONG shifted out and carried out onto TRIXIE(NZ). Shifted out under pressure in the home straight.

**WINNING WITNESS –** Jumped extremely awkwardly and lost ground. Over-raced in the early and middle stages.

**ELLA DULCIE –** Over-raced and threw its head up in the early and middle stages. Laid in, in the home straight. 100 metres.

**EASTCOAST MISS** – Held up for clear run near the 250 metres for some distance.

**TRIXIE (NZ)** – Bumped near the 1200 metres and again near the 600 metres when WINGS OF SONG rolled out.

#### RACE 9 – AVISO TAS INSURANCE BROKERS SUMMER CUP – (2200 Metres)

**SWOOP DOG –** Held up from the 600 metres

**ASHY BOY –** Jumped awkwardly and lost ground. Held up from the 600 metres when placed awkwardly behind the tiring AFRICAN THUNDER. Shifted out near the 400 metres to obtain a clear run.

**ARTY LUCAS** – Checked off heels of TRAVELLING GIGOLO when that gelding shifted wider to improve. (Adjourned inquiry)

**RISING LIGHT –** Raced three wide throughout.

**SH'BOURNE RENEGADE** – A post-race veterinary examination revealed no obvious abnormalities. Connections advised that the gelding will now be retired.

I'M SO COOL - Compounded in the home straight, a post-race veterinary examination revealed

**AFRICAN THUNDER** – When questioned on the tactics adopted today by rider S Tsaikos stated that his instructions were to be positive from the barrier and take up a handy position. Trainer D Tyson confirmed these instructions however stated that it had not been his intentions to have the gelding lead. Stewards reminded him of his obligations under the rules regarding any change of tactics in future.

**GLITTER 'N' GOLD –** When questioned rider T Baker reported the mare was one paced today and failed to respond to his riding. A post-race veterinary inspection revealed no obvious abnormalities.

#### RACE 10 – LADBROKES RACING CLUB CLASS 2 HANDICAP – (1430 Metres)

**MAKE A DECISION –** Shifted in near the 100 metres and inconvenienced SHOOTING NORTH as it was not quite clear. Apprentice T Johnstone was reprimanded for careless riding under the provisions of AR 131(a).

**ADACHI** – Laid in on the home turn.

**FURNEAUX –** When questioned on the below market expectations performance rider C Hefel stated that the gelding failed to respond from the 300 metres. A post-race veterinary examination revealed no abnormalities.

**DUNCANNON –** Raced three wide throughout.

**SHOOTING NORTH –** Steadied near the 100 metres when MAKE A DECISION shifted in.

**KINGS ON QUEENS –** Held up on the home turn.

**HELLOT –** Laid in under pressure in the home straight.

**FIGHTING GRACE –** Slow to muster early speed.
