Comments / Explanations:

RACE 1 – TASMANIAN BLOODSTOCK 2YO HANDICAP – (1100 METRES)

HOAX – Underwent a post-race veterinary examination and was provided dental treatment.

SAY IT WITH WORDS – Shifted in and bumped with NATIVE CLAN approaching the 600m. Underwent a post-race veterinary examination which revealed the gelding had a high heart rate and slow recovery. SAY IT WITH WORDS will require a pre-race veterinary examination prior to the gelding's next start.

LADY FERN – Slow to begin. Over-raced in the early stages, steadied off the heels of Hoax approaching the 600 metres.

NATIVE CLAN – Slow to muster early speed. Bumped by SAY IT WITH WORDS when it shifted in approaching the 600 metres.

FIRST LINE – Over-raced in the early stages.

RACE 2 – AVISO TAS INSURANCE BROKERS MAIDEN – (1200 METRES)

FREDDY'SAJETSTAR – Raced wide throughout.

ALPINE EDWARD – Slow to begin. Underwent a post-race veterinary examination and no abnormalities were detected.

KAGISO – Difficult to load and was fractious in the barrier. Underwent a pre-race veterinary examination and was declared a late scratching at 1:30pm on Vets advice. Trainer J. Keys was advised the gelding must complete a satisfactory trial prior to racing again. KAGISO underwent a post-race veterinary examination which detected a laceration and swelling to the head. Stewards advised trainer J. Keys the gelding will require a veterinary clearance prior to racing.

On the announcement of correct weight Stewards ordered that all monies invested on KAGISO be refunded, with the following deductions to apply to all successful wagers placed prior to 1.30pm. Stewards ordered that the following deductions would apply:

1st BLONDE STAR	12c Win, 7c Place
2nd MISS PRIVATE	20c place
3rd MY DESIGN	23c place

All monies bet after the withdrawal to be paid at face value of the tickets.

MISS PRIVATE – Bumped with ROLLING IN IT at the start.

MY DESIGN – Bumped with STEEL CONNECTION at the start. Raced three-wide throughout. Had a tendency to lay in approaching the 200 metres.

ROLLING IN IT – Bumped with MISS PRIVATE at the start.

BLONDE STAR – Slow to begin had a tendency to over-race middle stages.

STEELE CONNECTION – Began awkwardly after contacting the barrier gate and bumped with MY DESIGN. Raced greenly throughout.

RACE 3 – LADBROKES OWNERS INCENTIVE MAIDEN – (1000 METRES)

BAHIA BAY – Was taken in and tightened for room when Love Nest shifted in near the 800m.

FRENETICO – Jumped awkwardly and was slow to muster speed.

NEED A GIGGLE – Made contact with GEE GEES MOONLIGHT which jumped out at the start. Eased when tightened for room when LOVE NEST shifted in on to BAHIA BAY.

GLORY MISSION – Was held up to obtain a clear run approaching the 200 metres before shifting out to improve.

GEE GEES MOONLIGHT – Jumped out and made contact with NEED A GIGGLE at the start. Raced wide throughout.

LOVE NEST – Near the 800 metres shifted ground inwards abruptly and tightened BAHIA BAY, causing that horse to ease.

Stewards found rider J. Radley guilty under the provisions of AR131(a) careless riding after allowing his mount to shift in and tightening Bahia Bay near the 800m. In assessing penalty stewards took into account Mr Radley's record and that the interference was in the mid-range. Rider J. Radley's licence to ride in races was suspended for one Tasmanian race date commencing at midnight 29th March 2024. Rider J. Radley was advised of his right of appeal.

RACE 4 – WINNING EDGE PRESENTATIONS BENCHMARK 62 HANDICAP – (2200 METRES)

HAPPY CLAN – Bumped with NAMABAALÉ at the start.

NAMABAALÉ – Jumped out at the start bumping with HAPPY CLAN. Raced wide in the middle stages. Compounded over the concluding stages. A post-race veterinary examination revealed the gelding to have bled from both nostrils. Trainer G. Stevenson was advised of the provisions of AR79(4) A horse which, in the opinion of the Stewards, has had an attack of bleeding must not, without permission of the Stewards: (a) be trained, exercised or galloped on any racecourse for a period of 2 months after the attack of bleeding; (b) start in any race for a period of 3 months, and then only after a satisfactory trial or a gallop of at least 1,000 metres in the presence of a Steward. Trainer G Stevenson advised stewards its now his intentions to retire the gelding.

JACKJACK – Underwent a post-race veterinary examination, no abnormality was detected.

PAGE – Trapped three wide early stages.

RACE 5 – RANVET NATIONAL APPRENTICE RACE SERIES 2024 CLASS 2 HANDICAP (APPRENTICE RIDERS ONLY) – (1100 METRES)

JEHBENTI – Slow to muster speed. Shifts in and checks GEEGEE'S MISTY. Shifts out and brushes with BATCHY BULLET when entering the home straight.

GEEGEE'S MISTY – Checks off the heels of JEHBENTI.

BELLASARIO – Over raced in the early stages.

BATCHY BULLET – Jumped out at the start, bumping with BELLASARIO. Raced three wide throughout. Brushed with JEHBENTI entering the home straight. Underwent a post-race veterinary examination which detected mild lameness in the left hind leg. BATCHY BULLET will require a pre-race veterinary examination prior to the geldings next start.

FIANCETTO – Stewards granted permission for rider L. Maloney to ride ½ kilogram over the allotted minimum weight.

WHIZ BY – Wide early stages. Over-raced three wide

PERKINS – Stewards granted permission to race without blinkers.

Stewards inquired into an incident approaching the 600 metres, where JEHBENTI (J. Radley) appears to be tightened for room by BATCHY BULLET (E. Byrne Burke) and shifted in and tightened GEEGEE'S MISTY (G. Semmens). Stewards advised rider E. Byrne Burke to exercise care when shifting ground.

RACE 6 – OLIVE TREE CATERING MAIDEN/CLASS 1 – (2100 METRES)

AMERICAN JEWEL – Raced wide throughout. Underwent a post-race veterinary examination, no abnormalities were detected.

MIKAZUKI – Over-raced middle stages.

WADDY WADDY – Jumps awkwardly and made contact with the outside barrier partition. Slow to muster speed. Inconvenienced when Strawberry Kiss shifted out when entering the home straight.

STRAWBERRY KISS – Shifted out and inconvenienced WADDY WADDY when turning in to the home straight. Underwent a post-race veterinary examination and no abnormalities were detected.

WANING WEASEL – Raced wide middle stages.

RACE 7 – TASRACING NATIONAL APPRENTICE RACE SERIES 2024 0-62 (APPRENTICE RIDERS ONLY) – (1600 METRES)

ADACHI – Tightened on jumping when I'M KEEFE shifted in. Raced wide throughout.

I'M KEEFE – Jumped inwards and bumped ADACHI at the start. Underwent a post-race veterinary examination, no abnormalities were detected.

LORD WHITEGATE – Over-raced early.

OUR LITTLE TED – Tightened for room when LORD WHITEGATE shifted out and NOZTRABEEL laid in entering the home straight.

LOUD MOUTH (NZ) – Underwent a pre-race veterinary examination and was cleared to race after Stewards were advised the gelding had a plate replaced. LOUD MOUTH (NZ) was fractious in the barriers and underwent a pre-race veterinary examination and was cleared to race.

EAGLE STREET – Underwent a post-race veterinary examination, no abnormalities were detected.

KINGS ON QUEENS – Stewards were advised the gelding had a plate replaced prior to racing. Underwent a pre-race veterinary examination and was cleared to race.

NOZTRABEEL – Underwent a post-race veterinary examination, no abnormalities were detected.

COSTERO – Rider C. Van Munster pulled up at the 400m after she felt something was amiss with the gelding. Costero underwent a post-race veterinary examination, no abnormalities were detected. Trainer J. Blacker advised that the gelding will trial on Tuesday 26th March in Hobart.

RACE 8 – KEVIN SHARKIE BENCHMARK 76 HANDICAP – (1600 METRES)

KALIUWAA FALLS (NZ) – Had a tendency to over-race. Bumps DANTES (NZ) at the 700m.

YARRA MASTER – Bumped with ALPINE BLAST on several occasions in the home straight.

DANTES (NZ) – Three wide early and middle stages. Shifted in and bumped with KALIUWAA FALLS (NZ) at the 700 metres.

ALPINE BLAST – Bumped with YARRA MASTER on several occasions in the home straight.

Rider S. Carr pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) for using her whip on 9 occasions prior to the 100 metres. In assessing penalty Stewards took into account her guilty plea, her record under this rule and that the breach was four more than permitted prior to the 100m. After considering all circumstances stewards fined rider S. Carr the sum of \$600. Rider S. Carr was reminded of her right of appeal.
