# Comments / Explanations:

#### RACE 1 – LADBROKES OWNERS INCENTIVE SCHEME MAIDEN – (1200M)

**FREDDY'SAJETSTAR** – Over raced in the early and middle stages.

**SHARK ISLAND -** Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

**LONTANO** – Shifted in near the 1100 metres momentarily tightening the run of PURPLE MOON. Rider J Radley was advised to exercise care. Laid in momentarily tightening the running of GEEGEEHAILSTORM over the concluding stages.

**GEEGEE STRAWBERRY -** Underwent a pre-race veterinary examination as a result of a superficial graze to the near fore, passed clear to run. Laid out over the concluding stages.

**PURPLE MOON -** Stewards granted permission for rider M Ulucinar to ride ½ kg over the allotted weight. Jumped awkwardly, contacting the outside of the barriers. Had to be steadied near the 1100 metres when LONTANO shifted in. Was inclined to over race in the early stages.

#### RACE 2 – FINAL NIGHT RACE MEETING FOR THE SEASON APRIL 17 0 – 60 – (1200M)

**SUNSHINE MOSHE – Raced wide middle stages.** 

**GEEGES MISTY –** Rider dropped whip approaching the winning post.

**DASH IT –** Tightened on jumping when EGAO shifted in. Rider C Wells was reprimanded under the provisions of AR131(a) Careless Riding for allowing her mount to shift out at about the 100 metres bumping with SUNSHINE MOSHE (L Bingley) resulting in both horses bumping on several occasions.

**EGAO** - Shifted in on jumping tightening EGAO. Laid out on the home turn. Rider reported that it had not been her intention to sit outside the leader however, when she had attempted to steady the mare, it did not respond to her efforts. Rider A Darmanin was issued with a reprimand for failing to fulfill his riding commitments due to overweight under the provisions AR190(3).

#### RACE 3 - LADBROKE IT! MAIDEN/CLASS 1 - (2100M)

**MIKAZUKI** – Shifted in abruptly on jumping hampering WANING WEASEL and GEEGEES SUNSHINE which both lost their position. Raced wide in the middle stages before electing to go forward, held up over the concluding stages.

**MIGHTYMAXI** – Represented by Senior rider C Newitt, Apprentice J Radley pleaded guilty to a charge, under the provisions of AR132(7)(a)(i), in that he used his whip on consecutive strides on one occasion prior to the 100 metres. Rider J Radley was fined the sum of \$100.

JUST BE A QUEEN - Over raced passing the winning post on the first occasion.

**KINGSLEY COCO** - Declared a late scratching at 6:28pm on veterinary advice. A pre-race veterinary examination behind the barriers revealed the Mare to have blood in both nostrils. Trainer J Lutrell was advised of the provisions of AR79(1). The mare has been stood down from racing for a period of 3 months and until the completion of a 1000m gallop or official trial in the presence of a steward.

On the announcement of correct weight Stewards ordered that all monies invested on KINGSLEY COCO be refunded, with the following deductions to apply to all successful wagers placed prior to 6:28pm.

Stewards ordered that the following deductions would apply:

1st – MIGHTYMAXI 0c Win 2c Place

2nd – TOSEN FLAME 1c place

3rd – SPEED ROCK 2c place.

All monies bet after the withdrawal to be paid at face value of the tickets.

**WANING WEASEL** – Tightened on jumping. Raced three wide early and middle stages. Laid in near the 400 metres.

## RACE 4 - LADBROKES SPORTS BAR CLASS 1 HANDICAP - (1400M)

**SURELY SPECIAL** – Jumped awkwardly contacting the inside gate. Overaced early stages.

**BLONDE STAR** – Held up for clear running between SURELY SPECIAL and TRICKY MIKKI over the concluding stages.

**OZTURK -** Underwent a pre-race veterinary examination which failed to reveal any obvious abnormalities. Over raced early stages, laid out near the 1200 metre turn.

**DAIQUIRI DIVA –** Raced three wide throughout.

**TRICKY MIKKI –** Over raced early stages.

**LIKA MOSH –** Shifted in on jumping bumping DAQUIRI DIVA.

# RACE 5 - MEMBERS JACKPOT DRAW BENCHMARK 60 HANDICAP - (1400M)

**FIGHTING FLOYD –** Over raced early and middle stages.

**CHOSEN EAGLE –** Momentarily tightened for room when KEEPERS TOUCH shifted out approaching the 200 metres.

**LION'S TOOTH – Momentarily held up for a run on the home turn behind SUGOI LEGEND.** 

**STARNOTE** – Stewards queried rider C Newitt in relation to the below market performance of the mare. Rider C Newitt stated that his mount raced flat and failed to respond when placed under pressure. Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

**SHARE THE GOLD** – Stewards queried rider H Le Blanc on the below market performance of the gelding. Rider H Le Blanc stated the gelding failed to begin better than expected, when the gelding was placed under pressure it failed to respond to her riding.

#### RACE 6 - SALTER'S HIRE CLASS 4 HANDICAP - (1100M)

**BETTER THAN BANKSY –** Tightened on jumping when BOLD INSTICT shifted in.

**BOLD INSTINCT –** Shifted in on jumping.

**ZIPITUP –** Over raced at the 800 metres.

# RACE 7 - LITTLE GIANT HOMES OPEN HANDICAP - (1400M)

**BELLO BEAU –** Laid out under pressure entering the home straight before being corrected by rider C Newitt.

**GALENUS** – Hung out throughout the home straight. Underwent a post-race veterinary examination which revealed the gelding to be lame on the near fore and near hind. Rider C Baker when queried over the below market performance of her horse stated it was the gelding first start over the distance and failed to run out the distance.

**KALIUWAA FALLS** - Rider F Kersley pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) for using his whip on 7 occasions prior to the 100 metres. In determining penalty stewards took into account his guilty plea and his record in relation to this rule. Rider F Kersley was fined the sum of \$400.

**AND BEYOND -** Jumped awkwardly. Shifted wide in the home straight to gain clear running.

# RACE 8 - STEVE'S LIQUOR BENCHMARK 68 HANDICAP - (1600M)

**MYWORDIS** – Raced three wide early stages. Rider L Riordan reported he believed there was something amiss with his gelding. Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

**NAVY STREET –** Bumped shortly after the start.

**ALWAYS A WINNER – Shifted out marginally at the 500 metres brushing with WARDELL.** 

**RIGOLETTO – Shifted out at the start bumping with WARDELL.** 

**WARDELL** – Tightened on jumping and bumped with RIGOLETTO shifting out. Raced wide from the 800 metres. Brushed on two occasions with ALWAYS A WINNER at the 500 metres.

#### **ADDENDUM**

**GENERAL** 

Stewards spoke with riders G Catania and Apprentice C Wells in relation to the provisions of AR193(c) speaking to members of the public over the fence who are not licensed at the conclusion of the race. Under the provisions of AR193(c) the rider must not speak to or communicate in any way with any person other than the trainer or nominator (or their authorised agent) of the horse, an official in the course of his or her duties, or during the race another rider.

The Steward's report as posted is provisional and subject to further review and amendment.
