Comments / Explanations:**RACE 1 – LADBROKES OWNERS INCENTIVE MAIDEN – (1100 METRES)**

CHRISTOPHER ROBIN – Bumped by RARE ORA at the start. Had a tendency to over-race in the early stages.

MISTER MANIHI – Began awkwardly.

ROW ROW POWER – Shifted in under pressure at about the 200 metres momentarily crowding MISTER MANIHI.

ROWING POWER – Had a tendency to over-race in the early stages.

APRIL'S DANCE – Had a tendency to over-race in the middle stages.

GEE GEE SALTBUSH – Jumped in at the start tightening RARE ORO in on to CHRISTOPHER ROBIN.

PUZZLE MISS – Raced wide throughout.

RARE ORO – Tightened at the start when GEE GEE SALTBUSH jumped in.

SHE PLAYS GAMES – Steadied off heels near the 500 metres.

STEEL CONNECTION – Began awkwardly, brushing the inside of the barrier gate.

KISSED BY MIST – Jumped in at the start brushing with MISTER MANIHI and raced greenly throughout.

Prior to the declaration of correct weight rider A Darmanin (APRIL'S DANCE) wished to view the official patrol films. After viewing the films, the correct weight was declared on the judge's numbers.

RACE 2 – WINING EDGE PRESENTATIONS MAIDEN – (1400 METRES)

FOREIGN LEGION – Bounded on jumping, shifted in and bumped with TIDEFORD (NZ).

TIDEFORD (NZ) – Raced fiercely in the early stages, shifted out abruptly near the 900 metres and bumped with ZONNA VERDE.

FRYER HILL – Underwent a post-race veterinary examination which revealed the mare was lame in the right foreleg. Stewards advised trainer T Evans the mare will require a veterinary clearance prior to racing again.

MISS PRIVATE – Raced wide in the early stages.

WE ALL DECIDE – Rider A Darmanin pleaded guilty to a charge under the provisions of AR132(7)(a)(ii) for using his whip on 9 occasions prior to the 100 metres, four more than permitted. In determining penalty stewards took into account his guilty plea and his record in relation to this rule. Rider A Darmanin was fined the sum of \$300.

ZONNA VERDE – Raced wide early, bumped by TIDEFORD (NZ) near the 900 metres.

RACE 3 – KEVIN SHARKIE TASMANIAN SIRES PRODUCE – (1400 METRES)

GARCON D'ESPOIR – Fractious in the barrier prior to jumping. Shifted in on jumping brushing with NATIVE CLAN. Shifted out under pressure in the home straight.

HALEN – Caught three-wide in the early stages.

NATIVE CLAN – Brushed at the start by GARCON D'ESPOIR when it shifted in at the start.

LADY FERN – Stewards granted permission for rider S Carr to ride 1/2kg over the minimum allotted weight. Rider S Carr reported when returning to the scale that her mount was making a respiratory noise. Underwent a post-race veterinary examination which revealed no obvious abnormalities.

RACE 4 – AVISO TAS INSURANCE BROKERS BM76 HCP – (2200 METRES)

TRAVELLING GIGOLO – Jumped out at the start brushing with PUNTER. Raced three-wide in the middle stages.

PAGE – Stewards granted permission for rider S Carr to ride 1/2kg over the minimum allotted weight.

ALWAYS A WINNER – Had a tendency to over-race in the early and middle stages.

PUNTER – Brushed by TRAVELLING GIGOLO at the start. Had a tendency to over-race in the early and middle stages. Connections advised the gelding will now be going for a short spell.

RACE 5 – LADBROKE IT! BM60 HCP – (1400 METRES)

RIGOLETTO (NZ) – Bumped by LILY LUELLA at about the 250 metres.

CAPITAL CHEVAL – Raced three-wide in the middle stages. Was crowded and had to check off the heels of SUNSET GUN and RIGOLETTO (NZ) at about the 250 metres.

SURELY SPECIAL – Raced wide early.

SUNSET GUN – Had a tendency to over-race in the early stages. Carried wide by ZEWINNA which shifted out at about the 250 metres.

ZEWINNA – Jumped awkwardly shifting outwards. Shifted out over heels at about the 250 metres carrying SUNSET GUN wide.

LILY LUELLA – Shifted in on to RIGOLETTO (NZ) at about the 250 metres.

MONTE BIANCO – Had a tendency to over-race in the middle stages.

LET'S MESSAROUND – Slow to muster.

KEEPER'S TOUCH – Jumped inwards creating I'M BACK in on to PRINCESS MATOAKA.

Stewards inquired into an incident at about the 250 metres when ZEWINNA (J Radley) shifted out to improve over heels resulting in SUNSET GUN (E Byrne Burke) shifting out and away from ZEWINNA at the same time LILY LUELLA (T Johnstone) shifted in marginally on to RIGOLETTO (NZ) (K Sanderson), resulting in CAPITAL CHEVAL (B Muhcu) being crowded and having to check off the heels of SUNSET GUN. After hearing evidence from all riders, Stewards were unable to attribute the blame to any one rider.

RACE 6 – TASMANIAN BLOODSTOCK 3YO AUTUMN CLASSIC – (1400 METRES)

SANDUAL – Raced wide in the early and middles stages.

GUNSHIP – Underwent a post-race veterinary examination which revealed a high heart rate, slow recovery.

SIR JAG – Raced wide in the early and middles stages. Was carried up the track by WICKHAM LIGHT when it shifted out approaching the 250 metres.

WICKHAM LIGHT – Shifted ground out approaching the 250 metres carrying SIR JAG further up the track.

RIPPEN GOLD – Slow to begin.

RACE 7 – “IT’S WHY WE RACE” BM66 HCP – (1200 METRES)

GEE GEE MISS QUITA – Raced five-wide throughout.

RICH CLAN – Had a tendency to over-race in the early and middle stages.

FIGHTING FLOYD – Momentarily held up for a run to the inside of BANCA TOM at about the 200 metres.

PERIWINKLE – Underwent a post-race veterinary examination which revealed no obvious abnormalities.

ROHZHAE – Raced three-wide throughout.

GREY WHISPER (NZ) – Raced four-wide throughout.

NGAPALI BEACH – Underwent a pre-race veterinary examination after knocking out a cap and was passed fit to race.

RACE 8 – HAPPY MOTHER’S DAY! CLASS 1 HCP – (1100 METRES)

DYSART – Slow to begin.

BOKEO – Slow to begin.

FLYING BILLIE – Over-raced in the early and middle stages. Had to restrain off the heels of GEEGEECHASER. Underwent a post-race veterinary examination, no abnormalities were detected.

CORONATION KEELY was declared a late scratching at 10:18am on veterinary advice after the filly got her leg caught in a fence. Trainer S Cotton was advised a veterinary clearance would be required prior to racing again.

GEEGEECHASER – Jumped outwards at the start. Laid out and away from ARAYA SUNSHINE in the home straight resulting in BOKEO having to ease. Rider K Boxall reprimanded under AR131(a) for allowing her mount to shift out under pressure.

ARAYA SUNSHINE – Hung out under pressure in the home straight. Apprentice L Bingley reprimanded under AR131(a) for allowing her mount to shift out under pressure when not fully clear.
