RACE 1 – LADBROKE IT! MAIDEN – (1150 METRES)

BEERS ARE COLD – Beaten in excess of 20 lengths. A post-race Veterinary Examination failed to reveal any obvious abnormality.

AUNTY CONNIE (NZ) – Laid in under pressure entering the home straight.

DELAMERE – Raced three wide in the early and middle stages. Bumped and carried outwards entering the home straight.

GEEGEE STRAWBERRY – Caught wide in the early stages. Entering the home straight attempted a run to the outside of TWINKLEDUST where there was doubtful racing room. TWINKLE DUST then rolled out carrying GEEGEE STRAWBERRY out onto DELAMERE which was bumped and carried outwards. Apprentice K Boxall was reprimanded for careless riding under the provisions of AR 131(a) for attempting to take a run where there was insufficient racing room to do so.

LISPECTOR (NZ) – Over raced early and middle stages.

TWINKLEDUST – Laid out entering the home straight, tightening the running of GEEGEE STRAWBERRY which had attempted a run to its outside.

RACE 2 – KEVIN SHARKIE MAIDEN/CLASS 1 – (1880 METRES)

HAVLICEK – Over-raced in the early stages. A post-race Veterinary Examination failed to reveal any obvious abnormality.

MR ROUQUIN – Trainer Liandra Gray reported that the gelding had bled from 1 nostril and will now be retired. A post-race veterinary examination confirmed this report and MR ROUQUIN has been stood down to a 1000 metre gallop before being permitted to trial or race again. Trainer L Gray was advised of the requirements under the provisions of AR79.

SHAKEEDA – Stewards queried rider H Le Blanc in relation to the below market expectations. Rider H Le Blanc although disappointed with the mares performance was unable to offer any explanation. A post-race Veterinary Examination failed to reveal any obvious abnormality.

PINANDI – Checked at the start between runners.

RACE 3 – GOODSTONE GROUP MAIDEN – (1350 METRES)

ENSIGN EAGLE – Hard to load, a warning was continued. Over raced in the early stages and rider C Newitt reported the gelding hung in throughout. Hung in and brushed the running rail near the 200 metres. A post-race Veterinary Examination failed to reveal any obvious abnormality.

DIAMOND SUNRISE – Slow to begin. Held up for a clear run entering the home straight until shifting in to obtain clear running near the 200 metres.

PURPLE MOON – Stewards granted permission for rider M Ulucinar to ride 1/2kg over the allotted weight. Over-raced in the early stages.

HENLEY EXTREME – Declared a late scratching at 9.44am on veterinary advice after a confirmed telephone call from Trainer G Stevenson that the filly had an infection on its wither. Trainer G Stevenson was advised that a veterinary certificate would be required before racing again. On the announcement of correct weight Stewards ordered that all monies invested on HENLEY EXTREME be refunded, with the following deductions to apply to all successful wagers placed prior to 9.44am.

Stewards ordered that the following deductions would apply:

1st – KICKPASS	20c Win 15c Place
2nd – MISS PRIVATE	20c place
3rd – MISS VIVACE	19c place.

All monies bet after the withdrawal to be paid at face value of the tickets.

RACE 4 – TASMANIAN HORSE TRANSPORT CLASS 1 HANDICAP (1350 METRES)

GEEGEE'S CITY BOY – Had to steady off heels momentarily approaching the home turn.

BELLA TESORO – Commenced to over-race and had to be steadied off heels near the 1200 metres. Then continued to over-race in the early and middle stages until it compounded on the home turn to be beaten by 17 lengths. Rider K Boxall reported the mare resented the kick back from the track today. A post-race Veterinary Examination failed to reveal any obvious abnormality.

WHIZ BY – Raced three wide in the early and middle stages.

RACE 5 – THAI IMPERIAL BM60 HANDICAP – (1650 METERS)

COPPLESON (NZ) – Slow to begin, inclined to lay in over the concluding stages.

THREE'S A CROWD – Bumped with REWARD FOR ROSIE near the 100 metres.

FLIGHT READY – Raced three wide in the early stages.

REWARD FOR ROSIE – Compounded and bumped with THREES A CROWD near the 100 metres. When questioned rider C Newitt reported that the mare prefers to dictate the pace however he was unable to do so, he also stated that being second up over 1650 metres had found her wanting for fitness in this stage of her preparation and in his opinion would derive the benefit of the run.

RACE 6 – LENDING 4 U BM68 HANDICAP – (1150 METRES)

ELITE LEGACY – Jumped awkwardly and was then inconvenienced when THOROS OF MYR shifted out.

ETHICAL DILEMMA – Slow into stride.

INTISAR – Raced three wide.

THOROS OF MYR – Shifted out on jumping and bumped with ELITE LEGACY.

RACE 7 – THE STABLES AT SPREYTON 0 – 62 (1150 METRES)

GUNSHIP – Raced wide throughout.

POWER MAGNUM – Raced wide throughout. Carried out marginally approaching the winning post, in turn carrying out ALPINE AVIATOR which was making a run to its outside.

SUNSHINE MOSHE – Rider K Boxall reported her mount hung out throughout and made the 600 metre turn awkwardly and was short in its action. A post-race Veterinary Examination failed to reveal any obvious abnormality.

BARMAID GIRL – Raced wide throughout.

CHAMPAGNE CINDERS – Laid out approaching the winning post.

ALPINE AVIATOR – Held up from the 400 metres until the 250 metres and then carried out marginally over the concluding stages when POWER MAGNUM shifted out.

MR FREEZE – Over-raced in the early and middle stages and had to be restrained off heels approaching the 600 metre turn. Tightened and restrained approaching the winning post.

SHIM – Stewards granted permission for rider C Newitt to ride 1kg over the allotted weight. Carried out approaching the winning post and tightened the running of MR FREEZE which had to be restrained.

DASH IT – Tightened on jumping and slow to begin.

RACE 8 – WHAT THE FROTH BM76 HANDICAP – (1350 METRES)

SIR SIMON – Laid in under pressure in the home straight.

GEEGEE JET BY – Bumped with AND BEYOND near the 1200 metres and again approaching the winning post when ALPINE BLAST shifted out marginally.

ALPINE BLAST – ALPINE BLAST raced three wide throughout and bumped with GEEGEE JET BY near the winning post.

RACE 9 – TORQUE GEAR FOR GUYS BM64 HANDICAP – (1880 METRES)

SUGOI LEGEND – Jumped awkwardly and was caught wide in the early stages.

NAVAJO WARRIOR (NZ) – Declared a late scratching at 12.30pm acting on a confirmed phone call from trainer Leon Laskey advising that the gelding had injured itself on the float enroute to the track. Trainer L Laskey was advised that a veterinary certificate will be required prior to racing again. Stewards ordered that all monies invested be refunded in full with the following deductions. On the announcement of correct weight Stewards ordered that all monies invested on NAVAJO WARRIOR (NZ) be refunded, with the following deductions to apply to all successful wagers placed prior to 12.30PM.

Stewards ordered that the following deductions would apply:

1st – BRAZEN IMPACT 7c Win 7c Place
2nd – HELLOT 8c Place
3rd – WELDBOROUGH 8c Place

All monies bet after the withdrawal to be paid at face value of the tickets.

NOZTRABEEL – Connections advised that the gelding will now be retired.
