

### RACE 1 - LADBROKES IT! PACE - 2090m Mobile

MOVESLIKEALADY – Hung out after the start, continuing to do so until approaching the first turn where it shifted out markedly, locking wheels with MIKI SANZ resulting in both drivers being dislodged from their sulkies. Stewards deemed the performance of MOVESLIKEALADY outside the required standard and subsequently stood the filly down from racing until satisfactorily completing one barrier trial. MIKI SANZ raced driverless from the 1900 and was well picked up by the clerk-of-the-Course before the 1600.

General: Drivers J Walters and R Hillier were examined by Medical Edge staff and deemed fit to fulfill their remaining driving engagements for the evening.

General: MIKI SANZ and MOVESLIKEALADY were examined by the on-course Veterinarian. On examination both were found to have suffered no adverse effects from the incident.

# RACE 2 – FEHLBERGS PRODUCE 2YO COLTS & GELDINGS SWEEPSTAKES Heat 1 – 1609m Mobile

**STONE WRITER** – Broke gait racing into the first turn. Effectively taking no further part in the event. A post-race Veterinary examination found no abnormalities other than a scuff mark to its off-fore hoof.

General: Stewards questioned drivers D Ford (STONE WRITER) and R Ashwood (FLYING VINNIE) into the reason why STONE WRITER broke gait entering the first turn, also in attendance was P Ford the trainer's representative of STONE WRITER. Stewards after taking evidence from the drivers and on review of the official race footage charged driver Ashwood for causing interference to STONE WRITER. Stewards alleged, when crossing down to the marker line with FLYING VINNIE driver Ashwood was insufficiently clear of STONE WRITER. This incident resulted in contact to the off-fore leg of STONE WRITER causing it to break gait. Driver Ashwood pled guilty to the charge. Stewards, after taking into consideration the incident occurred racing into the first turn, the status of the race, that being a heat of a 2YO sweepstake and therefore qualification for the final, suspended driver Ashwood's licence to drive for four(4) Tasmanian Race Meeting Dates, Making driver Ashwood eligible to recommence driving on Monday September 9th, 2024 [AHR Rule 163(1)(a)(iii)].

## RACE 3 – FEHLBERGS PRODUCE 2YO FILLIES SWEEPSTAKES Heat 1 – 1609m Mobile

*General*: The start of this race was delayed approximately two(2) minutes due to the need for a sulky change on PHLOW JO and broken gear on ITSMENOTU.

**PHLOW JO** – First registered race start. Will be excluded from the barrier draw in mobile start events after breaking gait shortly after the start was effected.

**EBONYS POSTER** – Placed on its last chance to race truly after breaking gait free of interference approaching the 600.

**LILAC** – First registered race start.

General: Driver D Ford was reprimanded for shifting ground on entering the home straight for the run to the finish, resulting in the final marker being struck before entering the sprint lane [AHR Rule 163(1)(c)(ii)].

General: Following a report from Office of Racing Integrity (ORI) Stipendiary Steward Ms T Canham, trainer K Rattray was instructed to not use the burr that he had attached to the lugging pole on ARK MELODY again until the burr in dulled.

### RACE 4 - TASMANIAN HORSE TRANSPORT PACE - 1609m Mobile

**COVEFFE HUSTLER** – Placed on its last chance to race competitively after giving ground over the concluding stages, beaten in excess of 90 metres. Stewards in assessing were mindful of the winner's

performance against that of COVEFFE HUSTLER. A post-race Veterinary examination failed to detect any abnormalities.

### RACE 5 - PRYDES EASIFEED PACE - 2090m Mobile

**FIVEFORTY** - Will be excluded from the barrier draw in mobile start events after breaking gait shortly after the start was effected.

**SAPPHIRE GAMBLER** – Completed the event with a flat near-side tyre.

### RACE 6 - MORE CONFIDENCE CONSULTING PACE - 2090m Mobile

**SPACEWRITER** – Had difficulty in securing clear running over the concluding stages.

**DEADLY ASSISSIN** – Utilised the sprint lane in the run to the finish.
