# Comments / Explanations:

Rider L Annells was indisposed due to illness for this meeting. Rider L Annells was advised that she must provide a medical clearance prior to riding again.

### RACE 1 – #GOTTALUVTASSIERACING MAIDEN – 1150 METRES

**KITH AND KIM –** Slow to begin.

**UPWARD AND ONWARD –** Bounded on jumping and slow into stride.

**ELLISPHERE** – Raced greenly in the early and middle stages.

**LIGHTMEUPJAZZ** – Carried wider on the track approaching the 600 metres when SH'BOURNE GLORY laid out despite the efforts of rider A Darmanin.

**SH'BOURNE GLORY** –Tightened and bumped with TWICE THE ICE on two occasions approaching the 600 metres when SH'BOURNE GLORY shifted out.

**SKY LAND** – Stewards granted permission for rider C Newitt to ride 1kg over the allotted minimum weight. Shifted in on jumping and tightened the running of NO MORE ROCKS.

**TWICE THE ICE** – Bumped and became unbalanced near the 600 meters when LIGHTMEUPJAZZ was carried wider on the track.

### RACE 2 – KEVIN SHARKIE MAIDEN – 1350 METRES

**GEEGEES ROYAL DUKE -** Reared on jumping and was slow to begin.

**MOOMBAH FLYER –** Over-raced in the early and middle stages.

**NOTORIOUS OUTLAW –** Slow to begin.

**ONE STAR DREAM –** Passed a pre-race veterinary examination after examining a wound on the left hind coronet. Slow to begin, laid in under pressure in the home straight.

**DIAMOND SUNRISE** – Declared a late scratching on veterinary advice at 10.50am due to swelling in the near foreleg. Trainer P Luttrell was advised a veterinary clearance would be required prior to the mare racing again. On the announcement of correct weight Stewards ordered that all monies invested on DIAMOND SUNRISE be refunded, with the following deductions to apply to successful wagers placed prior to 10.50am.

Stewards ordered that the following deductions would apply:

1st - 9	CORSA VELOCE	4 cents win, 4 cents place.
2nd - 7	THE PRAYER	4 cents place.
3rd - 4	ONE STAR DREAM	8 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

**THE PRAYER** – Shifted out under pressure in the home straight and then shifted in and crossed GEEGEES ROYAL DUKE when not quite clear. Rider A Darmanin was reminded of his obligations when shifting ground.

**MONCLERE** – Shifted out on jumping crowding Night Invader. Rider D Pires reported that his mount did not handle the track conditions today.

**NIGHT INVADER –** Crowded on jumping and lost ground. Obliged to shift outward to obtain clear running near the 150 metres.

#### RACE 3 – THAI IMPERIAL BENCHMARK 60 HANDICAP – 1350 METRES

**EXALTED CROWN –** Over-raced in the middle stages and caught wide throughout.

**LORD WHITEGATE** – Raced wide throughout.

PASHEONA - Bumped near the 200 metres with RODRICK'S SECRET.

**SHARE THE GOLD –** Compounded from the 700 metres. Rider C Newitt reported that he felt something amiss with gelding's action. A post-race veterinary examination revealed an elevated heart rate and slow recovery.

**RODRICK'S SECRET –** Bumped near the 200 metres.

### RACE 4 - TORQUE GEAR FOR GUYS OPEN HANDICAP - 1350 METRES

**GENERAL ASSEMBLY –** Steadied passing the 1200 metres.

**FAKE MAGIC –** Carried to a three wide position leaving the 1200 metres.

**ETHICAL DILEMMA –** Steadied off the heels of GENERAL ASSEMBLY near the 1200 metres and rolled out.

### RACE 5 – THE STABLES AT SPREYTON BENCHMARK 68 HANDICAP – 1650 METRES

**MYWORDIS** – Shifted wider to obtain clear running near the 200 metres.

**ZULU ANGEL** – Clipped heels and blundered shortly after the start when CHI MAZEL shifted in and carried it onto the heels of ALWAYS A WINNER.

**CHI MAZEL –** Shifted in passing the 400 metres and bumped with MYWORDIS.

**METAVERSE** – Shifted three wide approaching the 600 metres.

**COPPLESON (NZ) –** When questioned on the below market expectation performance rider A Darmanin stated that his mount after being slow to begin raced at the tail of the fields and did not travel well at any stage. A post-race veterinary examination revealed no obvious abnormalities.

### RACE 6 - LADBROKES EASY FORM CLASS 1 HANDICAP - 1150 METRES

**DYSART –** Began very awkwardly and slow to begin.

**BLUFF POINT –** Jumped awkwardly.

**BLOOMTIME** – Shifted out approaching the 200 metres when not fully clear of Bluff Point. Rider A Darmanin was advised to ensure he is fully clear when shifting ground.

**GIE IT LALDY –** Slow to begin.

**SKY EAGLE –** Raced three wide in the early and middle stages.

### RACE 7 – TASMANIAN HORSE TRANSPORT BENCHMARK 60 HANDICAP – 1150 METRES

**CORNELIAN BAY –** Rider D Ganderton was reminded of his obligation to ride his mount out fully to the finish of the race. In not taking more severe action the Stewards were of the opinion that the result of the race had not been affected.

**FLIGHT READY –** Laid in entering the home straight.

# RACE 8 – GOODSTONE GROUP CLASS 1 HANDICAP – (1650 METRES)

**EARENDEL** – Declared a late scratching at 5.33pm on veterinary advice after rearing in the gates and striking its head. Trainer B Campbell was advised the gelding must trial satisfactorily on one occasion prior to racing again. On the announcement of correct weight Stewards ordered that all monies invested on EARENDEL be refunded, with the following deductions to apply to successful wagers placed prior to 5.33pm.

Stewards ordered that the following deductions would apply:

1st - 9	GODDESS OF ROCK	7 cents win, 13 cents place.
2nd - 11	LAUNNIE NIGHTS	8 cents place.
3rd - 3	ROWING POWER	9 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

**RALPH THE ROCKET –** Bumped entering the home straight when SIR TOROBEEL was carried outward by PINANDI shifting outwards.

**SIR TOROBEEL –** Caught wide throughout and carried wider entering the home straight and bumped with RALPH THE ROCKET.

**PINANDI –** Shifted out around LINDRUM to obtain clear running and carried SIR TOROBEEL wider on the track which then bumped with RALPH THE ROCKET.

**GODDESS OF ROCK** – Stewards queried trainer J Keys in relation to the improved performance of the mare. Trainer J Keys stated that he has a high opinion of the mare and the addition of blinkers for the first time today assisted in its performance.

**KNOT DANCING** – Underwent a pre-race veterinary inspection after suffering minor abrasions enroute to the course and was passed fit to compete. Steadied off heels entering the home straight when RALPH THE ROCKET shifted in and SIR TOROBEEL was carried outwards. A post-race veterinary examination revealed no obvious abnormalities.

**LAUNNIE NIGHTS** – Stewards granted permission for rider A Darmanin to ride 1/2kg of the allotted minimum weight.

**LINDRUM** – Stewards granted permission for rider C Jordan to ride 1/2kg over the allotted minimum weight.
