Comments / Explanations:

RACE 1 – BOOK INTO JACKSON SECURITY NEWMARKET NIGHT 27 NOV MAIDEN (1200 METRES)

CHRISTOPHER ROBIN – Over raced early stages.

MILTON – Declared a late scratching on veterinary advice at 1.45pm due to a stone bruise. Trainer S Cotton was advised a veterinary clearance would be required prior to the gelding racing again. On the announcement of correct weight Stewards ordered that all monies invested on MILTON be refunded, with the following deductions to apply to successful wagers placed prior to 1.45pm.

Stewards ordered that the following deductions would apply:

1st - 10	ESPIRIT DIVA	16 cents win, 13 cents place.
2nd - 1	BUNKER BOB	14 cents place.
3rd - 2	CHRISTOPHER ROBIN	15 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

NEED A GIGGLE – Raced wide middle stages.

NOTORIOUS OUTLAW – Slow to begin, over-raced early stages.

STAR WALKIN' – Slow to muster early speed.

COUNTESS ELECTRIC – Slow to muster early speed.

GEE GEE DARE – Over raced early stages.

HOTAPPLEPIE – Raced wide middle stages of the event.

PONSFORD – Tightened for room over the concluding stages when NEED A GIGGLE shifted in.

Rider C Van Muster (HOTAPPLEPIE) was harmlessly dislodged from her mount on pulling up. Rider C Van Munster was examined by medical staff and cleared to fulfill her riding engagements.

RACE 2 - CUP EVE CALCUTTA - SPORTIES HOTEL FEB 25 MAIDEN - (1400 METRES)

FOREIGN LEGION – Jumped inwards at the start and bumped with KAGISO then placing KAGISO in restricted racing room.

GEEGEES ROYAL DUKE – Over-raced early stages.

RIPPEN GOLD – Raced erratically in the early stages. Eased down at about the 800 metres. A post-race veterinary examination failed to reveal any obvious abnormalities. Trainer D Tyson was advised that the gelding has been stood down to two consecutive trials and a veterinary certificate prior to trialling.

BELLE PRETORIA – Slow to begin and over raced early stages.

DIAMOND SUNRISE – Declared a late scratching at 3.14pm due to no suitable rider available. On the announcement of correct weight Stewards ordered that all monies invested on DIAMOND

SUNRISE be refunded, with the following deductions to apply to successful wagers placed prior to 13.14pm.

Stewards ordered that the following deductions would apply:

1st	- 9	LOVE NEST	2 cents win, 3 cents place.
2nd	- 1	FOREIGN LEGION	3 cents place.
3rd	- 2	GEEGEES ROYAL DUKE	3 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

LADY SARAH – Slow to muster early speed.

LIGHTMEUPJAZZ – A post-race veterinary examination revealed no significant findings.

LOVE NEST – Slow to muster early speed, tightened and lost its position near the 1200 metres.

PHERE THE GIRLS – Over raced early stages.

STEEL RAIDER – Bumped with TWICE THE ICE at the start, raced wide throughout.

TWICE THE ICE – Bumped with STEEL RAIDER at the start. A post-race veterinary examination revealed no significant findings.

KAGISO – Bumped by FOREIGN REGION and placed in restricted racing room at the start. A post-race veterinary examination revealed no significant findings.

Rider A Malik (BELLE PRETORIA) was found guilty of a charge of careless riding under the provisions of AR131(a), in that near the 1200 metres, he permitted his mount to shift in when not sufficiently clear of LOVE NEST (J Radley) which was taken off its course, tightened for room resulting in him taking hold, easing and losing his rightful position. Rider A Malik's licence to ride in races was suspended for one Tasmanian race date. In assessing penalty stewards took into account his riding record under this rule, the circumstances of the event and that the interference was in the mid-range. Rider A Malik was advised of his right of appeal.

RACE 3 – LADBROKES 3YO MAIDEN – (1100 METRES)

ARTILLERY FIRE – Fractious in barriers prior to the start, bounded out at the start. Stewards queried rider D Pires in relation to the below market expectations. Rider D Pires stated that the filly. was fractious in the barriers prior to the start and raced greenly throughout. Raced wide throughout. A post-race veterinary examination revealed no significant findings.

MASTRETTA – Fractious in barriers prior to start.

POETIC LIGHT – Re-shod behind barriers and under-went a pre-race veterinary examination and was passed suitable to race. Slow to muster early speed. A post-race veterinary examination revealed no significant findings.

SKY LAND – A post-race veterinary examination revealed no significant findings.

WILD NIGHTS – Began awkwardly.

RACE 4 - CONGRATS MIKE MORRIS TTC HALL OF FAME INDUCTEE BENCHMARK 68 HANDICAP - (1400 METRES)

FAKE MAGIC – Shifted out under pressure in the home straight.

CHARLIE BUCKET – Restrained off heels at about the 1200 metres, shifted out under pressure in the home straight.

FIGHTING FLOYD – Slow to begin, restrained off heels at about the 1200 metres.

DAYAN STAR – Slow to begin.

Rider J Radley (FAKE MAGIC) pleaded guilty to a charge of careless riding under the provisions of AR131(a), in that approaching the 1200 metres, he permitted his mount to shift in when not sufficiently clear of CHARLIE BUCKET (C Wells (a)) resulting in its rider restraining off heels and FIGHTING FLOYD (E Byrne Burke) which was following then also having to steady off the heels of CHARLIE BUCKET. Senior rider C Newitt assisted J Radley (a) during the inquiry. Rider J Radley's licence to ride in races was suspended for one Tasmanian race date. In assessing penalty stewards took into account his riding record under this rule, the circumstances of the event and that the interference was in the mid-range. Rider J Radley was advised of his right of appeal.

RACE 5 – PORTERHOUSE & POT THURSDAY NIGHTS SPORTIES HOTEL MAIDEN/CLASS 1 – (1600 METRES)

DYNAMIC DEEL – Jumped inwards at the start and bumped with ALPINE TROUT.

GOOD LUCK BOB – Restrained off heels shortly after the start.

KING KURT – Raced wide throughout with cover.

LAUNNIE NIGHTS – Began awkwardly and shifted inwards shortly after the start, over raced early and middle stages, held up entering the home straight. Shifted out under pressure over the concluding stages.

ROWING POWER – Restrained off heels of LAUNNIE NIGHTS at about the 800 metres. Held up for clear racing room round the home turn and checked off the heels of LAUNNIE NIGHTS which had commenced to over race and shifted out marginally. Held up till about the 200 metres and then shifted wider to obtain a clear run.

ALPINE TROUT – Bumped at the start with DYNAMIC DEEL.

KITH AND KIN – Resaddled behind the barriers prior to the start, slow to muster early speed. A post-race veterinary examination revealed no significant findings.

PINANDI – Restrained after the start to obtain a rune closer to the rails.

MISS PEBBLES – Raced wide throughout with cover.

OUTERTHISWORLD – Over raced throughout.

UPWARD AND ONWARD – Raced wide throughout.

Correct weight was delayed for rider A Darmanin and the connections of ROWING POWER to view the official patrol films in relation to lodging an objection against the winner LAUNNIE NIGHTS (J Radley). After viewing the video patrol footage correct weight was declared on the judges' numbers.

Stewards inquired into the tactics adopted by rider J Radley(a) (LAUNNIE NIGHTS) In particular incidents involving ROWING POWER (A Darmanin). Rider J Radley was assisted in the inquiry by

Senior rider C Newitt. After viewing the official patrol films rider J Radley was advised that he must ensure he gives his fellow riders the room that they are entitled to and that when riding his mount out that he must endeavour to keep a straight line, rather than shifting in and out attempting to place his mount in a positive position and then placing himself awkwardly on the heels of runners in front, which then required him restraining and placing runners behind in an awkward position.

RACE 6 – THANK YOU GEOFF FROM SPORTIES HOTEL BENCHMARK 60 HANDICAP – (1600 METRES)

VINTAGE DIESEL (NZ) – Raced wide throughout, restrained momentarily off heels at about the 1200 metres.

LORD WHITEGATE – Over-raced early and middles stages of the race.

MOORBOOZIE – Began awkwardly, restrained after the start to obtain a position closer to the rails from the wide barrier.

BANCA GLEE – Re-saddled behind the barriers prior to the start.

THREE'S A CROWD – Threw its head in the air on jumping and shifted out bumping with I'M KEEFE.

STEEL MIST – Stewards queried rider C Van Munster in relation to shifting wider on the track entering the home straight. Rider C Van Munster stated that she believed the firmer ground to be out wider when she felt her mount started to tire. Stewards noted her explanation.

RACE 7 - VALE LEON HESKETH TTC MEMBER BENCHMARK 76 HANDICAP - (2100 METRES)

ZULU ANGEL – Slow to begin, over raced early and middle stages.

CHI MAZEL – Over raced early and middles stages. A post-race veterinary examination revealed no significant findings.

PAGE – Restrained off heels of GOLDEN PROPHET approaching the home turn.

RACE 8 - THANK YOU KRISTIE FROM SPORTIES HOTEL BENCHMARK 68 HANDICAP - (1200 METRES)

FURNEAUX – Began awkwardly, shifted out and bumped with NEEDS SUGAR. Over raced early stages.

MAKE A DECISION – Over raced early.

NEEDS SUGAR – Began awkwardly and bumped with FURNEAUX.

SAXON MIST – Stewards granted permission for rider A Darmanin to ride 1/2kg over the allotted weight.

Rider J Radley (WINCHESTER RIFLE) was found guilty of a charge of careless riding under the provisions of AR131(a), in that near the 1000 metres, he permitted his mount to shift in when not sufficiently clear of MAKE A DECISION (D Ganderton) which was taken off its course, tightened for room resulting in him taking hold, easing and losing his rightful position. Rider J Radley's licence to ride in races was suspended for one Tasmanian race date. Senior rider C Newitt assisted J Radley (a) during the inquiry. In assessing penalty stewards took into account his riding

record under this rule, the circumstances of the event and that the interference was in the midrange. Rider J Radley was advised of his right of appeal.

RACE 9 - PINT & PARMI MONDAY NIGHTS SPORTIES NHOTEL CLASS 1 HANDICAP - (1100 METRES)

KENSINGTON DIVA – Threw its head in the air and shifted out at the start, slow to muster early speed.

BLONDE STAR – Slow to begin.

BATCHY BULLET – A post-race veterinary examination revealed no significant findings.

WHEELING – Stewards granted permission for rider A Darmanin to ride 1/2kg over the allotted minimum weight.

CLARA KAREN – Stewards granted permission for rider A Malik to ride 1/2kg over the allotted minimum weight.
