# Comments / Explanations:

# RACE 1 – SALTERS HIRE FOR CORPORATE FUNCTIONS MAIDEN (1600 METRES)

**IRISH STORM –** Shifted in on jumping tightening FIRE UP RUBY.

**TIDEFORD (NZ)** – Raced three wide throughout, rider K Sanderson reported that his mount did not handle today's track conditions. A post-race veterinary examination revealed swelling to the off fore canon and the gelding has been stood down to a veterinary certificate of soundness.

**WARDLAW** – Shifted in after the start tightening the run of IRISH STORM.

**FIRE UP RUBY –** Shifted out on jumping bumping with IRISH STORM, over-raced in the early stages.

**MISS PRIVATE –** Raced wide in the early and middle stages.

**SPEEDYPIN –** Restrained after the start to obtain a position closer to the rail.

**THE PRAYER –** Rider A Darmanin was cautioned on his celebratory gesture prior to the line.

**LYCO RECO** – Stewards granted permission for rider A Malik to ride 1kg over the allotted minimum weight. Hung in entering the home straight.

**NIGHT INVADER –** Held up for clear running from the 400 metres to the 250 metres.

# RACE 2 – SALTERS HIRE FOR PERTIES CLASS 1 HANDICAP – (1400 METRES)

**PRIVATE STORM** – Declared a late scratching at 3.05pm due to no available rider. On the announcement of correct weight Stewards ordered that all monies invested on PRIVATE STORM be refunded, with the following deductions to apply to successful wagers placed prior to 3.05pm.

Stewards ordered that the following deductions would apply:

1st - 4	MANDATE	31 cents win, 26 cents place.
2nd - 1	THONATUS	26 cents place.
3rd - 14	SYRUP	26 cents place.

All monies bet after the withdrawal to be paid at face value of the tickets.

**DYSART –** Over-raced in the early stages, laid in, in the home straight.

**PROPHET EYES –** Raced wide throughout.

**LET'S MESSAROUND –** Slow to muster early speed, raced greenly throughout and carried wider near the 400 metres when Bounty Bay shifted wider.

**VANITY STAR –** Stewards granted permission for rider A Malik to ride 1/2kg over the allotted weight. Began awkwardly and was slow to begin.

**SYRUP –** Three wide early, steadied momentarily approaching the winning post when THONATUS rolled in despite the efforts of its rider.

**BOUNTY BAY –** Stewards granted permission for rider A Darmanin to ride 1/2kg over the allotted weight. Shifted out near the 400 metres and carried LET'S MESSAROUND wider. Rider A Darmanin was reprimanded for Careless Riding AR 131(a) for shifting out when not clear to do so.

# RACE 3 – SALTERS HIRE FOR EVENTS CLASs 3 HANDICAP (1200 Metres)

**DURAZZO –** Shifted out marginally bumping with CONUMDRUM passing the 800 metres.

**CONUMDRUM** – Passed pre-race veterinary examination after suffering a small graze on its off fore knee enroute to the course. Began awkwardly, shifting out and bumping with ISLAND WARRIOR.

**ISLAND WARRIOR** – Bumped with CONUMDRUM at the start. Three wide throughout. Rider allowed his mount to shift in at about the 900 metres.

**RUBBLEONTHEDOUBLE –** Bumped with ARAYA SUNSHINE at the start. Tightened from the 900 metres until about the 800 metres and commenced to over-race. Restrained off heels of CONUMDRUM at about the 800 metres.

**ARAYA SUNSHINE** – Bumped with RUBBLEONTHE DOUBLE at the start. Tightened for racing room from about the 900 metres by RUBBLEONTHEDOUBLE which was receiving pressure from its outside.

Rider J Radley was found guilty of a charge under the provisions of AR131(a) careless riding. Particulars being that he allowed his mount to shift in commencing at about the 900 metres to the 800 metres placing RUBBLEONTHEDOUBLE in restricted racing room, resulting in ARAYA SUNSHINE and RUBBLEONTHE DOUBLE being buffeted and unbalanced for some distance. In considering penalty stewards took into account his record under this rule and the level of carelessness. Rider J Radley was advised of his right of appeal.

#### RACE 4 – SALTERS HIRE PROUD SUPPORTERS OF THE TTC MAIDEN (COLTS & GELDINGS) (1100 METRES)

**ARCADE BOY –** Steadied off heels at about the 400 metres.

**GUBER –** Raced wide throughout.

**NICALBI –** Declared a late scratching at 7.43pm when unable to be loaded. On the announcement of correct weight Stewards ordered that all monies invested on NICALBI be refunded, with the following deductions to apply to successful wagers placed prior to 7.43pm. Trainer I & N Hay was advised that the gelding must complete a satisfactory trial prior to racing again.

Stewards ordered that the following deductions would apply:

1st - 4	RICH GLOW	0 cents win, 1 cents place.
2nd - 7	HALEN	3 cents place.
3rd - 9	SAY IT WITH WORDS	1 cents place.

All monies bet after the withdrawal to be paid at face value of the tickets.

**SAY IT WITH WORDS –** Contacted the running rail at about the 500 metres.

**SUREFIRE LOVER –** Began awkwardly, restrained off heels of ARCADE BOY entering the home straight.

**ENUFF BREAKERS –** Over raced early and middle stages, raced three wide throughout.

**STREETS AHEAD –** Buffeted near 500 metres when ENUFF BREAKERS laid in and SUREFIRE LOVER laid out.

#### RACE 5 – SALTERS HIRE FOR WEDDINGS MAIDEN (FILLIES & MARES - (1100 METRES)

**DIAMOND SUNRISE –** Tightened for room soon after the start and was restrained by its rider.

**DIESEL'S SUNSHINE** – Shifted in near the 800 metres when not fully clear of GEE GEES RUN OUT. Rider A MALIK was advised to exercise far greater care and ensure when crossing to the lead that he is fully clear to do so.

**GEE GEES RUN OUT –** Tightened and steadied near the 800 metres.

**MISS TANZANITE –** Shifted in over the concluding stages and tightened the running of ROLLING IN IT.

**PUZZLE MISS –** Bounded out at the start and was slow to begin.

**ZULU FIELDS –** Raced wide throughout.

**ROLLING IN IT –** Fractious in barriers prior to start, hung out home turn, momentarily steadied near the 100 metres when MISS TANZANITE shifted in.

# RACE 6 – SALTERS HIRE FOR MARQUEE HIRE BENCHMARK 60 HANDICAP – (1100 METRES)

**BLOOMTIME –** Raced three wide from the 800 metres.

**CAPABELLE –** Reared on jumping dislodging rider H Le Blanc. The on-course doctor and Medical Edge staff examined rider H Le Blanc. Rider H Le Blanc was passed fit to fulfill her riding engagements.

**MR FREEZE –** Over raced early and middle stages, raced three wide from the 800 metres.

**TARKINE EAGLE –** Trainer J Blacker advised a change of tactics for the gelding to be ridden further back, circumstances permitting. Tactics adopted. Raced three wide throughout.

# RACE 7 – SALTERS HIRE FOR FESTIVALS BENCHMARK 60 HANDICAP (1400 METRES)

**LORDOSIS** – Held up for clear running entering the home straight.

**HOT RELATION –** Raced three wide throughout.

**WINNING WITNESS –** Restrained off heels shortly after the start. Held up from the home turn until the 200 metres.

FAST THINKER – Shifted in near the 1200 metres tightened the running of WINCHESTER RIFLE.

WINCHESTER RIFLE - Shifted in near the 900 metres when not fully clear of FAST THINKER.

# RACE 8 – LADBROKES BENCHMARK 68 HANDICAP – (1600 METRES)

**GENERAL ASSEMBLY –** Crossed BLONDE SUSPECT near the 1500 metres when not quite clear. Rider J Booth was advised to exercise more care when shifting ground. Over raced early and middle stages. Disappointed for a run to the inside of KING ISLAND rounding the home turn and again over the final 50 metres.

**PENNINE –** Over raced early.

**BLONDE SUSPECT –** Restrained near the 1500 metres when being crossed by GENERAL ASSEMBLY. Trainer J Blacker advised a change of tactics and that they will attempt have the gelding ridden further forward circumstances permitting. Over raced early and middle stages.

THE SPIRIT OF ZERO – Over raced early.

**COUP DE SPRY** – Bumped with EMMJAY (NZ) at the start.

EMMJAY (NZ) – Shifted out at the start and bumped with COUP DE SPRY. Over raced early stages.
