### *Comments / Explanations:*

#### **RACE 1 – ROCKJAW TOURS “ITS WHY WE RACE” 3YO MAIDEN – (1200 METRES)**

**GEEGEE'S DOWNPOUR** – Stewards queried rider A Darmanin in relation to the tactics adopted and what his riding instructions were and his vigour in the home straight. Rider A Darmanin stated his instructions were to keep the horse on the bridle as it was still very green. And that around the home turn he was held up for clear racing room and when straightening he was reluctant to take a run between BROADMARSH and MAJESTIC MOLLY when MAJESTIC MOLLY commenced to shift in and then BROADMARSH started to shift ground out making it even more difficult for him to improve. Stewards noted A Darmanin's explanation.

**HALEN** – Raced three wide early.

**HOTAPPLEPIE** – Shifted out soon after the start away from SAY IT WITH WORDS which had rolled out marginally and bumped heavily with BILLIE THE GREAT which in turn was carried out onto MAJESTIC MOLLY. MAJESTIC MOLLY then bumped heavily with BROADMARSH.

**BILLIE THE GOAT** – Bumped heavily with HOTAPPLEPIE soon after the start and unbalanced the rider.

**BROADMARSH** – Trainer W McShane was advised a warning has been placed on the loading manners of the filly due to being difficult to load. Bumped heavily with MAJESTIC MOLLY soon after the start and then checked off the heels of HALEN.

**MAJESTIC MOLLY** – Bumped heavily HOTAPPLEPIE and carried out onto MAJESTIC MOLLY. soon after the start, over raced in the early stages of the event.

**POETIC LIGHT** – Slow to begin and raced three wide throughout. Carried wider near the 800 metres when BILLIE THE GREAT hung out.

### **RACE 2 – FLINDERS ISLAND CABIN PARK” HIDDEN ZEBRA” MAIDEN – (1400 METRES)**

**SCARLETTI** – Jumped awkwardly and struck the inside barrier partition.

**LIGHTMEUPJAZZ** – Held up for a clear run from the home turn until the 150 metres.

**VANSITTART** – Raced three wide throughout. Rider H Le Blanc was advised to exercise more care when shifting ground near the 800 metres when she crossed the running of GEEGEES ROYAL DUKE when not fully clear. Bumped with TUSKEGEE on the home turn.

**TUSKAGEE** – Stewards granted permission for rider K Sanderson to ride 1/2kg over the allotted weight. Laid in at about the 800 metre turn, bumped with VANSITTART on the home turn.

### **RACE 3 – NUTRIEN AG SOLUTIONS “STAR CHEERS” MAIDEN/CLASS 1 – (1600 METRES)**

**GOOD LUCK BOB** – Slow to begin. A post-race veterinary examination failed to reveal any obvious abnormalities.

**SUN HALO** – Slow to begin. Held up for a clear run entering the home straight.

**ALPINE TROUT** – Began awkwardly.

**EMMJAY** – Over-raced in the early and middle stages and raced wide throughout.

**THE PRAYER** – Slow to begin.

**UPWARD AND ONWARD** – Blundered on jumping.

### **RACE 4 – WHITEMARK POST OFFICE / CUTHILL FAMILY “DON’T SLIP THROUGH THE NET” CLASS 1 HANDICAP – (1400 METRES)**

**SH’BOURNE MIDNIGHT** – Commenced to over-race passing the 600 metres and shifted out to race three wide. Shifted in under pressure over the concluding stages and bumped with CORSA VELOCE after the finish. A Darmanin was advised to exercise more care when shifting ground.

**LOVE NEST** – Lost a near fore plate during the event.

**SYRUP** – Under-went a pre-race veterinary examination for a superficial graze to the girth on the off side and was cleared to race.

**GEE GEES CHORIS** – Slow to begin.

## **RACE 5 – 1808 A RUM BAR & COCKTAIL LAOUNGE 0 – 60 RATING (1400 METRES)**

**FAST THINKER** – Rider L Bingley was reprimanded under the provisions of AR132(7)(a)(i) for using her whip on consecutive strides on two occasions prior to the 100 metres. Stewards noted that this was rider L Bingley's first offence under this rule.

**FLIGHT READY** – Over-raced in the early stages and elected to shift out from the 1000 metres and raced wide thereafter.

## **RACE 6 – INTERSTATE HOTEL FLINDERS ISLAND CUP (1600 METRES)**

**GENERAL ASSEMBLY** – Shifted out on jumping and bumped with BLONDE SUSPECT.

**PENNINE** – The farrier attended to a loose shoe prior to the start of this race and a pre-race veterinary examination passed the gelding suitable to start. Over-raced in the early stages. Rider T Baker reported that his mount felt amiss in its action. A post-race-veterinary examination revealed no obvious abnormalities.

**FIGHTING FLOYD** – Carried in soon after the start and bumped with BLONDE SUSPECT.

**BLONDE SUSPECT** – Stewards granted permission for rider D Pires to ride 1/2kg over the allotted weight. Lost its position shortly after the start when GENERAL ASSEMBLY shifted out and FIGHTING FLOYD was carried in by CARNEROS which had laid in despite the efforts of its rider.

**CARNEROS** – Stewards granted permission for rider A Darmanin to ride 1/2kg over the allotted weight.

## **RACE 7 – GLASS WARRIOR AMBASSADOR FOR NETS PLATE BM68 HANDICAP (1200 METRES)**

**BETTER THAN BANKSY** – Over-raced in the middle stages.

**PEACE BE UPON HIM** – Slow to begin. Bumped with ISLAND WARRIOR on several occasions from the 600 metres to the 400 metres.

**THELMA** – Bumped with RED SPHERE on jumping.

**ISLAND WARRIOR** – Bumped with PEACE BE UPON HIM on several occasions from the 600 metres to the 400 metres. A post-race veterinary examination revealed a minor abrasion to the near hind leg.

**RED SPHERE** – Bumped with THELMA on jumping

## **RACE 8 – KILLARA "ISLAND WARRIOR" VASE BM68 HANDICAP – (1400 METRES)**

Correct weight was delayed enabling rider K Sanderson (DAYAN STAR), 2nd placegetter to view the Stewards' official patrol footage before deciding not to lodge an objection. Correct weight was then declared on the judge's numbers.

**DAYAN STAR** – Rider K Sanderson and connections viewed the film in the home straight prior to correct weight, however was satisfied and correct weight was given.

**HOT RELATION** – Declared a late scratching at 5.12pm on veterinary advice due to being lame in the near foreleg. On the announcement of correct weight Stewards ordered that all monies invested

on HOT RELATION be refunded, with the following deductions to apply to successful wagers placed prior to 5.12pm. Trainer Y Nishitani was advised a veterinary clearance would be required prior to trialling or racing again.

Stewards ordered that the following deductions would apply:

1<sup>st</sup> - 1 - FAKE MAGIC                      10 cents win, 11 cents place.  
 2<sup>nd</sup> - 3 - DAYAN STAR                      9 cents place.  
 3<sup>rd</sup> - 2 - GEE GEE ENUF SPEED                      No Third Dividend

All monies bet after the withdrawal to be paid at face value of the tickets.

**OLE OLA** – Over-raced throughout and hung out on the home turn. A post-race veterinary examination failed to reveal any obvious abnormalities.

## ADDENDUM

TASMANIAN RACING CLUB 29<sup>TH</sup> JULY, 2024

Stewards inquired into an incident that took place in the scales area which had been reported by the Clerk of Scales, Ms C Brydon. After taking evidence from stable hand Ms L Blacker and

Apprentice Jockey, Mr J Radley stewards issued reprimands under the provisions of AR228(b) Misconduct to both licensed participants. In not taking further action stewards were mindful that this was the first time that both participants had offended under this rule. Both were reminded to be respectful when dealing with matters in front of other participants.

Stablehand/trackwork rider B Woodsford pleaded guilty to a charge under the provisions of AR 123(1) for failing to wear a safety vest whilst mounted on a horse doing trackwork on the 18<sup>th</sup> October, 2024. Mr B Woodsford was fined the sum of \$200. Stewards also confiscated a whip that Mr Woodsford had repaired and was not up to standard.
