Trainer S Gandy was fined the sum \$50 under the provisions of LR13.3 for the late rider declaration of GEEGEE STRAWBERRY in Race 1.

Trainer J Blacker was fined the sum of \$50 under the provisions of LR13.3 for the late rider declaration of INDISPENSABLE in Race 5.

Comments / Explanations:

RACE 1 – HYPE TV MAIDEN – (1100 METRES)

NOTORIOUS OUTLAW – Compounded over the final 200 metres. A post-race veterinary examination revealed a high heart-rate, slow post-race recovery.

POWER GENERATOR – Bumped with GEEGEES DOWNPOUR rounding the 400-metre mark.

GEEGEES DOWNPOUR – Raced greenly throughout.

DIESEL'S SUNSHINE – Raced three-wide throughout.

STEEL RAIDER – Re-saddled behind the barriers prior to the start. Momentarily held up rounding the home turn, shifting wide to obtain clear running.

YOU BETTER RUN – Trainer J Bazan advised stewards on a change of tactics. And that the mare would be ridden further back with cover, circumstances permitting. Tactics adopted. Held up momentarily at the 100 metres behind RAINBOW ALLEY.

RAINBOW ALLEY – Raced greenly.

PONSFORD – Slow to muster early speed, bumping with PROSPEROUS MISS at the start.

PROSPEROUS MISS – Began awkwardly, shifting in brushing with PONSFORD. Compounded over the final 200 metres. A post-race veterinary examination revealed a high heart-rate and slow recovery post -race.

RACE 2 – RAINE & HORNE KINGSTON BENCHMARK 68 HANDICAP – (1600 METRES)

CHARLIE BUCKET – Laid in under pressure entering the home straight.

FIGHTING FLOYD – Slow to begin.

STEEL MIST – Began awkwardly and was slow into stride as a result. Raced three-wide early and middle stages.

PUNTER – A post-race veterinary examination revealed no obvious abnormalities.

RACE 3 – RAINE & HORNE SORELL MAIDEN/CLASS 1 – (2100 METRES)

KING KURT – Over-raced in the early and middle stages and was carted wider by UNNERVING at about the 1300 metres. Raced three-wide from the 1000 metres.

PUMA – Checked off heels and lost position at about the 500 metres.

ROWING POWER – Over-raced early stages. Was inconvenienced on several occasions by the riderless horse over the concluding stages.

EMMJAY – Fractious in the barrier prior to the start. The mare underwent a pre-race veterinary examination and was passed fit to run. Over-raced fiercely in the early stages. Trainer T Evans was advised that the mare would be stood down until completing one satisfactory steward's trial.

NO MORE ROCKS – Over-raced fiercely in the early stages.

UNNERVING – Reared on jumping, placing its head in the next barrier stall and harmlessly dislodging its rider. Trainer P Dargan was advised that the gelding would be stood down until completing a satisfactory steward's trial.

Trainer P Dargan wished to view the official patrol film. After doing so UNNERVING (C Wells) was declared a starter and correct weight was declared on the judge's placings.

Prior to the commencement of race three, rider M Ulucinar underwent a medical assessment from the on-course doctor and was passed fit to fulfill today's remaining riding obligations.

Rider Anthony Darmanin (ROWING POWER) pleaded guilty to a charge of careless riding under the provisions of AR 131(a), in that near the 500 metres, he permitted his mount to shift in when not sufficiently clear of PUMA (D Pires) which was checked and steadied to avoid the heels of ROWING POWER. Rider Anthony Darmanin had his licence to ride in races suspended for 1 Tasmanian race date, with the period to commence Midnight on Saturday 9th November 2024, and to expire on midnight 13th November 2024. In assessing penalty, account was taken of his guilty plea, his riding record, that the incident was in the mid-range.

RACE 4 – KELLY CIVIL CONTRACTING CLASS 1 HANDICAP (1100 METRES)

STRATOJACK – Slow to muster early speed.

CAPABELLE – Bounded on jumping and as a result was slow to muster early speed.

SPECIALIZED – Bounded out at the start. Rider T Baker reported that something amiss in the hind quarters of the filly. A post-race veterinary examination revealed no obvious abnormalities.

TURF PUZZLE – Over-raced early stages.

RACE 5 – TONY CARRICK GOODWOOD HANDICAP – (1100 METRES)

INDISPENSABLE – Brushed with TSUNAMI SAM on jumping.

FIRST ACCUSED – Raced three-wide throughout.

GEEGEE'S GEMSTONE – Fractious in the barriers prior to the start. Disappointed for a run over the concluding stages.

TSUNAMI SAM (NZ) – Bounded out on jumping, brushing with INDISPENSABLE. Over-raced throughout.

AND BEYOND – Fractious in the barriers prior to the start. The gelding underwent the first pre-race veterinary examination and was passed fit to run but was declared a late scratching at 2:57pm on veterinary advice after the mare reared in the barriers.

On the announcement of correct weight Stewards ordered that all monies invested on AND BEYOND be refunded, with the following deductions to apply to successful wagers placed prior to 2.57pm. Stewards ordered that the following deductions would apply:

1st - 14 – THESPIAN WATERS	5 cents win, 6 cents place.
2nd - 6 – ALVARINHO	7 cents place.
3rd - 9 – JAGUAR STONE	7 cents place

All monies bet after the withdrawal to be paid at face value of the tickets.

Trainer I Miller was advised that the gelding would be stood down until the completion of one satisfactory steward's trial.

GALENUS – Laid in under pressure over the concluding stages.

THESPIAN WATERS – Slow to muster early speed.

NICCO THE GREEK – Fractious in the barrier prior to the start. The mare underwent a pre-race veterinary examination and was passed fit to run.

DURAZZO – Slow to muster early speed.

IN THE OCEAN – Raced three-wide throughout with cover.

RACE 6 – RAINE & HORNE EASTERN SHORE BENCHMARK 64 HANDICAP – (1430 METRES)

FREAK ON A LEAD – Raced three-wide throughout.

DAYAN STAR – Brushed with HAPPY CLAN rounding the home turn. DAYAN STAR underwent a post-race veterinary examination that revealed a high hear-rate and slow recovery.

HAPPY CLAN – Raced four-wide throughout. Laid in rounding the home turn, brushing with DAYAN STAR.

DID YOU DECIDE – Underwent a post-race veterinary examination that revealed a high heart-rate and slow post-race recovery.

RACE 7 – LYDEN BUILDERS BENCHMARK 60 HANDICAP – (1100 METRES)

NAVAL ANTHEM – Raced three-wide throughout.

NEEDS SUGAR – Dwelt at the start.

DAY PERFORMER – Rider D Pires was reminded of his obligation to ensure he rides his mounts out fully to the line.

PERIWINKLE – Stewards reprimanded apprentice rider J Johnstone for failing to ride his mount out fully to the line. In not taking further action stewards were satisfied that placings had not been affected.

Stable hand Mr Ben Woodsford pleaded guilty to a charge under the provisions of AR 228(b) for misconduct. Particulars being that he used inappropriate language in a loud manner in the stabling area prior to the running of race 4. Stewards fined Mr Woodsford \$200 and invoked a previous penalty of \$300 of a suspended fine under the same offence.

Stewards inquired to an incident that occurred behind the barriers prior to the commencement of race five. Stewards reminded rider, Mrs D Parish of her obligation to conduct herself appropriately when speaking to racing officials.
