Comments / Explanations:

RACE 1 - SALTERS HIRE 3YO & UPWARDS MAIDEN - (1200 METRES)

CHRISTOPHER ROBIN – Had a tendency to lay in, in the home straight.

COASTAL STRIKE – Slow to begin after throwing its head up in the air. A warning has been placed on the gelding's barrier manners. Raced ungenerously throughout. A post-race veterinary examination revealed no obvious abnormalities.

CALLED THROUGH – Began awkwardly.

PEAK A BOOM – Laid out under pressure in the home straight.

YOU BETTER RUN – Connections advised stewards that it is their intentions to have the mare ridden handy circumstances permitting. Began awkwardly.

MISS DELPHI - Over raced early, raced wide throughout. Lost an off-side fore plate in the run.

TALK LIKE THAT – Began awkwardly, over-raced early and raced wide from the 800 metres.

NOODITY – Over raced at about the 1000 metres when receiving pressure from HARTFELT to its outside.

AL MAXIMUS – Jumped outwards at the start.

RACE 2 - LADBROKES RACING CLUB 3YO & UPWARDS MAIDEN - (1600 METRES)

ARCADE BOY – Over raced early – Rider T Baker reported his mount laid out throughout.

MATEUS – Lost both hind plates in the run.

MILES 'N' MILES – Slow to begin.

NUMBERONESTYLEGUY – Steadied off heels of CURRENCIES rounding the home turn and was momentarily held up for a clear run.

STREETS AHEAD - Slow to begin, raced wide throughout

GEEGEES LIGHTWOOD – A post-race veterinary examination revealed high heart-rate, slow post-race recovery.

MONCLERE – Raced wide from the 800 metres.

MR SHUSH – Over raced early stages.

MISS PRIVATE – Lost near hind plate in the run.

RACE 3 – LADBROKES LAUNCESTON CUP WEDNESDAY 26TH FEBRUARY BENCHMARK 60 HANDICAP – (1600 METRES)

LONDIANI – Over raced early. A post-race veterinary examination failed to reveal any obvious abnormalities.

WADDY WADDY – Slow to begin, raced three wide throughout.

LILY LUELLA – Shifted out under pressure in the home straight.

LINDRUM – Momentarily held up entering the home straight.

POP A HONDA – Slow to begin.

SWOOPING EAGLE – Fractious prior to the start, began awkwardly and was slow to begin. Over-raced early and middle stages. Checked off the heels of LONDIANI at about the 200 metres when LONDIANI commenced to tire.

RACE 4 – BOOK INTO THE KREGLINGER CORPORATE MARQUEE TO WIN A BRAND NEW CAR CLASS 1 HANDICAP – (1200 METRES)

WICKHAM LIGHT – Raced three wide throughout.

ADA WAY – Over raced middle stages.

GIE IT LALDY – Slow to begin, over raced middle stages.

IBUTHO – Raced three wide with cover.

BELMISTA – Fractious in barriers required replacement of the bridal. Warning on barrier manners.

CAPABELLE – Trainer P Dargan and the connections advised stewards that it is their intentions to have the mare ridden further back circumstances permitting. Began awkwardly and was slow to begin, over raced early. Tactics adopted.

SWINGING IT – A post-race veterinary examination revealed no obvious abnormalities.

Rider L Bingley (PEPPARONI) was found guilty to a charge of careless riding under the provisions of AR131(a), in that approaching the home turn, when riding her mount along, she permitted her mount to shift out when insufficiently clear of OCEAN EYES (K Sanderson) which changed strides when being carried out making contact with MATERIAL MADAM (M Ulucinar) which in turn was carried out tightening the run of ADA WAY (E Byrne-Burke) which was checked by its rider and lost its rightful running. Rider L Bingley's licence to ride in races was suspended for two Tasmanian race dates with the period to commence on midnight Friday 10th January, 2025 and expiring midnight 19th January, 2025. In assessing penalty, account was taken on her plea, record under this rule and that the incident was in the mid-range category. Rider L Bingley was advised of her right of appeal.

Rider M Ulucinar (MATERIAL MADAM) was found guilty to a charge of careless riding under the provisions of AR131(a), in that approaching the 900 metres, when riding his mount along, he permitted his mount to shift in when insufficiently clear of ADA WAY (E Byrne-Burke). Rider M Ulucinar's licence to ride in races was suspended for one Tasmanian race date. In assessing penalty, account was taken on his plea, record under this rule and that the incident was in the midrange category. Rider M Ulucinar was advised of his right of appeal.

RACE 5 - CUP EVE LUNCHEON TUESDAY 25TH FEBRUARY BENCHMARK 60 HANDICAP (1200 METRES)

LORD WHITEGATE – Raced wide from the 800 metres.

SANDUAL – Began awkwardly.

ESPUR – Slow to muster early speed.

MARTINI BLUE – Slow to begin, raced wide from the 800 metres.

WINCHESTER RIFLE – Stewards granted permission for rider D Pires to ride 1/2kg over the allotted weight. Over-raced middle stages.

RACE 6 - LADBROKES FORM GENIUS 4YO HANDICAP - (1200 METRES)

RUBBLE 'N' FUDD – Bumped at the start with GLORY MISSION. A post-race veterinary examination failed to reveal any obvious abnormalities.

GLORY MISSION – Stewards granted permission for rider D Ganderton to ride 1/2kg over the allotted weight. Over-raced middle stages. Bumped with RUBBLE 'N' FUDD at the start.

PEROLA – Over raced early stages and contacted the running rail at about the 600 metres. Held up for a clear run in the home straight.

RACE 7 – LADBROKES BET TICKER BENCHMARK 68 HANDICAOP – (1100 METRES)

FAKE MAGIC – Raced wide early.

GOLDEN MEADOW – Slow to begin.

RACE 8 - LADBROKES BLACKBOOK BENCHMARK 68 HANDICAP - (1400 METRES)

FAST THINKER – Over raced middles stages of the race.

ETHICAL DILEMMA - Slow to muster early speed, raced three wide throughout.

ES AND ES – At about the 500 metres shifted in and bumped with ETHICAL DILEMMA.

RACE 6 – KEVIN SHARKIE CLASS 3 HANDICAP (1200 METRES)

Stewards inquired into an incident shortly after the start where it appeared ESPRIT DIVA (M Ulucinar) clipped heels. After reviewing the official patrol films and taking evidence from riders RESTRICTED ACCESS (J Radley), ESPRIT DIVA (M Ulucinar) MONTEZULU (H McCarthy). Stewards were of the opinion that no one rider could be attributed to the interference as there were shifts from both inside and the outside that tightened the run of ESPRIT DIVA which appeared to clip heels and blunder. All riders were reminded of their obligations when shifting ground.
